1. Plan Description

The following description of the Valet Living, LLC 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Valet Living, LLC ("Company") who have completed three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Participant Contributions* – Each year, participants may contribute to the Plan on a pre-tax basis and/or on an after-tax Roth basis subject to the provisions of the Internal Revenue Code ("IRC"). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they elect not to participate. Automatically enrolled participants have their deferral rate set initially at 3% of eligible compensation. The deferral rate automatically increases 1% per year starting in year 3 to a maximum deferral rate of 6%. In addition, participants who have attained age 50 before the end of the plan year are eligible to make an additional "catch-up" contribution as prescribed by the IRC. Participants can change their elective deferral percentage or opt out at any time. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).
- c) *Company Contributions* – Effective January 1, 2024, the Company elected to provide Safe Harbor Qualified Automatic Contribution Arrangement (QACA) matching contributions. The company matched 100% of employees' contributions up to 3% of compensation and 50% of deferrals that exceed 3% but do not exceed 5% of the employees' compensation. Company Safe Harbor QACA matching contributions are determined on per-payroll basis. During 2023, the Company halted safe harbor matching contributions.

The Plan also allows for discretionary employer matching contributions and nonelective contributions. The Board of Directors of the Company determines the matching contribution to be made; however the Company is not obligated to make a contribution. A participant's eligibility for matching

contributions is based on the following factors: (1) the employee must be employed on the last day of the year; (2) employee must have completed at least 1,000 hours of service during the plan year. No additional employer contributions were made during 2024 or 2023.

- d) *Participants Accounts* – Each participant’s account is credited and/or reduced with the participant’s contributions and withdrawals, Company contributions, and allocations of the Plan earnings and losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the vested balance in the participant’s account.
- e) *Investment options* – Participants can direct the investment of their contributions and the Company’s contribution into various investment options offered by the Plan. Participants may change their investment options at any time online at the record keeper’s website.
- f) *Vesting* – Participants are vested immediately in their contributions and the Company’s discretionary matching and nonelective contributions, plus or minus any earnings or losses thereon. Participants are vested after two years of service in Company safe harbor QACA contributions. The nonvested balance is forfeited upon termination of service.
- g) *Notes Receivable from Participants* – Under the terms of the Plan, participants may borrow up to fifty percent of their vested account balance, with a minimum of \$1,000 and up to a maximum of \$50,000. Participants may not have more than one loan outstanding at any given time. The loans are secured by the balance in the participant’s account and bear interest at prime rate plus 2%. These interest rates on loans outstanding as of December 31, 2024, ranged from 5.25% to 10.5% and mature through 2033. Principal and interest are paid ratably through payroll deductions.
- h) *Payment of Benefits* – In the case of retirement, death, disability or termination of employment, participants may elect to receive the vested accumulated value of their account in a lump sum distribution payment. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive required minimum distributions. Hardship

distributions are permitted from pre-tax or Roth elective deferral accounts. In-service distributions may be made to a participant who has not separated from service provided the participant has attained the age of 59½ and can be only made from accounts which are fully vested.

- i) *Forfeited accounts* – Forfeitures are used to reduce future company contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$52,082 and \$246,129, respectively. During 2024, \$322,148 was used to reduce company QACA matching contributions and \$428 was used to pay administrative expenses. During 2023, \$12,245 was used to reduce company matching contributions and \$3,031 was used to pay expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan to make estimates and assumptions that affect the reported amounts of net assets and changes therein. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for

benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable from participants are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation of fair value of investments.

3. Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to December 31, 2024 through September 24, 2025, the date the financial statements were available to be issued.

5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable

Mutual Funds – Valued at the net asset value (NAV) of shares held by the Plan at year end. The Plan’s mutual funds are publicly traded and included in Level 1 of the fair value hierarchy.

6. Guaranteed investment contract (GIC)

The Plan holds a fully benefit-responsive investment contract with Massachusetts Mutual Life Insurance Company (MassMutual), the MassMutual Guaranteed interest account. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by MassMutual and is reset every six months. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at Contract Value. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from Plan coverage as result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business. Such events also include: (1) removal from the Plan of one or more groups or classifications of participants; (2) partial or complete Plan termination; or (3) Plan disqualification.

7. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

8. Nonexempt Party-in-Interest Transactions

For the year ended December 31, 2024, certain employee pretax contributions totaling \$1,926 were not remitted to the Plan within the respective time. The defined time period requires that sponsors remit employee contributions to the Plan as soon as they can be reasonably segregated from the sponsor's general assets, but not later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the sponsor. To correct this, during 2025, lost earnings in the amount of \$668 were remitted to the Plan and allocated to participants. These contributions are deemed nonexempt party-in-interest transactions and are disclosed in the accompanying supplemental schedule of delinquent participant contributions.

9. Related Party Transactions and Party-in-Interest Transactions

Empower Annuity Insurance Company of America (Empower) is the recordkeeper and custodian of the Plan. The Plan invests in funds managed by MassMutual.

10. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

11. Tax Status

Effective January 1, 2022, the Plan adopted a non-standardized form of a prototype plan sponsored by Florida Retirement Consultants. The prototype plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
