Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AJC 403(b) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of AJC 403(b) Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about AJC 403(b) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) (Schedule H, line 4i) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of AJC 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory defined contribution plan covering employees of the American Jewish Committee (AJC) that have met the Plan's eligibility requirements. An employee is eligible to participate in the Plan once he/she has reached 18 years of age and has one year of service with AJC. The employee must have worked at least 1,000 hours during the year. The Plan is subject to the provisions of ERISA. The Plan's trustees are responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's trustees.

SECURE Act

The Plan has adopted certain provisions under the Setting Every Community Up for Retirement Enhancement Act of 2022 (SECURE 2.0 Act). The Plan intends to formally execute the required Plan amendments for these provisions by December 31, 2026.

The following descriptions of the Plan below have been updated with the provisions of the SECURE 2.0 Act that impact the Plan.

Contributions

Employer contributions to the Plan are made quarterly on behalf of each participant who is eligible for such contribution. The amount of the employer contribution is subject to change based on the collective bargaining agreement. For the Plan years ended December 31, 2024 and 2023, the employer contribution was 3% of the eligible participant's compensation. Only compensation earned while the participant is active in the Plan is considered.

Contributions in excess of the dollar limitation specified by the Internal Revenue Code at the beginning of the Plan year are not permitted. Participants are permitted to rollover amounts representing distributions from other qualified defined contribution plans.

Participant accounts

Each participant's account is credited with AJC's contributions, as well as allocation of Plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their rollover contributions plus actual earnings thereon. The schedule below determines the vesting percentage for AJC's contributions:

<u>Years of vesting service</u>	<u>Vesting percentage</u>
Less than 3 years	0%
3 years or more	100%

Participants also become fully vested upon attaining their normal retirement date or in the event of death or disability. A participant's vesting service shall not include any service prior to January 1, 2021 or service before reaching age 18.

Notes receivable from participants

The Plan only allows for loans needed as a result of a financial hardship. Financial hardship means hardship due to immediate and heavy financial need. Federal rules are used in order to determine the qualifications for financial hardship. Loans are limited to the amount needed for the financial hardship. Loans must be paid to a party-in-interest who is a participant or beneficiary. Loans are limited to the lesser of 50% of the vested account balance or \$50,000. The minimum loan is \$1,000 and only one loan may be outstanding at a time. The interest rate will be based on the rates available for similar loans from commercial lending institutions, as determined by the Plan administrator, and will not change once granted. Principal and interest are paid ratably through semi-monthly payroll deductions. The loans are secured by the balance in the participant's account.

Payment of benefits

Benefit payments for participants with a vested account balance who are no longer working for AJC will begin on the normal retirement date. Normal retirement age is 65. Participants, who continue to be employed with AJC after their normal retirement date, will have their benefit payments begin on their late retirement date. Late retirement date is the first day of the month on or after the date, the participant stops working for AJC.

On termination of service due to death, disability, or retirement, a participant may elect to receive payout as a lump sum amount equal to the value of the participant's vested interest in his or her account, direct rollover, installment payments, annuity options or defer payments until age 73. If the participant's total vested account balance is \$5,000 or less, the benefit payment will be made in a lump sum distribution or rolled to another retirement plan or IRA in a direct rollover.

In the event of a participant's death, any death benefit will be distributed to the beneficiary or beneficiaries that were designated by the participant. If the participant was married, the spouse will be treated as the beneficiary unless an alternative beneficiary was elected to receive death benefit payments. If the participant does not have a spouse at the time of death, the benefits will be distributed equally to the participant's children (if any) or to the participant's estate.

Forfeited accounts

Forfeitures may first be used to pay Plan expenses. Any forfeitures left after paying Plan expenses are used to offset future employer contributions. During the years ended December 31, 2024 and 2023, administrative expenses were reduced by \$15,794 and \$240, respectively, from forfeited nonvested amounts. In addition, during the years ended December 31, 2024 and 2023, employer contributions were reduced by and \$22,113 and \$5,554, respectively, from forfeited nonvested amounts. Forfeited nonvested account balances were \$-0- for both years ended December 31, 2024 and 2023.

Withdrawals

Participants may withdraw all or any part of their vested account resulting from rollover contributions. Such withdrawals are limited to one during any one-year period and require spousal consent, if applicable.

2. Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and insurance company. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and capital gains are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from AJC are recorded in the year in which participant compensation is earned.

2. Summary of accounting policies (continued)

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payments of benefits

Benefits are recorded when paid.

Expenses

All administrative expenses shall be paid out of the Plan unless paid by AJC. Expenses that are paid by AJC are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Tax status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The Plan Administrator believes that the terms of the Plan have been prepared to conform with the requirements of the Code, and is currently being operated in conformity with the applicable requirements of the Code and, therefore, believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. As of December 31, 2024, the Plan Administrator believes that based on evaluation of the Plan's tax positions that any liability as a result of uncertain tax positions would not be material. Management continually evaluates expiring statutes of limitations, changes in tax law, and new authoritative rulings to assist in evaluating the Plan's tax positions. Accrued interest and penalties associated with uncertain tax positions, if any, would be recognized as part of the income tax provision. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. The Plan maintains its investments with an investment manager. Exposure to credit risk is reduced by placing such investments in high quality financial institutions and by following an investment strategy which utilizes a wide range of diversified funds.

5. Certification by Trustee

We have been informed by the Plan Administrator that Delaware Charter Guarantee and Trust Company D/B/A Principal Trust Company (Principal Trust Company) held the Plan's investment assets and executed investment transactions for the years ended December 31, 2024 and 2023. The Plan Administrator has obtained certifications from Principal Trust Company as of and for the years ended December 31, 2024 and 2023, that the information provided to the Plan Administrator by the Trustee is complete and accurate. The following account balances and transactions were obtained from statements certified by Principal Trust Company, the Plan's Trustee:

Statement of net assets available for benefits:

- Investments
- Note receivable from participant

Statement of changes in net assets available for benefits:

- Net appreciation in fair value of investments
- Dividends and capital gains
- Interest on note receivable from participant

6. Plan termination

Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the entire account balance will be distributed to the participants, including distribution of contract, if the participant is invested in an annuity contract.

7. Transactions with parties-in-interest

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions.

Indirect fees paid by the Plan for said services are included as a reduction in the net change in fair value of investments. Investment advisory and administrative expenses relating to the maintenance of the Plan are paid from the Plan assets. Direct fees paid by the Plan during the years ended December 31, 2024 and 2023 were \$25,026 and \$18,550, respectively.

The Plan Administrator pays for professional fees relating to services provided to the Plan. Fees paid on behalf of the Plan during the years ended December 31, 2024 and 2023 were \$45,248 and \$33,666, respectively. The Plan Sponsor also provides certain accounting and administrative services to the Plan for which no fees are charged.

8. Investment contract with insurance company

The Principal Fixed Income Guaranteed Option (PFIGO) is a benefit-responsive group annuity contract issued by the Principal Life Insurance Company (Principal). By definition, the Principal Fixed Income Option group annuity contract is an insurance contract. The account is credited with contributions and actual earnings and charged for participant withdrawals. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The PFIGO is a single group annuity contract with a fixed rate of interest. It is not a portfolio of contracts whose yields are based on changes in fair value of underlying assets as would be found in a Stable Value Fund. As a result, the average yield earned by the Plan is the yield earned (i.e. interest credited) on the group annuity contract.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on an agreed-upon formula with the issuer but cannot be less than zero. Under the terms of the existing contract, the crediting rate is currently reset on a semi-annual basis.

Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan document (including complete or partial Plan termination or a merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, or (e) premature termination of the contract. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with the Plan participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Investment contracts with the insurance company for the years ended December 31, 2024 and 2023 were \$112,884 and \$117,253, respectively.

9. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs that reflect unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date;

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad criteria data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. However, the determination of what constitutes "observable" requires significant judgment by the Plan. The Plan considers observable data to be that market data which is readily available, regularly distributed or updated, reliable and verifiable, not proprietary, provided by multiple, independent sources that are actively involved in the relevant market. The categorization of an investment within the hierarchy is based upon the pricing transparency of the investment and does not necessarily correspond to the Plan's perceived risk of that investment.

Registered investment company mutual fund investments are valued at quoted market prices that represent the net asset value of shares held by the Plan at year end. The change in market value of these investments is reflected in the statement of changes in net assets available for benefits as net appreciation or depreciation in fair value. The mutual funds held by the Plan are deemed to be actively traded.

10. Subsequent events

Subsequent events have been evaluated through August 28, 2025, which is the date the financial statements were available to be issued. The Plan is not aware of any material subsequent events, except as noted below.

AJC made funding contributions to the Plan totaling \$466,273 from January 1, 2025 through July 21, 2025, which will be applied to the Plan year ended December 31, 2025.

On March 31, 2025, AJC's Retirement Plan Committee approved an amendment to the Plan to allow for both employee and employer contributions under the provisions of ERISA Code Section 403(b). This amendment is expected to create a more modern and user-friendly employee experience, while also lowering costs. Empower was selected as the new recordkeeper and trustee for the Plan. The transition is anticipated to take place effective October 1, 2025.
