Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of World Energy 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of World Energy 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of World Energy 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan covering eligible employees of WMG Services, LLC (the "Plan Sponsor") and its affiliated companies (collectively, the "Company"). All covered employees ages 21 or older are eligible to participate in the Plan upon hire date for purposes of salary deferrals and employer matching contributions. All covered employees ages 21 and older are eligible to participate for purposes of profit-sharing contributions after one year of service. The Board of Trustees is responsible for oversight of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute to the Plan up to a maximum of 100% of their eligible salary, subject to Internal Revenue Code ("IRC") limitations, through salary reduction agreements with the Company. Further, participants who attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions, subject to Internal Revenue Code limitations. The Company may provide a discretionary matching contribution and a discretionary profit-sharing contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans, commonly referred to as rollovers. For the year ended December 31, 2024, the employer discretionary matching contribution amounted to \$504,329 and there was no discretionary profit-sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions, plan sponsor or its subsidiaries matching contributions, allocations of employer contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and rollover contributions plus actual earnings thereon. Participants vest 20% each year after two years of service and become 100% vested in employer matching and profit-sharing contributions plus earnings thereon after six years of service.

Forfeitures

Forfeitures are retained in the Plan and are used to reduce employer contributions. In addition, forfeitures may also be used to pay administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts were \$66,016 and \$17,125, respectively. Forfeitures of \$18,506 were used to fund employer contributions and \$68,170 were used to pay administrative expenses during the year ended December 31, 2024.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate equal to 1 percent above the then prime rate. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

Payment of Benefits

Upon termination of service or upon death, separation of service, disability or retirement, a participant has the option of receiving either periodic payments, partial payments, or a lump sum payment amount equal to the vested value of his or her account. If a terminated participant's vested balance is less than or equal to \$1,000, the amount may be automatically distributed in the form of a lump sum payment. Balances between \$1,000 and \$5,000 may be automatically rolled into an IRA. Further, in-service withdrawals from the Plan are available for special hardship reasons and after attaining the age of 59½. There have been no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not been paid at December 31, 2024.

Investment Options

Participants direct the investment of their contributions into their choices of investment options offered by the Plan. Company contributions are invested as directed by the participants.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator works with the Plan's investment advisors and custodian to determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Gains and losses on sale of investments are based on the average cost method. The net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits includes the total change in unrealized gains (losses) of investments held at year end plus realized gains (losses) on investments sold during the year. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in the net appreciation of fair value of investments. Administrative expenses totaled \$79,895 for the year ended December 31, 2024.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants in the following Plan year.

3. Information Certified by Trustee (Unaudited)

The following investment information, for which no auditing procedures were performed, included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by John Hancock Life Insurance Company, the custodian of the Plan, as of December 31, 2024 and 2023, and for the year ended December 31, 2024. In connection with this certification, the Plan administrator instructed the independent qualified public accountants not to perform, and they did not perform, any auditing procedures with respect to certified investments and investment activity, including net appreciation (depreciation) in fair value of investments, interest, and dividend income, except for comparing such information with the related information included in the financial statements. Based on information provided and certified by the custodian, there are no fixed income obligations, leases or debt instruments in default or deemed uncollectible, as defined by ERISA, for the years ended December 31, 2024 and 2023.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are financial instruments whose values are determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant judgement or estimation. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for Plan's assets measured at fair value. There have been no changes in the methodologies used for the periods presented in these financial statements.

Registered Investment Companies - Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

Common Collective Trusts - Common collective trusts are valued at the net asset value of units of a bank collective trust. The net asset value, as provided by the custodian, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily.

5. Tax Status

The Plan is qualified under provisions of the Internal Revenue Code ("IRC") and is exempt from federal income taxes.

The Plan has adopted a volume submitter profit sharing plan. The Internal Revenue Service has determined and informed the provider of the volume submitter plan by a letter dated June 30, 2020, that the volume submitter plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the letter was received, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

World Energy 401(k) Plan Notes to Financial Statements December 31, 2024 and 2023

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

In addition, there have been no tax related interest or penalties for the periods presented in these financial statements.

6. Party-In-Interest Transactions

Administrative expenses paid by the Plan amounted to \$79,895 for the year ended December 31, 2024. In addition, certain investment related expenses have been offset with net investment income and are not readily determinable. Notes receivable from participants represent exempt party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Audit fees for the required audit of the Plan's financial statements are paid directly by the Sponsor.

7. Plan Termination

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Partial Plan Termination

The Plan Sponsor has determined that a partial plan termination occurred during the plan year due to significant layoffs. Under the IRC and ERISA, a partial plan termination may occur if a significant percentage of Plan participants are terminated as a result of action taken by the Plan Sponsor. The Plan is impacted by (1) a reduced number of active participants and (2) acceleration of the vesting schedule for those participants that were involuntarily terminated by the sponsor (i.e., the "affected participants"). Because all of the participants affected by the partial plan termination were already fully vested in their accounts, there was no material impact on the Plan.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, two investments represented a concentration of greater than 10% of the Plan's net assets available for benefits.

9. Subsequent Events

Management has evaluated all other subsequent events through September 23, 2025, the date the financial statements were available to be issued. There are no recognized or non-recognized subsequent events that existed at the statement of net assets available for benefits date which are necessary to disclose to keep the financial statements from being misleading.
