Basis for Opinion

NOTE A DESCRIPTION OF PLAN

The following description of the Mayo Health Care Retirement Savings 403(b) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company. Employees are eligible to make elective deferrals as of their first day as an employee with the Company. Participants over age 21 become eligible to receive matching contributions after they have completed 1 year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participant contributions to the Plan are made in the form of salary deferrals of up to 100% of qualified compensation, as described in the Plan document, subject to IRS dollar limitations. The Company will contribute as a matching contribution an amount equal to 100% of the participant contributions that are not in excess of 3% of the participant’s compensation.

Participant Accounts

Each participant’s account is credited with allocations of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account, which is immediate.

Vesting

Participants are immediately vested in their voluntary contributions and matching contributions plus actual earnings thereon.

Participant Loans

Participant loans are not permitted.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

NOTE B SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

NOTE D FAIR VALUE MEASUREMENTS

NOTE I CHANGE IN THIRD-PARTY ADMINISTRATOR AND CUSTODIAN

Effective April 28, 2023, the Plan changed its Third-Party Administrator (TPA) from RiversEdge Advanced Retirement Solutions to Standard Insurance Company.

Additionally, the Plan's custodian was changed from Charles Schwab Trust Bank to Reliance Trust Company on April 28, 2023.

Plan assets were transferred from Charles Schwab Trust Bank to Reliance Trust Company on April 28, 2023. The Fund entered into a blackout period from April 12, 2023, to April 28, 2023

NOTE J ADMINISTRATIVE EXPENSES AND PARTY IN INTEREST TRANSACTIONS

Certain administrative expenses are paid by the sponsor on behalf of the Plan. Administrative expenses for record keeping paid by the Plan for the years ended December 31, 2024 and 2023 were \$25,389 and \$23,654, respectively.

Certain plan investments were managed by Charles Schwab Trust Bank investments. Effective April 28, 2023, the custodian for the plan was changed from Charles Schwab Trust Bank to Reliance Trust Company; these investments are managed by Reliance Trust Company. Charles Schwab Trust Bank and Reliance Trust Company both performed record-keeping services for the plan, and therefore, transactions involving Charles Schwab Trust Bank and Reliance Trust Company qualified as party-in-interest transactions. Charles Schwab Trust Bank and Reliance Trust Company received direct compensation and indirect compensation for services to the plan.

NOTE K SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 23, 2025, which is the date these financial statements were available to be issued. All subsequent events requiring recognition as of December 31, 2024, have been incorporated into these financial statements herein.
