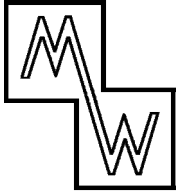

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Duquesne Club 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters—Supplemental Schedules Required by ERISA

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1: DESCRIPTION OF PLAN:

The following description of The Duquesne Club (the Club) 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. GENERAL:

The Plan is a defined contribution plan covering all employees of the Club. The Plan, as amended, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was instituted by the Club effective January 1, 1998.

B. ELIGIBILITY:

Covered employees of the Club are eligible to participate in the Plan after completing a 12-month period of service and obtaining at least 1,000 hours of service. The employee must have attained the age of 21 to be eligible to participate in the Plan.

C. CONTRIBUTIONS:

Under the terms of the plan agreement, participants may elect to defer 1% to 100% of eligible compensation subject to IRS limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various pooled separate accounts and three guaranteed interest contracts as investment options for participants. The Plan provides for employer matching contributions, which are invested in the same manner as employee deferral contributions.

Effective January 1, 2023, the Plan contributes employer matching contributions in accordance with the following formulas:

- a. For employees who are eligible to participate in the Plan as of December 31, 2006, continued participation will be in accordance with the following formula subject to the terms of the Plan. Bargaining unit employees may contribute up to 100% of their gross annual compensation. For any or all of the first 5% of the employee's contribution, the Club will contribute 30% of the dollar amount of the employee's contribution.
- b. For employees who are not eligible to participate in the defined benefit plan as of December 31, 2006, their 401(k) plan participation upon eligibility will be in accordance with the following formula subject to the terms of the Plan:

Employees with < 6 years of service will receive 2.0% of pay fixed contribution and 75.0% match on first 4.0% of base pay contributed;

Employees with 6 to 10 years of service will receive 2.5% of pay fixed contribution and 75.0% match on first 4.0% of base pay contributed;

Employees with 11 to 15 years of service will receive 3.0% of pay fixed contribution and 75.0% match on first 4.0% of base pay contributed; or

Employees with > 15 years of service will receive 3.5% of pay fixed contribution and 75.0% match on first 4.0% of base pay contributed.

With regard to elective deferrals, in any plan year in which a participant fails to file a salary deferral agreement with the administrator, such participant will be deemed to have entered into a salary deferral agreement for that plan year which authorizes the employer to withhold 3% of his or her compensation as an elective deferral.

D. NOTES RECEIVABLE FROM PARTICIPANTS:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Any such loan must be repaid in level payments, not less often than quarterly, over not more than five years, except that a loan to purchase a primary residence may be paid back over a longer period. Loan proceeds are withdrawn pro rata from the funds in which the participant's account balances are then invested; repayments shall be allocated amongst the funds in accordance with the manner in which the participant's contributions are then allocated. The interest that a participant pays to the Plan is not deductible for tax purposes, even if the participant borrows in connection with buying a home. The interest rate applied to participant loans is the current prime rate plus 2%.

E. PARTICIPANT ACCOUNTS:

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

F. GUARANTEED INTEREST ACCOUNTS:

John Hancock USA's Guaranteed Interest Account provides a guaranteed interest rate for a specified period of time as determined or allowed by the sponsor's retirement plan. The rate credited is the rate in effect on the day when each deposit is directed to the account.

G. VESTING:

Participants are immediately vested in their voluntary contributions plus any earnings thereon. Vesting in the Club's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited services.

H. PAYMENT OF BENEFITS:

In the case of normal retirement, early retirement, permanent disability, or termination of employment, participants may elect to receive the value of their accumulated plan benefits, in accordance with the provisions of the Plan, in a lump-sum distribution or IRA rollover. A lump-sum distribution is automatic for amounts up to \$5,000. The Plan makes required minimum distributions in accordance with IRS regulations.

I. FORFEITURES:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$39,706 and \$13,506, respectively. Forfeitures of nonvested Club contributions are used to pay any administrative expenses of the Plan and/or reduce employer contributions. In 2024 and 2023, employer contributions were reduced by \$43,204 and \$11,004 from forfeited nonvested accounts.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

A. BASIS OF ACCOUNTING:

The financial statements of the Plan have been prepared under the accrual basis of accounting.

B. INVESTMENT VALUATION AND INCOME RECOGNITION:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, and is based primarily on the market value of the underlying securities. The guaranteed interest accounts are not fully benefit responsive as defined by FASB ASC 962, and therefore are also reported at fair value. The plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

C. NOTES RECEIVABLE FROM PARTICIPANTS:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan is reduced and a benefit payment is recorded in accordance with the terms of the plan document.

D. PAYMENT OF BENEFITS:

Benefits are recorded when paid.

E. USE OF ESTIMATES:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

F. ADMINISTRATIVE EXPENSES:

Certain expenses of maintaining the Plan are paid directly by the Club and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. For 2024 and 2023, audit fees were paid by the Club.

G. SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

NOTE 3: FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: PSA's are similar to mutual funds except that they are issued by insurance companies and are not publicly traded like mutual funds. Each share of a PSA is determined on a participation-unit basis based upon the underlying value of the investments held in the separate account. Each participant's equity account provides a cumulative record of the number of participation units credited to the account and the number of units allocated or withdrawn from the account. The balance of participation units credited to the account, multiplied by the current participation-unit value, equals the amount of equity account assets held on behalf of the participant at any given time. The participation-unit value is adjusted each business day to reflect the investment results of the assets held under the separate account.

Guaranteed investment contract: Guaranteed investment contracts are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statements reporting purposes only. In determining the reasonableness of the methodology, the Custodian evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate).

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED):

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, and dividends for the year ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan).

NOTE 5: RELATED PARTY TRANSACTION:

Certain plan investments are pooled separate accounts managed by John Hancock USA. John Hancock USA is the custodian as defined by the Plan; and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for these investment management services are charged to the Plan via asset charges. Other direct fees and commissions paid by the Plan for investment management and administrative services amounted to \$10,895 and \$450 for the years ended December 31, 2024, and 2023, respectively. The plan sponsor pays directly any other fees related to the Plan's operations.

NOTE 6: PLAN TERMINATION:

Although it has not expressed any intent to do so, the Club has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Club may determine.

NOTE 7: TAX STATUS:

The IRS has determined and informed Dunbar, Bender & Zapf, Inc. by a letter dated June 30, 2020, that the Volume Submitter Profit-Sharing Plan with CODA, as adopted by the Club January 31, 2006, is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would be sustained upon examination by the IRS and the DOL. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8: RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
