Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Apple Growth Partners 401(k) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 2, 2024 (in liquidation) and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to December 2, 2024 (in liquidation), and the related notes to the financial statements (the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 2, 2024 and December 31, 2023, and for the period from January 1, 2024 to December 2, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.



Opinion

In our opinion, based on our audits and on the procedures performed as described in the Independent Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Independent Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the Board of Directors of Apple Growth Partners, Inc., and Apple Growth Partners, LLC, the Plan Sponsors, approved a plan of liquidation on September 23, 2024, which was completed on December 2, 2024. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Independent Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an independent auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of **Apple Growth Partners 401(k) Plan** (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan for the benefit of eligible employees of **Apple Growth Partners, Inc.** and **Apple Growth Partners, LLC** (together, the "Company"). The Plan covered all full-time employees, excluding seasonal tax preparers and interns. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On May 15, 2024, the Board of Directors of the Company adopted a resolution to freeze the Plan so that no employee shall become eligible to participate in the Plan on or after June 1, 2024, with no further contributions to be made after July 31, 2024. On September 23, 2024, the Plan agreement was amended to fully vest all participants in the Plan as of June 1, 2024, with the Plan to distribute all benefits held under the Plan to participants as soon as administratively feasible pursuant to the terms of the Plan. The final and full liquidation of the Plan occurred on December 2, 2024.

Empower Trust Company (the "Trustee") was the trustee and recordkeeper of the Plan. The Company was the administrator of the Plan (the "Plan Administrator"). The Trustee held all assets of the Plan in accordance with the service provider contract with the Company. The Investment Committee was responsible for oversight of the Plan and the appropriateness of the Plan's investment offerings and monitored investment performance.

Transfer to Other Qualified Plan

Effective August 1, 2024, net assets of the Plan totaling \$6,044,343, which included \$168,936 in outstanding notes receivable from participants, were transferred into the Eide Bailly 401(k) Profit Sharing Plan.

Contributions

Each year participants could contribute up to 100% of annual compensation as defined in the Plan agreement, subject to certain IRS limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company made matching contributions of 50% of the first 6% of eligible compensation that a participant contributed to the Plan. The Company did not make matching contributions on catch-up deferrals. The Company, at its discretion, could make qualified nonelective contributions; however, no such contributions were made during the period from January 1, 2024 to December 2, 2024. Participants must complete one year of service and be age twenty-one to receive qualified nonelective contributions. Participants directed the investment of contributions into various investment options offered by the Plan.

Notes to Financial Statements

Participant Accounts

Each participant's account was credited with the participant's contributions and the Company's matching contributions and an allocation of the Company's qualified nonelective contribution (when made) and Plan earnings, and charged with an allocation of administrative expenses. Participants who initiated a loan or benefit payment were charged a fee for that transaction. Allocations were based on participant compensation, account balances or specific participant transactions, as defined in the Plan agreement. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their 401(k) voluntary contributions plus actual earnings thereon. Vesting in the Company matching and qualified nonelective contributions was based on years of continuous service. Prior to termination, a participant began vesting in the Company contributions after two year of service, becoming fully vested after six years of service.

With the effective termination of the Plan on June 1, 2024, all participants became fully vested as of that date.

Notes Receivable from Participants

Participants were allowed to borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The resulting notes receivable were secured by the balances in the participants' accounts and bore interest at rates, which were commensurate with local prevailing rates at the time the notes were issued. Principal and interest was collected ratably through payroll deductions, until loans were offset as part of liquidating distributions.

Payment of Benefits

Upon termination of service due to death, disability, financial hardship, retirement or any other distributive event, as defined in the Plan agreement, participants or their beneficiaries would receive an amount equal to the value of the participant's vested interest in their account in a lump-sum payment or in various installment annuities. The Plan also allowed distributions on attainment of 59 1/2 years of age equal to the value of the participant's vested interest in their account. All benefits accumulated were distributed from the Plan on or before December 2, 2024.

Forfeited Accounts

If a participant was not fully vested on their termination date, the nonvested amount of the account was forfeited. Forfeitures were used to reduce future employer cash contributions or to pay Plan expenses. Employer cash contributions were reduced by \$36,887 from forfeited nonvested accounts during the period from January 1, 2024 to December 2, 2024. At December 31, 2023, forfeited nonvested accounts totaled \$2,187.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the Company's decision to terminate the Plan, the Plan's statements of net assets available for benefits as of December 2, 2024, and statement of changes in net assets available for benefits for the period from January 1, 2024 to December 2, 2024, are prepared using the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The Plan's statement of net assets available for benefits as of December 31, 2023 was prepared on the ongoing basis of accounting in accordance with GAAP.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. The net change in fair value of investments included the Plan's aggregate gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees were recorded as administrative expenses and were expensed when they were incurred. If a participant ceased to make loan repayments and the Plan Administrator deemed the note receivable to be in default, the participant note receivable was reduced and a benefit payment was recorded.

Contributions

Participant contributions were recorded when withheld from compensation. Employer contributions were recorded in the period in which they became obligations of the Company.

Benefits Paid to Participants

Benefit payments to participants were recorded when paid.

Administrative Expenses

The Plan's administrative expenses were paid either by the Plan or the Company, as provided by the Plan agreement. Certain administrative expenses, including an allocation of salaries related to Plan administration, and audit and legal costs, were paid by the Company and qualified as party-in-interest transactions which were exempt from prohibited transaction rules. Expenses that were paid directly by the Company were excluded from these financial statements. Fees for investment advisory, custodial and record keeping services were paid by the Plan. Participants were charged directly for loan fees and fees related to certain distribution types.

Subsequent Events

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to the most recent statement of net assets available for benefits presented herein, through the date these financial statements were available to be issued.

3. CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2023, and net change in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2024 to December 2, 2024, was obtained by management and agreed to and derived from information certified as complete and accurate by the Trustee.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2: Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability; and
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Shares held in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust ("CIT"): Valued at the NAV of units of a collective trust fund, classified as "other" and not assigned a level in the fair value hierarchy. The NAV as provided by the trustee of the CIT, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

Investment contract with an insurance company: This investment is reported at fair value as determined by the Trustee. Fair value is the amount participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement. The fair value represents contract value adjusted to reflect current observable inputs such as the credited rate, contractual minimum rates, and contract surrender charges, as applicable. The investment contract consists of investments in a guaranteed interest account, backed by the general account of the Trustee.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments were in funds and accounts that were managed by the Trustee or their subsidiaries and affiliates. Participant loan and distribution processing fees were paid to the Trustee by participants. The Plan paid for third party administrator fees and investment advisory fees, which qualified as party-in-interest transactions. The Plan also issued loans to participants which were secured by the vested balance of the participants' accounts. Certain management fees in the form of an expense ratio charged to each investment option were paid by the Plan and deducted from earnings on investments. These transactions were party-in-interest transactions, which were exempt from prohibited transaction rules.

6. TAX STATUS

The Plan used a prototype plan document sponsored by the Trustee. The prototype plan document has received an opinion letter from the IRS dated November 14, 2022 stating that the written form of the underlying prototype plan document is qualified under Section 401(a) of the Internal Revenue Code (the "Code") and that any employer adopting this form of the plan will be considered to have a plan qualified under Section 401(a) of the Code. The Plan is required to operate in conformity with the Code to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. While the Plan may be subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.

7. DELINQUENT PARTICIPANT CONTRIBUTIONS

During the Plan year ended December 31, 2023, participant contributions totaling \$1,000 were not allocated to a Plan participant's account within the period prescribed by DOL regulations. This transaction constitutes a prohibited transaction as defined by ERISA. The contributions and related lost earnings were allocated to the Plan participant's account during 2024.
