Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Savings Investment Plan for Employees of Reckitt Benckiser LLC (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Savings Investment Plan for Employees of Reckitt Benckiser LLC (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering certain employees of Reckitt Benckiser LLC (the "Company") who have met the eligibility requirements in accordance with the provisions of the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 75 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code (IRC). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for employer matching contributions of 75 percent of the participant's contribution up to 6 percent of eligible compensation. Highly compensated employees may contribute a maximum of 15 percent to the Plan on a pretax basis and a maximum of 6 percent on an after-tax basis. The Plan defines highly compensated employees as individuals with a base salary in excess of \$155,000. All new hires on January 1, 2010 and thereafter will also participate in a profit-sharing contribution, which is equal to 4 percent of eligible compensation subject to IRC limitations.

The Company also makes supplemental employer contributions in Reckitt Benckiser plc common stock, which is a non-participant-directed investment, under a formula that is primarily based on employee deferral rates and market appreciation of Reckitt Benckiser plc common stock over a three-year period. The supplemental employer contribution was \$2,570,714 during the year ended December 31, 2024. Such supplemental employer contributions are due to the Plan once employees meet certain criteria, which include making specified employee contributions and being employed by the Company on the applicable commitment date. Under limited circumstances, such as retirement or disability, employees earn a pro rata supplemental employer contribution. No supplemental employer contributions are due to the Plan unless employees meet applicable criteria. The Plan records supplemental employer contributions on the date such criteria are met. See Note 7 for additional information on the Plan's non-participant-directed investments.

Participant Notes Receivable

Participants may borrow from their accounts up to a maximum of 50 percent of their account balances, not to exceed \$50,000. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate. Generally, loans must be repaid within 5 years. However, loans to build or buy a primary residence may be repaid over a period of up to 10 years. Due to the transfer of certain loans into the Plan from historical mergers, there are loans that extend past 10 years.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is 100 percent vested in the employer match, profit-sharing, and transitional contributions after three years of credited service. Additionally, if the participant fulfills the commitment to save under the Plan for three years, they will become entitled to the stock contribution discussed in Note 7.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or elect to receive annual installment payments over 10 years. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions of the Plan. Forfeitures applied towards the Company's matching contributions totaled \$2,126,452 in 2024.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is a trustee of the Plan; therefore, these investment-related transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Non-participant-directed investments consist of shares of the Company's parent's common stock and Indivior plc common stock; therefore, these investment-related transactions qualify as party-in-interest transactions, as defined under ERISA.

Certain administrative functions are performed by officers and employees of the Company (who may be participants in the Plan) at no cost to the Plan. These transactions are not deemed prohibited transactions because they are covered by the statutory administrative exemption from the IRC and ERISA's rules on prohibited transactions.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

December 31, 2024 and 2023

Note 2 - Summary of Significant Accounting Policies (Continued)

The fully benefit-responsive unallocated contracts are valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible. Delinquent notes receivable from participants are reclassified as distribution based upon terms of the plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 16, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company and Wilmington Trust, NA (the "Trustees") hold the Plan's investments and participant notes receivable and execute all related transactions. The investment and participant notes receivable balances and related income included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustees.

Note 4 - Tax Status

The Plan is qualified under Section 401(a) of the IRC, and, accordingly, the trusts thereunder are exempt from federal income taxation under Section 501(a). The Plan sought and obtained its own Internal Revenue Service determination letter dated April 13, 2018, which indicated that the Plan, as designed, is in compliance with applicable IRC requirements. The Company and the Plan's tax counsel believe that the Plan continues to be designed and operating in a manner that is in compliance with applicable IRC requirements. No provision for income taxes has been included in the Plan's financial statements.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds and Money Market Funds

Mutual funds and money market funds are valued at quoted prices reported in active markets.

Common Stock

Common stock investments are valued at the closing price reported in the active markets where the individual securities are traded.

Common/Collective Trust Funds

The common/collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which are based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

In 2024, it was determined that certain investments previously classified as Level 1 mutual funds are common collective trust funds valued using net asset value as a practical expedient for fair value. As a result, the fair value hierarchy disclosure is no longer applicable for these investments. Accordingly, the 2023 fair value disclosure has been restated.

Note 6 - Investment Contracts

The Plan holds a portfolio of investment contracts that are directly effected with the issuers that is composed of a portfolio of traditional investment contracts and a synthetic investment contract. These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The key difference between a synthetic investment contract and a traditional investment contract is that the Plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrapper contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the Plan in certain circumstances. The wrapper contract typically includes certain conditions and limitations on the underlying assets owned by the Plan. With traditional investment contracts, the Plan owns only the contract itself. Synthetic and traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The synthetic investment contract held by the Plan includes a wrapper contract that provides a guarantee that the credit rate will not fall below 0 percent. Cash flow volatility (for example, timing of benefit payments) as well as asset underperformance can be passed through to the Plan through adjustments to future contract crediting rates. A formula is provided in the contract that adjusts the renewal crediting rate to recognize the difference between the fair value and the book value of the underlying assets. The crediting rate is reviewed quarterly for resetting.

The traditional investment contracts held by the Plan are guaranteed investment contracts with a variety of insurance companies. The contract issuers are contractually obligated to repay the principal and interest at specified interest rates that are guaranteed to the Plan. The crediting rates are based on formulas established by the contract issuers but may not be less than the guaranteed minimum interest percentages, which range from 0.91 percent to 4.49 percent. The crediting rates are reviewed on a quarterly basis for resetting. The contracts cannot be terminated before the scheduled maturity date, which range from March 31, 2025 to June 30, 2028.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the insurance company and the financial institution issuer. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Company has determined that the future occurrence of these events is not probable.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following: (i) an uncured violation of the Plan's investment guidelines, (ii) a breach of material obligation under the contract, (iii) a material misrepresentation, or (iv) a material amendment to the agreements without the consent of the issuer.
