Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Dichello Distributors, Inc., 401(k) Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Dichello Distributors, Inc., 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Dichello Distributors, Inc. (the "Company" or "Employer") who have completed 3 months of service and are 21 years of age or older. Employees who are covered by a collective bargaining agreement, are nonresident aliens, or leased employees, are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may elect to have a percentage or specified dollar amount deducted from their eligible compensation as defined by the Plan document. The participant contribution to the plan can be made on a pre-tax or after-tax basis (Roth). Participants who are age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. A participant may elect to increase, decrease or suspend deductions according to procedures established by the Company. There is an annual limit as to the amount that can be deducted from eligible compensation that is determined by the Internal Revenue Code ("IRC").

The Employer makes a safe harbor non-elective contribution in the amount equal to 3% of each employee's eligible compensation. Employer safe harbor contributions made to the Plan amounted to \$155,350 for the year ended December 31, 2024. The Company makes a discretionary matching contribution equal to 50% of the participant's elective deferral up to 4% of the participant's eligible compensation. Discretionary matching contributions made to the Plan amounted to \$91,384 for the year ended December 31, 2024.

The Employer may make discretionary profit sharing contributions in amounts set by the Employer each year. Employees do not have to make 401(k) contributions in order to receive a discretionary profit sharing contribution, which is based on participant eligible compensation. No Employer discretionary profit sharing contributions were made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) Employer's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested portion of their account. All accounts are participant directed.

1. Description of Plan (continued)

Vesting

At all times, a participant is 100% vested in their contributions and Employer contributions plus allocated earnings thereon.

Plan Credit Account

The Plan and Ascensus Trust Company, (the “trustee”) have entered into a service based pricing arrangement whereby a portion of the revenue earned by the trustee is passed through to the Plan for payment of permitted Plan expenses. The Plan Credit Account is an account within the Plan, similar in design to forfeiture accounts. The Plan Credit Account balance was \$231 and \$203 at December 31, 2024 and 2023. During 2024, \$3,351 of the Plan Credit Account was used to reduce administrative expenses and \$0 was used to reduce employer contributions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or after attaining age 59.5, in accordance with provisions specified in the Plan document. If the value of a participant's vested interest in their account is between \$1,000 and \$5,000, the account will be cashed out by distributing the vested interest in a single-sum payment or by direct rollover to an IRA or other eligible retirement plan as soon as reasonably practicable following the date the participant's employment terminates.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in the net asset value (“NAV”) of the respective investment vehicle and consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50 % of their account balance. Participants may only have one loan outstanding at a time. Loan terms range from 1-5 years or up to 30 years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest are paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (“U.S. GAAP”). Accordingly, investment income is recognized when received and disbursements are recognized when made, except for investments which are reflected at fair value. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in conformity with U.S. GAAP.

The preparation of financial statements requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the NAV per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value. Mutual funds are valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission and are deemed to be actively traded. These funds are required to publish their daily NAV and to transact at that price and are deemed actively traded. The common/collective trust is valued at NAV, as provided by the trustee, which is used as a practical expedient based on the fund’s underlying investments. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividends are recorded when received. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 25, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) (modified cash basis) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC as an agent of Ascensus Trust Company, a qualified institution.

5. Common/Collective Trust

The MetLife GAC – 25053 Class 15 (the “Fund”) is an investment option offered to participants under the Plan. The Fund is operated by Reliance Trust Company.

The Fund’s NAV per unit is computed at the close of the New York Stock Exchange (“NYSE”), each day the NYSE is open for business (valuation date). Generally, trust units are issued and redeemed only at valuation date and at the NAV per unit computed on that date. The investment objectives of the Fund are to maximize current income consistent with the maintenance of principal and to provide for participant withdrawals at NAV for certain events without penalty or adjustment. Fund units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the Fund.

The fund has no unfunded commitments or restrictions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the prototype plan sponsor by an opinion letter dated June 30, 2020, that the prototype Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

7. Tax Status (*continued*)

The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Party-in-Interest Transactions

Certain investments of the Plan are managed by Vanguard Group, Inc. through Ascensus Trust Company. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits (modified cash basis).

Certain administrative functions are performed by employees of the Company, which is a party-in-interest. No such employee receives compensation from the Plan.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
