## **Independent Auditors' Report**

To the Administrative Committee of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the accompanying financial statements of OB/GYN Affiliates 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of OB/GYN Affiliates 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information as described in Note 10 to the financial statements, is complete and accurate.

### **Opinion**



**Note 1:**     **Description of Plan**

The following brief description of the OB/GYN Affiliates (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan.

General

The Plan is a defined contribution plan covering certain eligible employees of the Company. Employees are eligible for participation in the Plan after completing one year of service with the Company. The minimum age to participate in the Plan is twenty-one. Eligible employees may enter the Plan on the first day of the Plan year quarter coinciding with or next following the date the participant satisfies the eligibility requirements. The Plan excludes union employees, non-resident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was adopted on January 1, 2002 and most recently restated effective January 1, 2022. The Plan administrator is responsible for oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitoring investment performance. The Plan's trustee is Reliance Trust Company. The Plan is intended to be a qualified defined contribution plan which satisfies the requirements of Section 401(k) of the Internal Revenue Code (the Code). Under the Code, participants are not liable for federal income taxes on employee contributions, company contributions, or plan earnings until such time as they are partially or completely withdrawn from the Plan.

Certification

Reliance Trust Company (the Custodian) has certified to the accuracy of the investment transactions, recognition of income, expenses, and assets held as of December 31, 2024 and 2023.

Contributions

Each year, participants may contribute pretax annual compensation to the Plan. Contributions are subject to certain maximum limits set by the Internal Revenue Service (IRS) and are invested at the direction of the participant. Participants who have obtained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts from other qualified plans. The Plan currently offers 36 pooled separate accounts and 1 stable value fund as investment options for participants and all assets in the Plan are subject to participants' investment direction. The Company may also make rigid discretionary matching contributions that will not exceed 4% of a participant's total compensation. The Company will also make a nonelection Safe Harbor contribution equal to 3% of the participants compensation. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a 2% deferral rate with no escalation, unless they elect not to Participate in the Plan. The Company made contributions to the Plan in the amount of \$1,388,278 during the year ended December 31, 2024.

Participant Accounts

Each participant's account is adjusted by the following increases and decreases: (a) Plan earnings; (b) payment of benefits; (c) increase (or decrease) in the fair value of applicable investments; (d) Company contributions; (e) participant contributions; and (f) administrative expenses incurred in the operations and maintenance of the Plan and its investments. Participant Accounts, continued

each participant's account are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is that which can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer safe harbor non-elective contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 20% vested after two years, with a 20% increase each succeeding year until becoming fully vested after the sixth consecutive year of service. In addition, there is special 100% vesting for two affiliates of the Company. Participants are 100% vested in the Company's contributions upon death or disability.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to or lesser of \$50,000 minus the highest outstanding balance of loans in the past 12 months, or 50% of their vested balance. Each participant can have only one loan outstanding at a time and cannot exceed a term of more than five years. The loans are secured by the balance in the participants' account and bear an interest rate equal to 2% above the prime rate. Principal and interest are paid ratably through monthly payroll deductions. Interest from loans is recognized when earned. During the years ended December 31, 2024 and 2023, the Plan issued 8 and 4 loans to participants, respectively. At December 31, 2024 and 2023, the balance of participant loans totaled \$100,260 and \$105,405, respectively.

Payment of Benefits

On termination of service due to disability, retirement, or withdrawal from the Plan, a participant will receive a lump-sum cash payment for balances that do not exceed \$5,000. If balances exceed \$5,000 distributions may be elected by either: (a) a lump sum, or (b) partial withdrawals or installments.

Forfeitures

Forfeitures may be used to reduce employer contributions, or used to pay Plan expenses. For the years ended December 31, 2024 and 2023, there were \$-0- forfeited. The balance in the forfeitures account available to be used as of December 31, 2024 and 2023, was \$68,989 and \$28,143, respectively.

Hardship Distribution

Under certain circumstances, a participant may qualify for certain hardship distributions if a participant has an immediate and significant financial need, subject to certain usage requirements and other conditions. The participant may receive a lump sum payment equal to the vested amount of the participant's account balance.

Administration of Plan Assets

Contributions are held and managed by the custodian, who invests cash received, allocates interest and dividend income, and makes distributions to participants. Employees of the Company perform certain administrative functions for the Plan. Such employees do not receive compensation from the Plan. Administrative expenses can be paid directly by the Company or through the Plan.

**Note 2: Summary of Significant Accounting Policies**

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan have been prepared using the accrual basis of accounting from information provided by the Company, the Plan administrator and the custodian in accordance with U.S. GAAP.

Investment contracts held by a defined-contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts. The Plan has one fully benefit-responsive investment contracts which is the Stable Value Advantage investment option.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the cash basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant ceases to make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and a delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan presents, in the statements of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**Note 3: Fair Values Measurement**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are based upon quoted market prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan had no Level 3 investments at December 31, 2024 and 2023.

Transamerica's Stable Value Option is considered a deposit liability with no defined maturities and is fairly valued at contract value. That is, the contract value listed in the financial statements is also the fair value. This option is not guaranteed by the Federal Deposit Insurance Corporation.

The separate accounts invest exclusively in underlying mutual funds traded on an established market. All separate account investments classified as Level 1 investments are valued daily using publicly available quoted market prices. Separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who generally use the mean of bid and ask prices, but may also use alternative observable pricing inputs for certain securities and are classified as Level 2 investments.

During 2024, the Plan's total investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$3,426,788.

**Note 4: Investment Contract**

The Plan has one fixed account under investment contract. This account is credited with declared rates of interest and is subject to a minimum rate described in the investment contract. Amounts allocated to the fixed account is held in the Plan's general account which supports insurance and annuity obligations. Certain conditions or restrictions apply to transfers in connection with the fixed account. Withdrawals to pay participant benefits (as fined in the investment contract) from the fixed account are made at book value. The investment contract does not have a maturity date and may retain the right to defer payments from the general account in the event of certain emergency conditions or as provided by applicable law.

**Note 5: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**Note 6: Tax Status**

The Plan obtained its latest determination letter dated February 21, 2012, in which the IRS stated that, the Plan, as then designed, was in compliance with applicable requirements of the Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirement of the Code. Therefore, the amounts contributed by the Company, plan participants and plan earnings are not taxable to the participants until distributed and no provision for income taxes has been included in the Plan's financial statements. Currently the tax returns open and subject to examination are the 2021, 2022 and 2023 tax years by the IRS. However, the Plan is not currently under audit nor has the Plan been contacted by this jurisdiction. The Plan administrator and sponsor believe the Plan's tax position would be upheld under examination. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note 7: Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds and securities managed by Transamerica Retirement Solutions, LLC. Transamerica Retirement Solutions, LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Many investment options have charges and restrictions that apply when transactions are made, and vary depending in the type. Refer to the Plan administrator about specific charges and restrictions. Fees paid using plan assets during the year ended December 31, 2024 were \$191,076.

**Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 11: ERISA Bond Requirements**

ERISA requires that every person who handles funds or other property of the Plan be bonded. The bond coverage is to be determined by the balance of the total Plan assets, and is required to be at least equal to the lesser of 10% of the Plan's assets at the beginning of the Plan year or \$500,000. At December 31, 2024, the Plan's sponsor maintained bond coverage in the amount of \$500,000.

**Note 12: Subsequent Events**

The Plan has evaluated subsequent events and transactions for potential recognition or disclosure through the date at which the financial statements were available to be issued, which is the date of the independent auditors' report, and determined there were no events that required disclosure.
