## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of the Meow Wolf 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Meow Wolf 401(k) Plan**

#### 1. Description of the Plan

The Meow Wolf 401(k) Plan (the Plan) was established by Meow Wolf, Inc. (the Company and Employer) on October 1, 2019 to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### *General:*

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Company has established a Plan committee, comprised of Company employees, which is responsible for administration of the Plan. Empower Retirement LLC and Empower Trust Company, LLC (collectively Empower) serve as the Plan's recordkeeper and trustee, respectively. Empower holds, invests, and reinvests Plan assets in the interest and direction of the participants and their beneficiaries. The Company has engaged Heffernan Retirement Services as an investment advisor to assist the Plan committee in selecting investment options offered under the Plan and monitoring investment performance.

##### *Eligible Participants:*

Employees, as defined by the Plan agreement, aged 21 and older, may participate in the Plan following completion of three months of service.

##### *Contributions:*

Participants are permitted to make voluntary pre-tax salary deferrals and Roth post-tax contributions up to 100% of their annual eligible compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined plans (rollovers), subject to Code regulations.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The automatic pre-tax salary deferral contribution is set at 3% of eligible compensation, as defined by the Plan agreement, unless participants request a different amount to be contributed or formally declined participation.

#### 1. Description of the Plan (continued)

##### *Contributions:* (continued)

The Company may make discretionary matching contributions at the option of the Company's Board of Directors. In 2024, the Company elected to match 100% of the first 3% of eligible compensation by participants, up to a maximum of \$3,900, resulting in Company matching contributions of \$1,810,401. The Company may also make discretionary nonelective profit-sharing contributions. The Company has not made any profit-sharing contributions to the Plan through December 31, 2024.

In order for the Plan to be in compliance with certain non-discrimination tests, a qualified nonelective contribution of \$27,760 was made to the Plan, which was recorded as a contribution receivable as of December 31, 2024. The receivable was funded in 2025.

Contributions are subject to certain limitations under the Code.

##### *Participant Accounts:*

Participant accounts are credited with participant contributions, Company contributions, and an allocation of Plan earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant vested accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

##### *Vesting:*

Participants are immediately vested in their contributions, plus actual earnings (less any losses) thereon. Vesting in Company contributions, plus allocated earnings (less any losses) thereon, is based on years of service. Participants vest in Company contributions at the rate of 50% after the first year of service and are fully vested after two years. Participants also become fully vested in Company contributions upon death or disability.

##### *Forfeitures:*

The non-vested portion of terminated participant account balances is forfeited upon distribution of the vested account balance. Forfeitures are retained in the Plan and may be used to pay Plan administrative expenses or reduce future Company contributions. As of December 31, 2024, there was \$11,519 in the forfeiture account (\$3,724 at December 31, 2023). In 2024, forfeitures of \$40,393 were used to reduce Company contributions and \$17,805 were used to pay Plan expenses.

##### *Payment of Benefits:*

On termination of service for any reason, benefits are paid to participants in a lump-sum cash distribution equal to the value of the participant accounts. Terminated participant accounts below \$7,000 will be automatically distributed directly to participants without participant approval. The Plan agreement also allows for certain in-service and hardship withdrawals of benefits to current employees. Distributions will be paid as soon as administratively feasible and may be paid in a lump sum cash payment or rolled into another qualified retirement plan or individual retirement account, as elected by the participants, subject to certain stipulations as defined by the Plan agreement. Benefits are recorded when paid.

##### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain account maintenance fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

##### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks and market conditions, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risks in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

##### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

#### 2. Summary of Significant Accounting Policies

##### *Basis of Accounting:*

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the U.S. (GAAP).

##### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Investments:*

The Plan's investments are comprised of mutual funds and a guaranteed investment contract. These investments are accounted for as follows:

*Mutual Funds:* These funds are valued at the net asset value of shares held by the Plan at year end, as quoted in active markets.

*Guaranteed Investment Contract (GIC):* This is a fixed annuity contract through Empower Annuity Insurance Company of America offered by Empower. The reported values are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider (Empower).

##### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes, within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

*Fair Value Measurement:* (continued)

The three-level hierarchy for fair value measurement is defined as follows:

**Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

**Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

**Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

#### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net investment income on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 14, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

#### 5. Party-In-Interest Transactions

Certain Plan investments include investments options managed or offered by Empower. As Empower is the Plan's trustee, purchases and sales of these investments qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules under ERISA.

6. Nonexempt Prohibited Transactions

In 2024, the Company did not remit participant contributions and note repayments totaling \$435 on a timely basis as required by the Department of Labor (DOL). The Company contributed lost earnings to the Plan in 2024 in order to correct the delinquent remittances. The DOL considers delinquent contributions to be nonexempt prohibited transactions with the Plan sponsor that can jeopardize the Plan's tax-exempt status.

7. Subsequent Events

Subsequent events have been evaluated through September 16, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
