Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Liberty Motors, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. (1) Summary of Significant Accounting Policies

Method of Accounting

Liberty Motors, Inc. (the Plan Sponsor or Plan Administrator), is an automobile dealership operating in western South Dakota. The Plan was formed January 1, 1999 and includes employees of Liberty Motors, Inc., Liberty Chrysler Center LLC, Liberty Auto Center LLC, Liberty Import Center LLC, and Liberty Chevrolet LLC, collectively the Company, companies under common control.

Nature of Business of Plan Sponsor

The financial statements of Liberty Motors, Inc. 401(k) Plan (the Plan) are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value on a recurring basis as determined by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, the Trustees) (Notes 5 and 7), except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Net Change in Fair Market Value of Investments

The net appreciation in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year, and the unrealized gains and losses in securities held at the end of the year.

Risks and Uncertainties

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Contributions

Contributions from Plan participants and matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

(1) Summary of Significant Accounting Policies

Subsequent Events

The Plan has evaluated subsequent events through September 23, 2025, the date which the financial statements were available to be issued.

(2) Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which includes employees of the Company. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Employees of the participating companies who have completed one year of service with 1,000 hours and have attained the age of twenty-one are eligible to participate in the Plan. Upon meeting the Plan's eligibility requirements, employees may enter the Plan on the first day of the month. Employees of the participating companies are eligible for matching contributions upon eligibility and entry.

Contributions

Participating employees contribute an amount each pay period as provided for in their participation agreement. Employees may contribute from 1 percent to 100 percent of their compensation, not to exceed certain limits established by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Matching contributions are 100 percent of the first 3 percent of compensation deferred and 50 percent of the next 2 percent of compensation deferred. The Company may also provide a discretionary contribution to the Plan annually. No discretionary contributions were made during the year ended December 31, 2024.

The Plan allows Roth elective deferrals. Contributions to Roth 401(k) accounts are made on an after-tax basis and are included in the participant's gross income. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participants' Roth deferrals and gains and losses attributable to such deferrals are accounted for separately. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contribution, an allocation of the Company's nonelective contribution, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(2) Description of the Plan

Participant Investment Options

Upon enrollment to the Plan, a participant may direct employee and employer contributions to any of the funds offered by the Plan. Participants may change their investment options daily.

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account.

Participants with benefits in excess of \$1,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits not greater than \$1,000 are paid in one lump-sum upon termination of employment, death, disability, or retirement. A participant with an account balance of greater than \$1,000, but less than \$5,000, may receive a rollover distribution into an individual retirement account set up by the Plan Administrator.

Vesting

Participants are immediately vested in their contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's nonelective contribution and prior matching contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant becomes 20 percent vested after two years of credited service, as defined, and continues to vest at the rate of 20 percent for each successive year of service until 100 percent vested after six years of service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Forfeitures

Forfeitures are used to reduce the administrative expenses of the Plan or employer contributions. Non-vested account balances are forfeited, unless participants return to employment and contribute the distribution received at termination within a specified time. Forfeited nonvested accounts totaled approximately \$-0- and \$900 for December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, employer contributions were reduced by \$3,043 from forfeited non-vested accounts.

(3) Administrative Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

(4) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their account.

(5) Investments -- Information Certified by Trustees

The Trustees hold the Plan's investments, executes investment transactions, and perform all related accounting functions. The Trustees determined the fair value of investments at December 31, 2024 and 2023.

In accordance with Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator has received certification from the Trustees as to the accuracy and completeness of certain financial information of the Plan as of and for the years ended December 31, 2024 and 2023. The Trustees have certified information contained in the following:

Statements of Net Assets Available for Benefits (except for employee and employer contributions receivable)
Statement of Changes in Net Assets Available for Benefits (except for contributions, benefits paid to participants and administrative expenses)
Supplemental Schedule of Assets Held at End of Year

The Plan invests in mutual funds and a guaranteed investment contract with underlying assets consisting of any combination of stocks, bonds, fixed income securities, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is possible that the value of the Plan's investments, both in total and in individual participant accounts, has changed significantly since December 31, 2024.

(6) Income Tax Status

The Plan has adopted a non-standard form of prototype plan. The prototype plan has received an opinion letter from the Internal Revenue Services (IRS) as to the prototype plan's qualified status. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. Generally Accepted Accounting Principles (GAAP) requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the Department of Labor or IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing, jurisdictions, however, there are currently no audits for any tax periods in progress.

(7) Recurring Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

(7) Recurring Fair Value Measurements

- Level One: inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level Two: inputs include
 1. quoted prices for similar assets or liabilities in active markets;
 2. quoted prices for identical or similar assets or liabilities in inactive markets;
 3. inputs other than quoted prices that are observable for the asset or liability;
 4. inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level Three: inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(8) Participant Withdrawals

As of December 31, 2024 and 2023, Plan assets include terminated participants with account balances totaling approximately \$445,000 and \$444,000, respectively.

(9) Party-In Interest Transactions

Fees for legal and professional services rendered to the Plan may be paid by the Company at its discretion. Certain Plan investments include a guaranteed annuity contract managed by the Trustees at December 31, 2024 and 2023.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

(10) Guaranteed Annuity Contract

The Plan holds a traditional fully benefit-responsive guaranteed annuity contract (GAC) with Empower Annuity Insurance Company of America totaling \$48,808 and \$51,707 at December 31, 2024, and 2023, respectively. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent and is reviewed on a quarterly basis for resetting. The crediting rate was 1.45% at December 31, 2024. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

(10) Guaranteed Annuity Contract

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.
