Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of First National Bancorp, Inc. Employee Stock Ownership Plan with 401(k) Provisions (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H, line 4i-schedule of assets held at end of year as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of Plan

The following description of the First National Bancorp, Inc. Employee Stock Ownership Plan with 401(k) Provisions (the "Plan") is provided for general information purposes only. For a more complete description of the Plan, participants should refer to the Plan document and its related provisions.

General

The Plan is a defined contribution plan covering all full-time employees of First National Bancorp, Inc. (the "Company") who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (the ERISA). The Plan was established by the Company on January 1, 1988 and was most recently restated effective January 1, 2013 and amended for legislative changes, effective January 1, 2022.

The Plan operates as an employee stock ownership plan ("ESOP") and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the "Code"), to primarily invest in the Company stock, and is intended to constitute a cash or deferred arrangement pursuant to section 401(k) of the Code. The Plan is administered by a Board of Trustees. The Board of Trustees contracts with an independent firm to audit the Plan's financial statements and hires a third-party administrator to assist the Plan administrator in performing its plan record-keeping responsibilities.

Eligibility

Employees of the Company are eligible to participate in the Plan after attaining age 18. Entrance is allowed on the first day of the month following the date of employment or upon reaching age 18, whichever is later. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation of discretionary Company contributions. Allocations are based on a participant's eligible compensation, relative to total eligible compensation.

Administration of Plan Assets

The Plan assets are held by the Plan Trustees. The Plan Trustees have designated John Hancock Life Insurance Company as the trustee of the non-employer stock contributions, and they have designated the Plan administrator as custodian of the Company common shares. Company contributions are held and managed by the Plan administrator, who invests cash received, interest and dividend income and makes distributions to participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Plan administrator fees are paid directly by the Company.

Investment Options

Participant contributions and Company matching contributions are allocated among the available investment options as directed by each participant. By designating these investment alternatives for participants, allowing frequent fund transfers and providing the necessary fund information to participants, it is intended that the Plan be treated as an ERISA 404(c) Participant-Directed Account Arrangement.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) investment earnings and losses and (b) the Company's matching and discretionary contributions, if eligible. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Contributions

Under the 401(k) provisions of the Plan, participants may contribute any amount of their pretax annual compensation, as defined in the Plan (the elective deferral), not to exceed the limits of the Internal Revenue Code sections. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other tax qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Investment options of the Plan include various separate accounts offered through John Hancock Life Insurance Company in addition to Company stock.

The Company makes a matching contribution equal to the sum of 100% of the amount of the participant's elective deferrals that is not in excess of 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceeds 3% of the participant's compensation but not in excess of 5% of the participant's compensation. Employer discretionary contributions are only made to participants who have completed a year of service during the plan year (1,000 hours) and are employed on the last day of the plan year. In 2023, the Company did not make a discretionary contribution.

Diversification

Diversification is allowable by the Code (IRC Section 401(a)(28)(B)) and is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with a minimum 10 years of participation in the Plan may elect to diversify a portion of their account attributable to Company stock.

Put Option

Under Federal income tax regulations, employer stock held by the Plan and participants that is not readily tradable on an established market must include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase, with interest, over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Voting Rights

The Trustees of the Plan will vote all Company stock held by it as a part of the Plan assets, provided that the participants or beneficiaries will be entitled to direct the Trustees as to the manner in which voting rights on shares of Company stock which are allocated to their account are to be exercised (a) with respect to any corporate matter which involves the voting of such shares with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade or business, or such similar transaction, and (b) with respect to all corporate matters if, at the time of the vote thereon, the Company stock is a "registration-type" class of securities. If the participant or beneficiary does not timely exercise their right to vote Company stock, the Trustee will vote such Company stock.

Vesting

Participants are immediately vested in their contributions plus actual earnings or losses thereon. If a participant's employment ends for any reason other than normal retirement, permanent disability, or death, they will vest in the employer contributions in their account based on total years of service with the Company. Participants vest 20% per year of service following their first full year of service and are 100% vested after six years of service. All contributions become fully vested upon the death or permanent disability of a participant before retirement or other termination.

Payment of Benefits

On termination of service a participant may elect to receive an amount equal to the value of their vested interest in their account as a lump sum payment or installment payments over a period of time not beyond the participant or beneficiary's life expectancy if the vested benefit under the Plan exceeds \$7,000. If the participant's vested balance does not exceed \$7,000, then the participant will receive the distribution in a single lump-sum distribution.

Distributions will be made in cash, Company stock or both. A participant may elect to have the entire distribution made in the form of Company stock plus cash for fractional shares. Unless elected in writing, Company stock will be distributed in substantially equal installments over a period not longer than five years. Participants receiving stock distributions are required to offer "right of first refusal" to the Company for any future sales or transfers of said stock. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,748 and \$35, respectively. Forfeited accounts are used to reduce employer contributions or pay plan expenses. During the year ended December 31, 2024, no forfeited non-vested amounts were used to reduce employer contributions or plan expenses.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code. Upon termination of the Plan, participants would become 100% vested in their accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Released gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year. The Board of Trustees determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussion of fair value measurements. The classification of investment earnings reported above and in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Contributions

Participant contributions and related Company matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Deductions for benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Company has evaluated subsequent events through September 25, 2025, the date which the financial statements were available to be issued.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts – Valued at fair value based on the NAV of units as determined by the insurance company. The NAV is based on the observable market prices of the underlying assets within the account less liabilities. The NAV for the underlying assets of the account is a readily determinable measure of their fair value and is the basis for current transactions.

Employer stock – Valued at the fair value per share at year-end as determined by an independent stock appraisal. This appraisal was based on a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparable and the estimated fair value of Company assets and liabilities.

Note 5 - Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company (the custodian of the Plan). The certification does not include the Company's stock.

Note 6 - Risks and Uncertainties

The Plan utilizes various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility, as well as valuation assumptions for the Company's common stock based on earnings, cash flows, and other such techniques. Market risks include global events which could impact the fair value of investments, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the financial statements.

Note 7 - Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian and, therefore, these transactions qualify as exempt party-in-interest transactions. The Company paid the investment management services fee.

The Company is a financial institution in Montana and the Plan's checking account is held with the Company. The Plan invests in Company common stock.

Note 8 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 25, 2013, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company, Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Dividends

Participants have been given the right to take a distribution of dividends in cash or leave the funds in the Plan to be re-invested in other investment options available in the Plan. During each quarter of 2024, the Company paid dividends to the ESOP of \$0.50 per share (\$2 total annual rate per share). Total dividends paid was \$93,341 during the year ended December 31, 2024.
