## Notes to Financial Statements

### Note 1. Description of Plan

The following description of the Zuern Building Products, Inc. 401(k) Profit Sharing Plan (Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering employees of Zuern Building Products, Inc. (Company) with the exception of members of a collective bargaining unit, leased employees, and non-resident aliens. Employees over age 18 are eligible to participate in the Plan upon completion of six months of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may make pre-tax and Roth contributions, as defined by the Plan, subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan utilizes "safe-harbor" matching contributions intended to satisfy the provisions of §401(k)(12) and §401(m)(11) of the Internal Revenue Code; thereby eliminating the requirement for ADP and ACP nondiscrimination testing. The Company contributes a matching contribution equal to 100% of the employee's contributions up to 3% of the employee's compensation for the Plan year. The Company also contributes an additional matching contribution equal to 50% of the employee's contributions from 3% to 5% of the employee's compensation for the Plan year. Matching contributions totaled \$603,770 in 2024.

In addition, the Company may make discretionary profit-sharing contributions. Profit-sharing contributions are allocated, as outlined in the Plan agreement, to those participants who work 1,000 hours and are employed on the last day of the Plan year (or were terminated during the Plan year due to normal retirement, death, or disability). Profit-sharing contributions of \$565,592 were authorized for 2024 and funded in March of 2025.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, and a group annuity contract as investment options for participants.

**Participant Accounts:** Participant accounts are credited with their contributions, the Company's contributions, Plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are vested immediately in their contributions and Company safe harbor matching contributions plus actual earnings thereon. Vesting in Company discretionary contributions (and earnings thereon) is based on years of continuous service. Participants vest over a 6-year schedule: 1 year-10%; 2 years-20%; 3 years-40%; 4 years-60%; 5 years-80%; 6 years-100%. A participant will become fully vested upon death or total and permanent disability.

**Notes Receivable from Participants:** The Plan does not allow participants to initiate loans.

## Notes to Financial Statements

### Note 1. Description of Plan (cont.)

**Payment of Benefits:** On termination of service due to death, disability, separation or retirement, a participant may elect to receive a lump-sum amount or installments equal to the value of the participant's vested interest in his or her account. In addition, in-service withdrawals are allowed after participants reach age 65 or in cases of financial hardship.

The Plan has the ability to make automatic distributions without participant consent for terminated participants who fail to affirmatively elect a distribution and have a vested balance under \$5,000.

**Forfeited Accounts:** At December 31, 2024, and 2023, forfeited nonvested accounts totaled \$10,062 and \$103,760 respectively. Forfeitures are used first to pay administrative expenses, with the remaining balance used to reduce Company contributions. During 2024, forfeitures of \$103,958 were used to reduce Company contributions.

### Note 2. Summary of Accounting Policies

**Basis of Accounting:** The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition:** The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a detailed discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**Subsequent Events:** The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were issued.

### Note 3. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the net asset value (NAV) of shares, based on quoted market prices, held by the Plan at year end.

*Pooled separate accounts:* Units held in pooled separate accounts (PSA) are valued using the net asset value practical expedient (NAV practical expedient) as reported by the account manager. The NAV practical expedient is based on the underlying assets owned by the PSA, minus its liabilities, and then divided by the number of units outstanding.

### Note 4. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Trust Company (the custodian of the Plan).

### **Note 5. Group Annuity Contract**

The Plan entered into a fully benefit-responsive group annuity contract with Principal Trust Company (Principal). Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Principal maintains the contributions governed by this contract in a general account. The account is credited with participant contributions plus earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

A rate of interest contractually guaranteed by Principal is credited to participant account balances. This crediting rate resets semiannually. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

No redemption fees, early withdrawal charges or market value adjustment are charged on participant transfers into or out of the group annuity contract. A Plan Sponsor initiated liquidation will be subject to either a 12-month irrevocable advance notice or a 5% surrender charge. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### **Note 6. Related-Party Transactions and Party in Interest Transactions**

Principal Trust Company is a custodian of the Plan. Certain Plan investments are units of funds managed by Principal Trust Company. Transactions in these investments are deemed exempt party-in-interest transactions. Administrative expenses paid by the Plan to Principal Trust Company totaled \$99,655 for the year ended December 31, 2024.

### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Company contributions.

### **Note 8. Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
