INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
U.S. Physical Therapy, Inc. 401(k) Salary Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of U.S. Physical Therapy, Inc. 401(k) Salary Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the U.S. Physical Therapy, Inc. 401(k) Salary Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of certain clinics owned by U.S. Physical Therapy, Inc. (the “Company”). For a complete list of clinics covered, participants should contact the Company.

All employees other than union employees and nonresident aliens are eligible to participate in the Plan on the first day of the month coinciding with or next following the attainment of age 21 and completion of thirty days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

T. Rowe Price Retirement Plan Services, Inc. is the Plan’s recordkeeper and T. Rowe Price Trust Company (TRPTC) is the Plan’s trustee.

Contributions

Participants may elect to make salary deferral contributions to the Plan of up to 90% of their eligible compensation as defined by the Plan, subject to certain limitations. A participant may designate all or a portion of their elective deferrals as Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company automatically makes a pretax salary deferral contribution of 6% of eligible compensation for all newly eligible or rehired employees unless they affirmatively elect otherwise. The Plan allows for in-plan Roth rollovers and rollover contributions from other qualified plans.

The Company may: (1) contribute a discretionary matching contribution to all participants on a payroll period basis and/or (2) make a discretionary nonelective contribution to all participants employed on the last day of the plan year and/or (3) make qualified nonelective employer contributions. The Company did not elect to make a discretionary matching, nonelective or qualified nonelective contribution for the year ended December 31, 2024.

The Plan is participant directed, and participants may change their contribution rates each payroll period and investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) Plan earnings and charged with any applicable administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Plan participants may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance in the Plan. Loans are paid in level installments through payroll deductions for periods ranging up to five years, or longer for the purchase of a primary residence. Loans bear interest at 2% over the prime interest rate at the date of the loan and are secured by the participant's vested account to the extent of the principal amount of the loan plus accrued interest. Participants may only have two loans outstanding at any time and may not refinance their loans.

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of service. Participants vest 20% per year after one year of service and are 100% vested after five years of service.

Payment of Benefits

A participant shall be immediately vested upon death, normal or early retirement, or termination of employment due to total and permanent disability. Normal retirement age under the Plan is 62 and early retirement can be elected at age 55 with five years of service. Upon death, retirement, disability, or termination of employment, the vested funds in the participant's account may be distributed in a lump-sum payment. The Plan also allows hardship withdrawals and in-service withdrawals at the age of 59½ from all of the participant's fully vested accounts.

Effective July 1, 2024, the Plan implemented certain provisions of the Secure 2.0 Act. The Plan now allows the automatic rollover of vested account balances of terminated participants that are \$7,000 or less into an IRA 90 days following the participant's termination date. Automatic rollovers are processed quarterly. Previously, vested account balances of terminated participants that were \$5,000 or less were cashed out. The Plan also now allows active participants to take one distribution of \$100 to \$1,000 for emergency expenses per year with the option to repay the distribution within three years. The Plan will be formally amended to adopt these provisions prior to December 31, 2026.

Forfeitures

Forfeitures of nonvested Company contributions may be used to reduce employer contributions or to pay administrative expenses of the Plan. The forfeitures balance was \$4,487 and \$942 at December 31, 2024 and 2023, respectively. There were no forfeitures used during the year ended December 31, 2024.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, participants would become 100% vested and receive benefits based on their account balances accumulated to the date of termination of the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Company discretionary matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation. The Company discretionary nonelective and qualified nonelective employer contributions are recorded in the plan year in which participant compensation is paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Nondiscriminatory Refunds

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code (IRC) are recorded as a liability. The Plan had nondiscriminatory refunds of \$40,223 as of December 31, 2024 that were distributed to the applicable participants in 2025. There were no nondiscriminatory refunds payable as of December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to administration, investment advisory, notes receivable from participants, and certain transactions are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

Investments measured using the NAV practical expedient are described below:

Common Trust Funds: Valued using the NAV practical expedient based on the units held by the Plan. NAV is calculated by the fund manager based on the underlying investments. The T. Rowe Price Stable Value Fund (the “Stable Value Fund”) primarily invests in guaranteed, bank, and synthetic investment contracts and/or separate account contracts. Units are issued and redeemed daily for the Stable Value Fund at a constant NAV of \$1 per unit. The Stable Value Fund imposes certain restrictions on investments made under the Plan, and the Stable Value Fund itself may be subject to circumstances that impact its ability to transact at a constant NAV of \$1 per unit. Plan management believes that events that may cause the fund to transact at less than \$1 per unit are unlikely to occur. All other common trust funds are comprised of T. Rowe Price Retirement target date trust funds that invest in underlying commingled T. Rowe Price Trusts with no redemption restrictions. The Plan has no unfunded commitments or further obligations to invest in the common trust funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TRPTC certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Plan investments are in mutual funds and common trust funds managed by entities related to or by TRPTC. TRPTC is the trustee as defined by the Plan. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 6 - TAX STATUS

The Plan has adopted a non-standardized pre-approved plan, which obtained its latest opinion letter dated August 19, 2020 in which the Internal Revenue Service (IRS) stated that the document satisfies the applicable provisions of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
