**NOTE 1 – DESCRIPTION OF PLAN**

General: The following description of the Amalgamated Bank 401(k) Plan for Non-Collectively Bargained Employees (the “Plan”) provides only general information. Participants should refer to the Plan agreement or Summary Plan Description for a more complete description of the Plan’s provisions and definitions of defined terms.

The Plan is a defined contribution plan covering substantially all Non-Collectively Bargained Employees (“Employees”) of the Amalgamated Bank and its subsidiaries (the “Bank” or “Plan Sponsor”). The Plan was established on September 1, 1993. Employees contribute to the Plan on a pre-tax basis. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan was restated effective January 1, 2021.

Eligible Employees within the Bank are covered by the Plan. Prior to obtaining a non-union promoted position, eligible employees are covered by the Amalgamated Bank 401(k) Plan for Collectively Bargained Employees (the “Collectively Bargained Plan”). If employees obtain non-union positions within the Bank, the balances of their individual participant accounts in the Collectively Bargained Plan are transferred to the Plan. The opposite of this can also occur. For the year ended December 31, 2024, there were no noncash transfers to the Plan from the Collectively Bargained Plan related to Employees obtaining a non-union position during the period, or vice versa.

As of December 31, 2024, and 2023, and for the year ended December 31, 2024, the recordkeeping and trustee functions were performed by Vanguard Fiduciary Trust Company (“Vanguard” or “Trustee”) or its affiliate.

Eligibility: Employees become eligible to participate in the Plan on the first day of the month following their date of hire or date they are promoted to a managerial position. Once the eligibility requirements are met, an employee can enroll and become a participant and begin making contributions to the Plan.

For participants who were covered by the Collectively Bargained Plan and are promoted into managerial positions, entry into the Plan is effective with the first payroll cycle following the date of promotion.

If an Employee chooses not to participate in the Plan when first eligible, the Employee may enroll at a later date and begin making pretax contributions on the first day of the following calendar quarter.

Contributions: Participants are eligible to contribute a flat dollar amount or a percentage of their pretax annual compensation and the Plan offers an after-tax Roth option as an additional deferral selection. A participant in the Plan may contribute an amount up to 80% of the participant’s eligible pre-tax compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code (“IRC”). The maximum was \$23,000 per annum for the Plan year ended December 31, 2024, however, may be further limited by the IRC. For participants 50 years of age or older, catch-up contributions are permitted which increase the contribution limit by \$7,500 to \$30,500 per annum for the Plan year ended December 31, 2024. Participants may also contribute rollover amounts, which represent distributions from other qualified defined benefit or defined contribution plans.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon and therefore will not have forfeitures if they terminate from the Plan.

Administrative Expenses: Administrative expenses of the Plan are paid by either the Plan or the Plan’s sponsor as provided in the Plan document.

**NOTE 1 – DESCRIPTION OF PLAN (Continued)**

Participant Accounts: Individual accounts are maintained for each participant. The account of each participant is credited with: (a) their contributions and (b) an allocation of Plan earnings and expenses based on account balances. Participant account balances are charged with withdrawals and for certain fees related to loans and withdrawals. Participants can change their investment elections once a quarter.

The benefit to which a participant is entitled under the Plan is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow any amount up to 50% of their vested account balance. However, their loan (when added to any other outstanding loan) can be no more than \$50,000 minus their highest outstanding total loan amount during the prior 12 months. The amount of the loan must be at least \$1,000. The loans are secured by the balance in the participant's account and bear interest commensurate with the prevailing rate of interest that would be charged by independent lenders for similar loans at the date of origination. As of December 31, 2024, and 2023, the interest rates charged on participant loans were fixed between 4.25% and 9.50%, respectively. The period of repayment of any loan shall not exceed five years, unless the loan is to be used in conjunction with the purchase of the principal residence of the participant, in which case the repayment period may be for a term in excess of five years. At December 31, 2024 and 2023, the outstanding participant loans receivable mature through May 2033 and October 2044, respectively. Principal and interest are paid through payroll deductions over the term of the loan. Any loans not repaid within a certain period of time are classified as deemed distributions.

Payment of Benefits: Upon death, disability, retirement or termination of service, participants or their designated beneficiaries may receive a lump-sum amount, or distributions in the form of installments.

Active participants, over the age of 59-1/2, may withdraw all available amounts in their accounts. Certain hardship withdrawals by active employees may be allowed.

An individual may receive a direct cash-out for any balance less than \$1,000. A participant with a balance between \$1,000 and \$5,000 has the option to roll over his/her account balance to a qualified IRA account.

Distributions may be subject to income tax withholding in accordance with Internal Revenue Service (IRS) regulations.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan have been prepared in conformity with U.S. generally accepted accounting principles ("U.S. GAAP") and are presented on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value.

Purchases and sales of investments are recognized on a trade-date basis. Dividend income is recognized on the ex-dividend date and interest income is recognized when earned. Net appreciation or net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**NOTE 3 – CERTIFICATION BY THE PLAN TRUSTEE**

Substantially all information pertaining to the Plan's investments and notes receivable from participants included in the financial statements, including the associated investment income (loss) and interest earned on notes receivable from participants, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Vanguard, the Trustee.

**NOTE 4 – INVESTMENTS AND FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2:* Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE 4 – INVESTMENTS AND FAIR VALUE MEASUREMENTS (Continued)**

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan:

*Mutual funds* – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Collective trust* – The fair value of participation units held in the collective trust fund are based on the net asset value per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Bank has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their accounts.

**NOTE 6 – TAX STATUS**

The Plan is based on a Prototype Plan Document of Vanguard, which received an opinion letter from the IRS, dated June 30, 2020, stating that in their opinion, the Prototype Plan was acceptable under Section 401 of the IRC. Although the Plan has been amended, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan continues to be in compliance with the applicable requirements of the IRC and therefore, the Plan is qualified, and that the related trust is tax-exempt as of the financial statement date.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Bank has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS**

Certain employees of the Bank provide services to the Plan. None of these individuals or the Bank receives compensation from the Plan. For the year ended December 31, 2024, Vanguard charged certain fees amounting to \$38,889 for the maintenance of loans and expedited withdrawal of funds, which were paid directly by the participants.

All of the plan investments are held in Vanguard investment funds. Those funds, excluding the collective trust investment that is managed by Vanguard, are sponsored by an affiliate of the trustee and receive investment management fees which are paid from the funds themselves. The fees reduce the investment income of the funds and are reflected as a component of net appreciation in fair value of investments on the statement of changes in net assets available for benefits. Vanguard as trustee, or its affiliates, qualifies as a party in interest under Section 3(14) of ERISA and its transactions involving purchases and sales of Vanguard managed mutual funds and a collective trust represent party in interest transactions.

Participant loans totaling \$557,764 and \$431,790 at December 31, 2024 and 2023, respectively, qualify as party-in-interest transactions.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan offers numerous investment options consisting of a variety of mutual funds and a collective trust fund. In general, investment securities are exposed to various risks, such as interest rate, credit, and overall market risk, including global events. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the Statements of Net Assets Available for Benefits and participant account balances.

**NOTE 9 – SUBSEQUENT EVENTS**

The Plan Administrator has performed an evaluation of events that have occurred subsequent to December 31, 2024 through September 23, 2025 at which the date the financial statements were available to be issued.
