NOTE 1: DESCRIPTION OF PLAN

The following description of Mavagi Enterprises, Inc. Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the associated plan documents for a complete description of the Plan's provisions.

General: The Plan was established April 1, 2020 to provide health and other benefits to eligible participants. Substantially all employees of Mavagi Enterprises, Inc. (the Plan Sponsor) employed under a federal service contract are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is part of a group insurance arrangement, The Contractors Insurance Trust ("the Arrangement"), that provides benefits to the participants of the Plan Sponsor through group insurance policies and health benefits with various insurers. The Arrangement is the holder of the insurance policies and acts as the conduit for payment of the premiums. The Arrangement receives contributions from the Plan Sponsor, remits the premium payments to the Insurers, and pays administrative expenses.

Benefits: The Plan provides medical, life, dental, vision, EAP, telemedicine services, and accidental death and dismemberment for eligible participants and their dependents. The third-party administrator pays insurance premiums to various insurance companies for benefits for eligible participants and their dependents. Insurance companies are responsible for paying benefits under these agreements.

The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

The Sponsor has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Cash: Represents the allocated cash balance to the Plan in the Arrangement.

NOTE 2: SIGNIFICANT ACCOUNTING POLICIES *(continued)*

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Benefit Obligations: Benefit obligations include those premiums for which services have been performed but which have not been paid as of December 31. Based on the inherent uncertainties involved, it is reasonably possible that the estimate will change in the near term.

Administrative Expenses: The Plan's administrative fees are paid by the Plan.

Trust Fees: The Plan's trust fees, for processing and payment of insurance premiums and other administrative services, are paid by the Plan.

Trust Fees Payable: This amount represents certain fees pertaining to the current year, but not yet paid at year end.

Individual Premium Reserve ("Hour Bank Reserve" – Accumulated Eligibility Credits): The Plan Sponsor contributes a required amount for employees based on a predetermined hourly fringe rate. Amounts contributed in excess of the required premiums, less expenses, are retained in the Plan for the benefit of these participants. This excess is known as the "hour bank reserve." The hour bank reserve balances are used to fund employee premium shortfalls during months when the employee does not work sufficient hours to maintain full-time coverage. These funds may also be used after employee termination to fund continuation of coverage until exhausted.

Subsequent Events: Plan management has evaluated subsequent events through September 8, 2025, which is the date the financial statements were available to be issued, and determined that there were no subsequent events requiring disclosure.

NOTE 3: CONTRIBUTIONS

The Plan is funded by contributions from the Plan Sponsor and participants. Insurance premium payments and fees are made from these contributions. Contributions are allocated to Plan benefits and expenses in accordance with an administrative services agreement between the Plan Sponsor and the third-party administrator. The Plan Sponsor is ultimately responsible for the allocation and administration of funds. However, the third-party administrator pays insurance premiums to various insurance companies.

NOTE 5: INCOME TAX STATUS

The Plan has not applied for exemption from state or federal income taxes. Plan management believes that the Plan qualifies for exemption from income tax under the Internal Revenue Code and, therefore, no provision for income taxes is reflected in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7: TRANSACTIONS WITH PARTIES-IN-INTEREST

Trust fees charged by the Plan's third-party administrator during the year ended December 31, 2024 and 2023, were \$51,190 and \$65,373, respectively. At December 31, 2024 and 2023, amounts payable to the Plan's third-party administrator for trust fees were \$8,531 and \$17,523 respectively.
