Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of St. Marys Foundry LTD 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules for the year ended December 31, 2024, on pages 12 through 13, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following description of the St. Marys Foundry LTD 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by St. Marys Foundry LTD (the “Company”), covering all employees who have completed six months of service and are age nineteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The original effective date of the Plan is January 3, 2023.

Contributions

Each year, participants may make contributions based on their pre-tax annual compensation, as defined in the Plan and up to allowed Federal limits. Participants may make contributions as pre-tax or after-tax (Roth). Participants who have attained age fifty (50) before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers cash, various mutual funds, and a collective trust fund as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly-eligible employees are enrolled in the Plan, at a default deferral rate of 3%, unless the employee affirmatively elects not to participate. Each year, the Company decides how much, if any, the Company wishes to make as a matching contribution. Since the matching contribution is discretionary, the Company may decide not to make a matching contribution. During the years ended December 31, 2024 and 2023, the matching contribution was 100% of participants’ contributions, up to 3% of qualifying compensation. Participants direct the investment of their matching contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and Company matching contributions, as well as allocations of the Company’s Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and the earnings thereon. Vesting in the Company’s matching and discretionary contributions and the earnings thereon is based on years of continuous service. A participant is 100% vested after four years of credited service.

Notes Receivable from Participants

Participants may borrow from their account up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. No loan in an amount less than \$1,000 will be made. Loan terms generally may not exceed five years; however, if the loan qualifies as a home loan, the administrator may permit a longer repayment term. Loans are collateralized by the balance of the participant’s vested account and bear interest rates ranging from 4.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance or partial payments (payments of a portion of the participant's account that are not regularly scheduled). In addition, hardship distributions are permitted if certain criteria are met.

The Plan adopted the automatic rollover provisions as contained in Internal Revenue Notice 2005-5. In accordance with the SECURE 2.0 Act of 2022, the Plan has administratively implemented an increase in the involuntary cash-out threshold from \$5,000 to \$7,000, effective for distributions made on or after January 1, 2024. Although the formal plan amendment reflecting this change has not yet been executed, the Company intends to adopt a conforming amendment within the remedial amendment period.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$6,880 and \$1,889, respectively. The accounts may be used to pay the Plan's administrative expenses. Forfeitures may also be used to reduce future employer contributions to the Plan. During the years ending December 31, 2024 and 2023, the amount of forfeitures used to reduce employer contributions was \$1,284 and \$0, respectively.

Plan Amendment

Effective January 1, 2024, the Plan was amended such that (1) the eligibility requirement changed from 500 hours of service in a six-month period to 250 hours of service in a six-month period, and (2) the number of hours of service necessary for a year of vesting service changed from 1,000 to 500.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees, if any, are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are classified as distributions based on the terms of the Plan document.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Excess Contributions

Amounts payable to participants for contributions in excess of allowed limits, totaling \$5,648 for the year ending December 31, 2024 were paid by March 15, 2025.

Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan, unless otherwise paid by the Company, and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and loans from participants' accounts are charged directly to the participants' accounts. Investment related expenses are included in net appreciation in fair value of investments.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets;• quoted prices for identical or similar assets or liabilities in inactive markets;• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or by other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE C – FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Cash and Cash Equivalents:

Cash and cash equivalents consist of funds that are highly liquid in nature, such as money market accounts.

Mutual Funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Collective Trust Fund:

A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE E – PARTY-IN-INTEREST AND PROHIBITED TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Capital Bank and Trust Company. At December 31, 2024 and 2023, Capital Bank and Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

During the year ended December 31, 2023, the Company remitted \$114,083 of employee contributions and loan repayments withheld from participant paychecks after the Department of Labor’s prescribed deadline. These contributions were deposited after the earliest date of which they could reasonably have been segregated from the Company’s general assets. As a result, the Company is deemed to have committed a prohibited transaction under ERISA Section 406 and IRC Section 4975. The Company has corrected this issue through:

- Filing a Voluntary Fiduciary Correction Program Application Form with the Department of Labor,
- Calculating and restoring lost earnings to affected participant accounts, and
- Filing IRS Form 5330 and paying the applicable excise tax under Internal Revenue Code 4975.

NOTE F – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances.

NOTE G – TAX STATUS

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the plan's counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I – INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, Capital Bank and Trust Company, has certified that the investment information included in the accompanying financial statements and supplemental schedules is complete and accurate.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.
