### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of CHI Franciscan Health Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 30, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the period January 1, 2024 through August 30, 2024, and the related notes (collectively referred to as the “financial statements”).

## Notes to Financial Statements

August 30, 2024

### 1. Description of the Plan

The following description of CHI Franciscan Health Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the summary plan description and plan document for a more complete description of the Plan's provisions.

#### General

The Plan is an Internal Revenue Code (the Code) Section 403(b) defined contribution plan with an effective date of July 1, 1996. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Highline Medical Center became part of the CommonSpirit Health controlled group, formerly Catholic Health Initiatives (CommonSpirit), on April 1, 2013.

Prior to January 1, 2016, the Plan covered substantially all employees of Highline Medical Center (the Company). Effective January 1, 2016, the Plan was amended to only allow for participation in the Plan by employees subject to the terms of a collective bargaining agreement. Employees classified with PRN status are only eligible to make employee contributions and do not receive an allocation of company contributions. All other employees of the Company at December 31, 2016, became eligible to participate in the CommonSpirit Health 401(k) Retirement Savings Plan.

Effective January 1, 2017, the Plan was amended to allow for the eligibility of certain employees of Highline Community Health Services d/b/a/ Northwest Regional Hospital (Regional Hospital). Regional Hospital became an adopting employer of the Plan, and CHI Franciscan Health became the sponsor of the Plan. Eligible employees are allowed to make participant contributions immediately upon hire. Except for employees classified with PRN status, company contributions are available to all collectively bargained employees of the Company upon reaching the age of 18 and after completing two years of service in which at least 1,000 hours are worked in the first 24 consecutive months. Plan entry dates are restricted to the beginning of each month.

Effective September 1, 2024, the Plan merged into the CommonSpirit Health ERISA 403(b) Plan. All assets and participant account balances were transferred from the Plan to the CommonSpirit Health ERISA 403(b) Plan as of the close of business on August 30, 2024.

Fidelity Management Trust Company (Fidelity), The Lincoln National Life Insurance Company (Lincoln), American United Life Insurance Company (AUL), and American Century Investments (American Century) are custodians of the Plan. Fidelity Investments is the record-keeper for the Plan.

## Notes to Financial Statements (continued)

### **1. Description of the Plan (continued)**

The Plan is administered by the CommonSpirit Health Retirement Plans Sub-committee (the Committee). The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to CommonSpirit Health's Human Resources and Compensation Committee of the Board of Stewardship Trustees.

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants are eligible to start making deferral contributions on the first day of employment.

Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. All contributions are subject to certain limitations of the Code.

The Company matches 100% of employee contributions, up to 2% of eligible compensation deferred to the Plan. To become eligible, employees must be 18 years old and have completed two years of service without an intervening break in service. The Company further contributes a discretionary contribution equal to 5% of eligible compensation for each employee who is eligible for the discretionary contribution. Participants eligible to receive the Company's matching contribution are also eligible for the discretionary contribution.

Participants direct all contributions into various investment options offered by the Plan and can change their investment options on a daily basis.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of plan earnings and is charged a fixed per annum rate of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements (continued)

### **1. Description of the Plan (continued)**

#### **Vesting**

Participants are immediately vested in their contributions and all employer contributions plus actual earnings thereon.

#### **Participant Loans**

Notes receivable from participants represent participant loans. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of 5 years, unless the loans are used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed 15 years. Under the terms of the plan agreement, loans bear a reasonable rate of interest determined by the local prevailing rate. Principal and interest are paid ratably through monthly payroll deductions.

#### **Payment of Benefits**

Participants are entitled to distributions from the Plan upon death, disability, normal or early retirement, or other termination of employment. Upon termination of service, a participant will receive his or her vested benefits under the Plan. The forms of distribution include a lump-sum distribution, installments, or a partial lump-sum distribution, with the remainder taken as a lump-sum distribution or installments at a later date.

Additionally, participants may request distribution of certain portions of their accounts due to financial hardship, as defined.

#### **Administrative Fees**

Substantially all administrative and trustee fees are paid by the participants through a fixed per annum fee, charged on a quarterly basis, and investment fees are deducted directly from investment returns.

### 2. Summary of Accounting Policies

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### Benefits Paid to Participants

Benefits are recorded when paid.

#### Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments held by the Plan (except for fully benefit-responsive investment contracts) are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for further discussion and disclosures related to fair value measurements.

In accordance with Accounting Standards Codification 820, *Fair Value Measurement*, assets and liabilities measured at fair value are categorized into the following fair value hierarchy:

- Level 1: Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for assets or liabilities. The fair value hierarchy gives the highest priority to Level 1 inputs.
- Level 2: Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability.

### 2. Summary of Accounting Policies (continued)

- Level 3: Unobservable inputs are used when little or no market data is available. Therefore, fair value is based on prices or valuation techniques which require inputs that are both significant to the fair value measurement and observable. These inputs reflect management's judgments about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed. The fair value hierarchy gives the lowest priority to Level 3 inputs.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought, sold, and held during the year.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at August 30, 2024 or December 31, 2023.

*Mutual Funds:* Mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of August 30, 2024 or December 31, 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### 5. Fully Benefit-Responsive Investment Contract

The Plan has a balance in the VALIC Fixed Account, which is a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The VALIC Fixed Account is maintained in a general account with VALIC. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.25%. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

When CommonSpirit Health merged the Plan into the CommonSpirit Health ERISA 403(b) Plan, the VALIC contract relationship remained unchanged as the contract transferred into the CommonSpirit Health ERISA 403(b) Plan.

#### **5. Fully Benefit-Responsive Investment Contract (continued)**

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts depends on the third-party issuers' ability to meet their financial obligations. The issuers' ability to meet their contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

### **6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

### **7. Related-Party and Party-in-Interest Transactions**

The Plan invests in certain funds managed by Fidelity, Lincoln, AUL, and American Century, the custodians of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

### **8. Income Tax Status**

The underlying volume submitter plan has received an advisory letter from the Internal Revenue Service (IRS) dated August 7, 2017, stating that the form of the underlying specimen plan is qualified under Section 403(b) of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 403(b) of the Code, and, therefore, the related custodial accounts are tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related custodial accounts are tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
