#### **Note 1. Description of the Plan**

The following description of the Security 401(k) Profit-Sharing and Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### General:

The Plan is a defined contribution plan covering all employees of Security Finance Corporation of Spartanburg, its subsidiaries and its affiliated employers (collectively the “Company”). Security Finance Corporation of Spartanburg is the Administrator (“Administrator”) and Sponsor (“Sponsor”) of the Plan. The Administrator created a committee to oversee all matters that concern the operations of the Plan. The Board of Directors of the Company appoints four officers of the Company to serve on the Plan Committee (“Administrative Committee”). The Plan is administered under a written plan and trust agreement, with Charles Schwab Trust Bank as the trustee (“Trustee”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan provides that an employee becomes eligible to participate in the Plan after being credited with at least one year of eligibility service (as defined in the Plan document) with the Company and attaining the age of eighteen.

##### Contributions:

Each year, participants may contribute pre-tax or Roth contributions up to 75% of eligible annual compensation with certain limitations, as defined in the Plan. Participants who have obtained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company matches 100% of contributions up to 3% of eligible employee compensation and 50% of contributions of the next 2% of eligible employee compensation.

The profit-sharing portion of the Plan is discretionary and non-contributory. The Company has traditionally made voluntary contributions to the profit-sharing portion of the Plan in an amount determined by the Board of Directors of the Company, not to exceed certain annual limitations as set forth in the Internal Revenue Code (“IRC”). For the Plan year ended December 31, 2024, the Company made a profit-sharing contribution of \$615,550. The amount is included in Company contributions receivable within the statement of net assets available for benefits as of December 31, 2024. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

##### Participant accounts:

Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, Company contributions, and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Note 1. Description of the Plan, Continued**

##### Forfeitures:

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$261 and \$181, respectively. These accounts were and will be used to reduce Plan administrative expenses. During 2024, the Plan used \$7,850 of forfeitures to reduce Plan administrative expenses.

##### Vesting:

A participant becomes fully vested in his or her profit-sharing account upon the completion of three years of service or in the event of a participant's death or disability. Participants are vested immediately in their contributions and the Company's matching contributions plus actual earnings thereon.

##### Investment options:

Under the Plan, participants have the option to direct investments into various mutual funds and a collective trust fund.

##### Payment of benefits:

On termination of service, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum amount distribution or can elect to receive substantially equal installment payments over a specified period of time. Upon attainment of age 59½, an active or inactive participant may elect to withdraw any portion or all of the vested interest in his or her 401(k) account balance. Participants may elect to withdraw the vested portion of their profit-sharing account upon termination. Hardship distributions are permitted upon demonstration of financial hardship. On termination upon death, beneficiaries may elect to receive a lump sum distribution or substantially equal installment payments over a specified period of time, subject to limits on period of time.

#### **Note 2. Summary of Significant Accounting Policies and Activities**

##### Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Note 2. Summary of Significant Accounting Policies and Activities, Continued**

#### Contributions:

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the participant contributions are withheld from compensation.

#### Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of benefits:

Benefits are recorded when paid.

#### Expenses:

Administrative expenses of the Plan are paid by either the Plan or the Plan's Sponsor, as provided in the Plan document. Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees charged by the Plan's Trustee are netted against any revenue share amounts from the various funds. Fees related to the administration of distributions to participants are charged directly to the participant's account and are included in administrative expenses.

#### Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

### **Note 3. Trustee Certifications**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the Trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that the information provided to the Plan Administrator by the Trustee related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

*Mutual funds, continued:* These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Collective trust fund:* Valued at NAV. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company profit-sharing contributions.

#### Note 6. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated September 21, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7. Related-Party and Party-in-Interest Transactions

Certain administrative functions are performed by the officers and employees of the Company (who may also be participants in the Plan) at no cost to the Plan. These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note

2, the Plan made direct payments to the Trustee totaling \$32,988 which were not covered by revenue sharing. This amount is included in administrative expenses shown within the statement of changes in net assets available for benefits. The Company pays directly any other fees related to the Plan's operations.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9. Subsequent Events**

Plan management has evaluated subsequent events through September 25, 2025, the date that the financial statements were available to be issued. On March 18, 2025, the Company adopted the super catch-up election where participants between the ages of 60 to 63 are eligible to make additional catch-up contributions. Effective March 20, 2025, these participants can contribute to the enhanced catch-up contribution limit of \$10,000 or 150% of the standard age 50+ catch-up contribution limit, whichever is greater. The enhanced catch-up limit for 60-63 in 2025 is \$11,250.
