## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Parkway Corporation Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

#### Note 1. Description of Plan

The following description of Parkway Corporation Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all nonunion employees and employees of certain bargaining units of Parkway Corporation (the Company) who have completed six months of service. An eligible employee may elect to become a participant on the entry date following the date on which the employee satisfies the eligibility requirements. The entry date is the first of the month after six months of service. The Company's Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may contribute (elective contribution) up to 100% of pretax or after-tax (Roth) annual compensation, as defined in the Plan. Participants age 50 or older are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company may elect to make a discretionary profit-sharing contribution or a safe harbor contribution. There were no profit-sharing contributions for the year ended December 31, 2024. The Company made a safe harbor contribution of 3% of eligible plan compensation totaling \$602,761 in 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Auto-Enrollment:** The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

**Investment options:** Upon enrollment in the Plan, a participant may direct contributions in any of the various funds offered by the Plan as more fully described in the Plan's literature. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's elective and rollover contribution, an allocation of the Company's safe harbor and discretionary profit-sharing contribution, and Plan earnings/losses, and charged with distributions and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Note 1. Description of Plan (Continued)

**Vesting:** Participants are immediately vested in their contributions (including rollover contributions) and any Company safe harbor contribution, and the earnings thereon. Company discretionary profit-sharing contributions, including earnings thereon, become vested as follows:

**Payment of benefits:** Upon termination of service, reaching retirement age, death or disability, a participant or their designated beneficiary may elect to receive their vested account balance in the form of a lump-sum payment or other methods as outlined in the Plan. In-service withdrawals and withdrawals for certain financial hardships are also permitted. A participant is fully vested in their entire account balance upon reaching age 65 or the sixth anniversary of plan membership, or upon becoming totally and permanently disabled. In addition, the beneficiary will collect the full value of a participant's account if the participant dies while employed.

**Forfeitures:** Forfeitures may first be used to pay administrative plan expenses. Any amounts remaining after paying plan expenses are used to reduce employer contributions. If any forfeitures still remain, such forfeitures will be reallocated to participants. During 2024, no forfeitures were reallocated to participant accounts. Forfeited accounts totaled \$0 at both December 31, 2024 and 2023, respectively. During 2024, \$0 was used to pay administrative expenses and no forfeitures were used to reduce employer contributions.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of: (a) \$50,000, reduced by the participant's highest outstanding loan balance in the prior 12 months or (b) 50% of the value of the participant's vested benefit in the Plan, reduced by any outstanding loan balance on the date the new loan is made. Loan terms range up to five years, except for loans borrowed for the purchase of a participant's primary residence. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate reported in *The Wall Street Journal* on the date the loan is requested, plus 1%. These rates range from 4.25% to 9.50% on loans outstanding at December 31, 2024, and the loans mature through 2052. Principal and interest are paid ratably through biweekly payroll deductions for Parkway employees.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which were reported at contract value through the date of termination). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Contributions:** Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. Participant contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction in contributions.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Administrative expenses include fees related to the administration of the notes receivable and certain record-keeping fees paid by the Plan that are charged directly to the participant's account. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events (events occurring after December 31, 2024) through September 29, 2025, the date the financial statements were available to be issued.

#### **Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Registered investment companies (mutual funds):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Pooled separate accounts:** Valued at the NAV of shares in each account held by the Plan at year-end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the insurance carrier, is used as a practical expedient to estimate fair value.

**Common collective trusts:** Valued at the NAV of shares in each account held by the Plan at year-end. The NAV is not a publicly quoted price in an active market. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value.

#### Note 5. Fully Benefit-Responsive Investment Contract

The Plan had a traditional, fully benefit-responsive guaranteed investment contract with the Principal Life Insurance Company (Principal) that was reported at contract value. Principal had a fixed income guaranteed option, which maintained the contributions in a general account. The account was credited with contributions, earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate was based on a formula agreed upon with the issuer but was not to be less than 1% or greater than 3%. Such interest rates were reviewed semi-annually for resetting. During the 2024 Plan year, the fully benefit-responsive investment contract was terminated, and funds were transferred to a money market account.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances

#### Note 7. Related-Party and Party-in-Interest Transactions

Certain plan investments are invested in funds managed by Principal Financial Group, an affiliate of the Plan's custodians. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian for the year ended December 31, 2024, totaled \$112,827. Additionally, the Plan issues notes to participants, which are secured by the participant's account balances. These transactions also qualify as party-in-interest transactions.

#### Note 8. Tax Status

Effective February 22, 2022, the Plan adopted a non-standardized form of a prototype plan sponsored by Principal Life Insurance Company. The prototype plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any significant uncertain tax positions that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress.
