Note 1 Description of Plan

The following description of the Lender Service Provider, LLC Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Lender Service Provider, LLC (the "Company") who have at least three months of eligible service and have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees of Lender Service Provider, LLC (the Company) who have completed at least three months of service, as defined in the Plan, and have reached at least 21 years of age are eligible to begin participating on the first day of each month coinciding with or next following date requirements are met. Upon enrollment in the Plan, a participant may direct employer and employee contributions to any combination of available investment options.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company contributes a discretionary matching contribution that is allocated based on a participant's contributions. Additional amounts may be contributed at the discretion of the Company's Board of Trustees. For the Plan years ended December 31, 2024 and 2023, the Company made a discretionary matching contribution equal to 50% of employee contributions up to \$2,000 of participants' compensation from the time period of January 1st through April 30th. For the years ended December 31, 2024 and 2023, the Company matching contribution was \$0 and \$93,173, respectively. For the Plan years ended December 31, 2024 and 2023, the additional discretionary contribution was \$0.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Account

Each participant's account is credited with the participant's contributions, the Company's matching and discretionary contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

All investments of the Plan are participant-directed. Participants have the option of directing their account balance to one or more different investment options.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes receivable are secured by the balance in the participant's account and bear interest at a rate of 4.25%-9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through biweekly payroll deductions. Notes receivable from participants had a balance of \$101,038 and \$69,851 at December 31, 2024 and 2023, respectively.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount or in annual installments if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000, it can be distributed only in a single lump sum payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Effective January 1, 2020, the new IRS hardship distribution regulations were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disasters as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to exhaust plan loans. Written amendments to the Plan to reflect these operational changes have been adopted in accordance with applicable law and IRS guidance.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures may be reallocated to participants in the same manner as Company contributions or may be used to pay administrative expenses in accordance with the Plan document. At December 31, 2024 and 2023, unallocated forfeitures from nonvested accounts totaled \$38,900 and \$27,886, respectively.

Note 2 Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses charged by the Trustee of the Plan and investment advisory fees are paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued.

Note 3 Fair Value Measurements

Fair Value Hierarchy

The Plan follows ASC 820, Fair Value Measurement, which establishes a framework for measuring fair value and expands disclosures about fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments held in investment contracts that are fully benefit-responsive are measured at contract value in accordance with ASC 962-325. Contract value represents contributions plus earnings, less participant withdrawals and administrative expenses, and is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The fair value hierarchy prioritizes inputs into three levels:

- Level 1 – quoted prices in active markets for identical assets
- Level 2 – observable inputs other than quoted prices in Level 1
- Level 3 – unobservable inputs that are significant to the valuation.

Valuation Methodologies

- Collective Investment Trusts (CITs) – Units valued at NAV as reported by the trustee. Reported using the NAV practical expedient and not categorized in the hierarchy.
- Pooled Separate Accounts (PSAs) – Mutual fund-based accounts valued at daily NAV. Reported using the NAV practical expedient.
- Fixed General Account Annuity (Voya) – A spread-based general account contract. Reported at contract value, which approximates fair value. Classified as Level 2.

- Nature: The Plan invests in a group annuity contract issued by Voya Retirement Insurance and Annuity Company.
- Crediting Rate: Interest is credited daily at a rate declared periodically by Voya. In 2024, credited interest was \$3,653; in 2023, \$3,141.
- Liquidity: Participant withdrawals are permitted at contract value. Employer-initiated events (plan termination, layoffs, mergers) may be subject to restrictions, including delayed payout or market value adjustments.
- Classification: Reported at contract value, which approximates fair value (Level 2).
- Balances: \$207,425 at December 31, 2024, and \$189,120 at December 31, 2023.
- Risk: The contract is subject to the creditworthiness of Voya. If discontinued, a market value adjustment or surrender charge may apply.

At both December 31, 2024 and 2023, contract value equaled fair value, and no adjustments were necessary.

Note 4 Information Prepared and Certified by Trustee

Certain information related to the investments in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024 was obtained or derived from the information furnished to the plan administrator and certified as complete and accurate by the Voya Retirement Insurance and Annuity Company, the custodian of the Plan.

Note 5 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan document to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

Note 6 Tax Status

The Company adopted a nonstandard prototype document with an IRS opinion letter dated June 30, 2020, which states the prototype Plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan remains open to examination through the applicable statutory periods.

Note 7 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8 Party-in-Interest Transactions

Certain Plan investments for the years ended December 31, 2024 and 2023 were managed by Voya Retirement Insurance and Annuity Company, Northwestern Mutual Investment Services and E.R.I.S.A., Inc. E.R.I.S.A., Inc. is the Third-party Administrator, Northwestern Mutual Investment Services is the Investment Advisor, and Voya Retirement Insurance and Annuity Company is the Recordkeeper as defined by the Plan. These transactions qualify as exempt party-in-interest transactions. See the supplemental schedule for the party-in-interest investments. Fees paid by the plan for the direct advisory services of Voya Retirement Insurance and Annuity Company, Northwestern Mutual Investment Services and E.R.I.S.A., Inc. amounted to \$34,866 and \$23,003 for the years ended December 31, 2024 and 2023, respectively.

Note 9 Reconciliation of Financial Statements to Form 5500

For the years ended December 31, 2024 and 2023, there were no differences between the audited financial statements and the Form 5500.

Note 10 Reclassification of Investments
