## Independent Auditors' Report

To the Plan Administrator of  
Presbyterian School 403(b) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Presbyterian School 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Presbyterian School 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of Presbyterian School 403(b) Plan. Because of the significance of the matter described in the *Basis for Disclaimer of Opinion* section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

### Basis for Disclaimer of Opinion

As discussed in Note 8, Presbyterian School 403(b) Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Presbyterian School 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


## **Auditors' Responsibilities for the Audit of the Financial Statements**

Notes to Financial Statements for the year ended December 31, 2024

### NOTE 1 – DESCRIPTION OF PLAN

The following brief description of Presbyterian School 403(b) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established January 1, 1993, covering substantially all employees of Presbyterian School (the School) except for those employees who normally work fewer than 20 hours per week. Covered employees are eligible to participate in the Plan immediately upon hire. An employee is eligible to receive employer contributions on the first day of the month coinciding with or next following the date of hire if the employee is classified as benefits eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Plan provides for both participant contributions and employer contributions as follows:

- *Participant contributions* – Participants may elect to contribute up to 100% of their compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code (the Code). All eligible employees hired on or after July 1, 2023, automatically have 4% of their compensation contributed to the Plan unless they elect not to defer or to defer an alternative amount. In addition, participants who have attained the age of 50 prior to the end of the Plan year or have at least fifteen years of service with a qualifying organization may make additional catch-up contributions, as defined by the Plan. Participants may elect to rollover any amounts they receive as distributions from another qualified retirement plan and to make after-tax Roth contributions to the Plan.
- *Employer contributions* – For all eligible employees, the School makes an employer matching contribution equal to 100% of the employee's elective deferral not to exceed 4% of the employee's compensation. The School also may elect to make a discretionary non-elective contribution to all eligible employees whether they actively contribute to the Plan or not. In the 2024 plan year, the School elected to make a non-elective contribution equal to 2% of eligible employees' compensation.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting – Participants are immediately 100% vested in all participant contributions and actual earnings thereon. Participants become 50% vested in employer contributions and actual earnings thereon after one year of credited service and 100% vested after two years of credited service.

Participant accounts – Each participant's account is credited with the participant's contribution, employer contributions, and an allocation of the investment earnings and expenses for each fund in which their account is invested. Allocations of investment earnings and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The only benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Notes receivable from participants – Participants may borrow from their participant account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in the preceding one-year period or 50% of their vested account balance. The balance in the participant's account secures the loan. Participants are limited to one outstanding loan at any time. Loan

terms range from one to five years, except when the loan is used to purchase a participant's principal residence, for which the loan may range from five to fifteen years. The interest rate on all loans is 1% over the prime rate published in the Wall Street Journal on the first business day of the month the loan is originated.

Forfeitures – The Plan uses any amounts forfeited to reduce future employer contributions or to pay plan expenses. During 2024, \$345 of forfeitures were used to reduce employer contributions. Unused forfeitures totaled \$255 and \$579 at December 31, 2024 and 2023, respectively.

Distribution of benefits – The Plan provides for benefit distributions to plan participants or their beneficiaries, equal to the balance of their vested accounts upon death, disability, retirement, or other termination of employment. Participants may withdraw a portion or all of their elective participant contributions and transfer account, while still employed, upon reaching the age of 59½. Additionally, participants may qualify for a hardship withdrawal of their fully vested account, except for matching and non-elective contributions invested in custodial accounts, while still employed, for the purpose of immediate and heavy financial needs, as defined by the Plan.

Plan termination – Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their employer contributions.

## **NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of accounting – The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and insurance companies. See Note 6 for discussion of fair value measurements.

The Plan invests in fully benefit-responsive investment contracts and presents these investments in the financial statements at contract value. Because contract value is the amount participants would receive if they were to initiate permitted transactions under the Plan, it is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. The contract value of fully benefit-responsive investment contracts represents contributions plus earnings, less participant withdrawals and administrative expenses.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions from Plan participants and the matching and discretionary contributions from the School are recorded in the year in which the participant contributions are withheld from compensation.

Benefit payments – Benefit payments to participants are recorded upon distribution.

Expenses – Certain expenses of maintaining the Plan are paid directly by the School and are excluded from these financial statements. Certain investment management fees are included in net appreciation in fair value of investments. Other investment-related and recordkeeping expenses paid by the Plan are included in administrative expenses.

Estimates – Management must make estimates and assumptions to prepare financial statements in accordance with generally accepted accounting principles. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions. Actual results could vary from the estimates that were used.

### **NOTE 3 – TAX STATUS**

The School has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Code. The Plan's required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The plan sponsor has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

### **NOTE 4 – INVESTMENTS**

At December 31, 2024 and 2023, certain assets of the Plan were invested in funds managed by Teachers Insurance and Annuity Association of America (TIAA), College Retirement Equities Fund (CREF) and Empower Annuity Insurance Company of America (Empower), as insurance companies of the Plan. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

## NOTE 5 – INFORMATION CERTIFIED BY INSURANCE COMPANIES

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to notes receivable from participants and investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA, CREF and Empower, qualified institutions.

## NOTE 6 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establish a hierarchy that prioritizes inputs used to measure fair value. The three levels of the fair value hierarchy are as follows:

- *Level 1* – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the reporting date.
- *Level 2* – Inputs are other than quoted prices included in Level 1, which are either directly observable or can be derived from or corroborated by observable market data at the reporting date.
- *Level 3* – Inputs are not observable and are based on the reporting entity’s assumptions about the inputs market participants would use in pricing the asset or liability.

Following is a description of the valuation methods and inputs used for each major class of assets measured at fair value. There have been no changes in the methods used at December 31, 2024 and 2023.

- *Mutual funds* are valued using quoted market prices and are traded on an exchange in an active market.
- *CREF accounts* invest principally in equity securities, fixed-income instruments and short-term investments in accordance with each portfolio’s investment objectives. Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who

may employ various pricing methods to value the investments, including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost. Each account determines its unit value each day. Unit values are published each day the New York Stock Exchange (NYSE) is open and are the basis for current transactions.

- *Non-benefit responsive fixed annuity contracts* are valued using a quantitative model based on assumptions of future interest rates and related discounted cash flows. Since the annuity is not available for sale or transfer on any securities exchange, transactions in similar investment instruments are not observable.
- *TIAA Real Estate Account* generally invests in real estate properties and real estate-related investments. The account’s value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional’s opinion. Securities held are priced using values obtained from independent pricing sources. Unit values are calculated and published each day the NYSE is open and are the basis for current transactions.

These valuation methods may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate, the use of different methods or assumptions could result in a different fair value measurement at the reporting date.

Purchases of Level 3 assets during the year ended December 31, 2024 totaled \$35,715. The following table represents the Plan’s Level 3 financial instruments, the valuation techniques used to measure the fair value of those financial instruments, and the significant unobservable inputs and the ranges of values for those inputs.

## NOTE 7 – INVESTMENT CONTRACTS WITH INSURANCE COMPANIES

### TIAA Contract

The Plan has entered into an investment contract with TIAA. The fixed annuity portion of this contract, or the TIAA Traditional Annuity Account (TIAA TAA), is maintained by TIAA in a general account and is backed by TIAA’s claim-paying ability. During the accumulation phase, TIAA TAA provides a guarantee of principal, a guaranteed minimum rate of interest, and the potential for additional interest if declared by TIAA. Together, the guaranteed minimum and additional amounts make up the “crediting rate” in the accumulation phase of the account. TIAA groups the funds received over discrete time periods into “vintages.” The interest credited to each vintage period reflects the investment returns initially obtained on TIAA’s investments during the period.

Certain TIAA contract types are fully benefit-responsive; therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to these contracts. Of the amounts invested in TIAA TAA, \$519,927 and \$513,563 are fully benefit-responsive at December 31, 2024 and 2023, respectively, and \$818,852 and \$814,270 are non-benefit responsive at

December 31, 2024 and 2023, respectively. Non-benefit responsive contracts contain liquidity restrictions on the redemption of TIAA TAA accumulations by participants, which could impact the value realized upon exiting the contract.

#### MassMutual Contract

The MassMutual Capital Preservation Account (MMCPA) investment option is a market value separate account investment option with a general investment account guarantee that provides a stated rate of return and insulates participants' accounts from daily fluctuations in the market. Under the terms of the MMCPA group annuity contract, participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their balance in the MMCPA investment option at contract value; therefore, the MMCPA is fully benefit-responsive and valued at contract value.

#### Crediting Interest Rates

##### *TIAA Contract*

The crediting interest rate is supported by the investment performance of a large, diversified portfolio (TIAA's general account), is correlated with the highest quality debt security yields, and is adjusted for contract liquidity, but may not be less than 1% to 3% based on the individual participant's contract type. TIAA declares a current interest rate annually.

##### *MassMutual Contract*

The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Empower declares the crediting interest rate quarterly based on the investment experience of the investment pool.

The Plan's ability to receive amounts due under each contract is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value under some of these contracts. Such events include: (1) complete or partial plan termination or merger with another plan, (2) plan sponsor events such as bankruptcy, spin-offs, divestitures, layoffs, or retirement incentive programs that cause a significant withdrawal from the Plan, (3) the liberalization of Plan withdrawal or transfer rules or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Upon occurrence of any of these events, a market value adjustment may apply. The School does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

#### **NOTE 8 – NET ASSETS AVAILABLE FOR BENEFITS**

The provisions of ERISA for plan years beginning after January 1, 2009 related to 403(b) plans were amended to include an audit requirement for large plans (generally those with 100 participants or more). Prior to that time, the School did not routinely receive participant account records from the third-party administrator. Further, the School's record retention policies did not result in the maintenance of payroll

records dating to the inception of the Plan. As a result, adequate documentation was not available for the Plan to verify the proper balance of net assets available for benefits at December 31, 2017, which was the first year an audit was required.

**NOTE 9 – SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 8, 2025, which is the date that the financial statements were available for issuance. As a result of this evaluation, no events were identified that are required to be disclosed or would have a material impact on reported net assets available for benefits or changes in net assets available for benefits.
