Independent Auditor's Report

NOTE 1. DESCRIPTION OF PLAN

The following description of the Ellington Management Group 401(K) & Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more detailed and complete description of the Plan’s provisions. The Plan was adopted by Ellington Management Group LLC (the “Company”).

A. GENERAL

The Plan is a defined contribution plan which became effective February 1, 1996, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all employees of the Company. The Board of Trustees oversees governance of the Plan. The Plan’s Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Trustees.

B. CONTRIBUTIONS

Each year, participants may contribute up to 100% of their annual pre-tax eligible compensation as defined in the plan document, not to exceed amounts prescribed by the Internal Revenue Service (IRS). Participants may elect to treat all or a portion of these deferral contributions as Roth contributions. Participants who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions up to amounts prescribed by the IRS. Participants may also contribute amounts representing distributions from other qualified plans as defined. Participants direct the investment of their contributions and the employer contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Company, at its discretion, may elect to make a qualified nonelective contribution to the Plan to satisfy the nondiscrimination rules, which apply to the Plan. Additionally, the Company, at its discretion, may elect to make a profit sharing contribution to eligible participants. Employees are eligible to receive the Company’s discretionary employer profit sharing contribution upon completion of three consecutive months of service as defined by the plan document. To be eligible to receive the discretionary employer profit sharing contribution, participants must also complete at least 500 hours of service during the plan year and must be employed on the last day of the plan year, with the exception of the participant’s death or termination of employment due to disability or normal retirement that occurs at the time the participant is still employed by the Company. The Company did not make any contributions for 2024. Contributions are subject to certain statutory limitations.

C. PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution and allocations of (a) the Company's discretionary contributions and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. VESTING

Participants are immediately vested in their contributions and the Company's qualified non elective contributions plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions and earnings thereon will be vested as follows:

2 to 3 years	20%
3 to 4 years	40%
4 to 5 years	65%
5 years or more	100%

E. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%. Interest rates are determined by the prime rate as published in the Wall Street Journal on the 14th day of each month plus 1%. Principal and interest is paid ratably through payroll deduction within a maximum term of five years. If the note is used to purchase a primary residence, then a longer repayment term is permitted. A participant may only have one note outstanding at a time.

F. PAYMENT OF BENEFITS

Participants become fully vested in their accounts upon termination of service due to death, disability or normal retirement. On termination of service due to any other reason, a participant will receive the value of the participant's vested interest in their account. Upon severance of service, participants whose vested account balance is \$1,000 or less will receive a distribution of their account as a lump-sum distribution unless the participant makes an affirmative election to rollover such amount to an Individual Retirement Account or Annuity ("IRA") or a qualified retirement plan. Participants whose vested account balance exceeds \$1,000 must consent to receive a distribution and may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump sum amount, partial payment or as a rollover to an IRA or a qualified retirement plan.

However, the plan administrator may choose to immediately distribute account balances whose value exceeds \$1,000 if the participant has terminated service and has reached the later of age 62 or normal retirement age.

Hardship and in-service withdrawals are permitted, as defined in the plan document.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

B. USE OF ESTIMATES

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

C. INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan’s valuation policies. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received rather than on an ex-dividend date, and the effect is not material to a fair presentation. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

D. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

E. PAYMENTS OF BENEFITS

Benefits are recorded when paid.

F. OPERATING EXPENSES AND ADMINISTRATION

For 2024, the Plan paid all of the expenses of the Plan including administrative fees, investment fees, and the annual audit fees. Investment related expenses are included in net appreciation in fair value of investments.

G. DATE OF MANAGEMENT'S REVIEW OF SUBSEQUENT EVENTS

Subsequent events were evaluated through September 18, 2025, which is the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4. CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC, agent for Ascensus Trust Company (the trustee of the Plan).

NOTE 5. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

In 2024, the Plan paid \$27,032 to Goldgrab CPA PLLC, the plan auditors, representing the 2023 plan year annual audit fee. This transaction qualifies as a party-in-interest transaction.

This party-in-interest transaction is exempt from the prohibited transaction rules of ERISA.

NOTE 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7. TAX STATUS

The Internal Revenue Service has determined and informed Ascensus Inc. by a letter dated March 31, 2014 that their Prototype Non-Standardized Profit Sharing Plan with CODA (Cash or Deferred Arrangement), is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan adopted Ascensus Inc's Prototype Non-Standardized Profit Sharing Plan with CODA. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
