Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of ProSearch Strategies, LLC 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of the Plan

The following description of the ProSearch Strategies, LLC 401(k) Profit Sharing Plan & Trust (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by ProSearch Strategies, LLC (Company) and its subsidiaries for the benefit of its employees who are age 18 or older. There is no service requirement to be eligible. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). John Hancock Trust Company LLC (John Hancock) is the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 92% of their eligible compensation. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan provides for a guaranteed non-elective safe-harbor matching provision. The Company's non-elective safe-harbor matching contribution is 100% of the first 3% of a participant's eligible compensation. Employees are not required to make contributions into the Plan to receive the guaranteed non-elective safe-harbor contributions. The Plan also provides for a discretionary matching contribution as determined each year by management. For the years ended December 31, 2024 and 2023, the Company made a discretionary matching contribution of 100% of the first 3% of a participant's eligible compensation. In addition, the Company may also make discretionary profit-sharing contributions as determined each year by management. For the years ended December 31, 2024 and 2023, the Company made no discretionary profit-sharing contributions.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise.

Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions are immediately vested in their voluntary contributions and the Company's safe-harbor and matching contributions, plus the earnings thereon. The Company's profit-sharing contributions plus the actual earnings thereon, become 33% vested for each year of service until fully vested after three (3) years of service. If a participant attains age 60, becomes permanently and totally disabled, or dies; the full value of the employer profit-sharing contributions plus the actual earnings thereon becomes immediately vested.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. All loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. A participant may have one outstanding at one time.

Payment of Benefits

Upon termination of service, participants may receive a lump-sum amount equal to the value of their account. If the value of their account is greater than \$5,000, the account can be rolled over into an Individual Retirement Account (IRA). Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

Forfeited Accounts

Forfeitures of terminated participants are used first to pay administration fees and then used to reduce the annual Employer contribution including restoration of previously forfeited participant accounts. At December 31, 2024 and 2023, the amount of total forfeitures totaled \$0 and \$305, respectively. During the years ended December 31, 2024 and 2023, total forfeitures of \$305 and \$0, respectively, were used to pay Plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. The stable value fund is composed primarily of fully benefit-responsive investment contracts contained in a collective trust and is valued at net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Certain events would limit the ability of the Plan and the trust to transact at fair value. Plan management does not believe that any such events are probable of occurring.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule

Note 4. Investments and Fair Value Measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1:** Quoted prices in active markets for identical assets or liabilities
- Level 2:** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3:** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There were no Level 2 or Level 3 securities during 2024 and 2023.

Note 5. Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6. Plan Tax Status

The Plan operates under a non-standardized profit-sharing adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by John Hancock Retirement Plan Services LLC. The Plan has not submitted to the Internal Revenue Service (IRS) for an individual determination letter given receipt of an opinion letter dated June 30, 2020. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons. The Employer pays certain professional fees for the administration and audit of the Plan. The Plan paid \$3,839 and \$5,133 of recordkeeping fees during December 31, 2024 and 2023, respectively. Participant loans are secured by the balances in the participant accounts and fees relating to the loans are paid by the Participant.

Note 9. Reconciliation of Financial Statement to Form 5500

The net assets available for benefits per the financial statements are higher than the Form 5500 at December 31, 2024 and 2023 by \$170,558 and \$170,313, respectively. The difference at December 31, 2024 and 2023 relates to contributions receivable. The net increase in net assets available for benefits per the financial statements is more than the net increase per the Form 5500 for the year ended December 31, 2024 by \$245, which relates to the change in contributions receivable. The net increase in net assets available for benefits per the financial statements is more than the net increase per the Form 5500 for the year ended December 31, 2023 by \$170,313, which relates to the change in contributions receivable.

Note 10. Subsequent Events

Subsequent events have been evaluated through August 8, 2025, which is the date the financial statements were available to be issued.

Note 1. Description of the Plan

The following description of the ProSearch Strategies, LLC 401(k) Profit Sharing Plan & Trust (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by ProSearch Strategies, LLC (Company) and its subsidiaries for the benefit of its employees who are age 18 or older. There is no service requirement to be eligible. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). John Hancock Trust Company LLC (John Hancock) is the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 92% of their eligible compensation. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan provides for a guaranteed non-elective safe-harbor matching provision. The Company's non-elective safe-harbor matching contribution is 100% of the first 3% of a participant's eligible compensation. Employees are not required to make contributions into the Plan to receive the guaranteed non-elective safe-harbor contributions. The Plan also provides for a discretionary matching contribution as determined each year by management. For the years ended December 31, 2024 and 2023, the Company made a discretionary matching contribution of 100% of the first 3% of a participant's eligible compensation. In addition, the Company may also make discretionary profit-sharing contributions as determined each year by management. For the years ended December 31, 2024 and 2023, the Company made no discretionary profit-sharing contributions.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise.

Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participant contributions are immediately vested in their voluntary contributions and the Company's safe-harbor and matching contributions, plus the earnings thereon. The Company's profit-sharing contributions plus the actual earnings thereon, become 33% vested for each year of service until fully vested after three (3) years of service. If a participant attains age 60, becomes permanently and totally disabled, or dies; the full value of the employer profit-sharing contributions plus the actual earnings thereon becomes immediately vested.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. All loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. A participant may have one outstanding at one time.

Payment of Benefits

Upon termination of service, participants may receive a lump-sum amount equal to the value of their account. If the value of their account is greater than \$5,000, the account can be rolled over into an Individual Retirement Account (IRA). Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

Forfeited Accounts

Forfeitures of terminated participants are used first to pay administration fees and then used to reduce the annual Employer contribution including restoration of previously forfeited participant accounts. At December 31, 2024 and 2023, the amount of total forfeitures totaled \$0 and \$305, respectively. During the years ended December 31, 2024 and 2023, total forfeitures of \$305 and \$0, respectively, were used to pay Plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. The stable value fund is composed primarily of fully benefit-responsive investment contracts contained in a collective trust and is valued at net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Certain events would limit the ability of the Plan and the trust to transact at fair value. Plan management does not believe that any such events are probable of occurring.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule

Note 4. Investments and Fair Value Measurement

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1:** Quoted prices in active markets for identical assets or liabilities
- Level 2:** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3:** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There were no Level 2 or Level 3 securities during 2024 and 2023.

Note 5. Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6. Plan Tax Status

The Plan operates under a non-standardized profit-sharing adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by John Hancock Retirement Plan Services LLC. The Plan has not submitted to the Internal Revenue Service (IRS) for an individual determination letter given receipt of an opinion letter dated June 30, 2020. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons. The Employer pays certain professional fees for the administration and audit of the Plan. The Plan paid \$3,839 and \$5,133 of recordkeeping fees during December 31, 2024 and 2023, respectively. Participant loans are secured by the balances in the participant accounts and fees relating to the loans are paid by the Participant.

Note 9. Reconciliation of Financial Statement to Form 5500

The net assets available for benefits per the financial statements are higher than the Form 5500 at December 31, 2024 and 2023 by \$170,558 and \$170,313, respectively. The difference at December 31, 2024 and 2023 relates to contributions receivable. The net increase in net assets available for benefits per the financial statements is more than the net increase per the Form 5500 for the year ended December 31, 2024 by \$245, which relates to the change in contributions receivable. The net increase in net assets available for benefits per the financial statements is more than the net increase per the Form 5500 for the year ended December 31, 2023 by \$170,313, which relates to the change in contributions receivable.

Note 10. Subsequent Events

Subsequent events have been evaluated through August 8, 2025, which is the date the financial statements were available to be issued.
