### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nemak USA, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the years ended December 31, 2024, and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Note 1. Description of Plan**

The following description of the Nematik USA, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, a copy of which is available from the Plan sponsor, Nematik USA, Inc. (the "Company").

General

The Plan is a defined contribution plan covering all qualified employees of the Company who have completed three months of service. Employees may begin participating on the first day of the month coinciding with or following the date three months of service is completed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100 percent of their pre-tax and after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible pre-tax compensation and their contributions invested in a designated fund until changed by the participant. All participants, excluding Wisconsin hourly employees hired before January 1, 2015, are subject to an automatic deferral increase of 1 percent annually, to a maximum of 15 percent unless they affirmatively elect to opt out of the automatic deferral increase.

On behalf of each employee who has met the eligibility requirements to contribute to the Plan, the Company shall make a safe harbor qualified non-elective contribution in an amount equal to 3 percent of participants' eligible compensation for the Plan year. As of July 1, 2020, the Plan suspended all safe harbor contributions effective July 1, 2020 for the remainder of the 2020 Plan year. The Plan reinstated the safe harbor qualified non-elective contribution in an amount equal to 3 percent of participants' eligible compensation effective January 1, 2021.

As determined by the Company's Board of Directors, the Company may elect to make a discretionary match to all eligible participants. The Company may also elect to make a discretionary profit-sharing contribution to each eligible participant's account, as defined by the Plan. During 2024 and 2023, the Company did not elect to make a discretionary match or profit-sharing contribution.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions as well as allocations of the Company's discretionary profit-sharing contributions and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from that participant's vested account.

Vesting

The Plan provides separate vesting provisions for certain employees that joined the Plan through a merger in 2014. However, all participants are immediately vested in their voluntary employee contributions and the Company safe harbor qualified non-elective contributions plus actual earnings or losses thereon.

All employees with the Company vest in the Company's discretionary profit-sharing contributions and discretionary match contributions, other than certain match contributions described below or safe harbor qualified non-elective contributions, plus actual earnings or losses thereon based on years of continuous service and are subject to the following vesting schedule:

Payment of Benefits

On termination of service due to death, disability, retirement or termination, a participant may elect to receive a lump-sum distribution, a direct rollover or a combination lump-sum and direct rollover distribution equal to the value of the vested interest of the participant's account. After attaining age 59 ½, a participant may elect to receive an in-service distribution for all or a portion of their vested balance in accounts in which they are fully vested. Upon a participant attaining age 65, in-service withdrawals are permitted from all accounts. Hardship distributions are also available from a participant's elective deferral and rollover account balance subject to regulatory requirements.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the outstanding balance of loans from the Plan as defined, or 50 percent of their vested account balance. The loans are collateralized by the balance in the participants' accounts and bear interest at a rate determined by the Plan administrator at 1.00 percent above the prime rate. Interest rates fluctuated between 8.5% and 9.5% during the years ended December 31, 2024 and 2023. Participants may apply for only one loan each year and may only have two loans outstanding at any given time. Principal and interest are paid ratably through payroll deductions.

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of a participant's account, as defined by the Plan, represents a forfeiture. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,596 and \$58,234 respectively. These accounts are first used to pay administrative expenses of the Plan and any remainder is applied to reduce the contributions from the Company. During 2024, forfeitures totaling \$58,445 were used to pay administrative expenses.

**Note 2. Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is a price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

All expenses related to maintaining the Plan are paid by the Plan; however, the Company may, at its discretion, pay any or all such expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**Note 3. Information Certified by Fidelity Personal Trust Company, FSB**

All investment information disclosed in the accompanying financial statements and supplemental schedule, including cash and cash equivalents and investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments and interest, dividends, and other income for the years then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Personal Trust Company, FSB ("Fidelity"), the trustee of the Plan.

**Note 4. Related Party and Party-In-Interest Transactions**

Sentinel Benefits & Financial Group ("Sentinel") serves as the Plan's third-party administrator and investment advisor. Fees paid to Sentinel for these services totaled \$400,751 and \$418,585 for the years ended December 31, 2024, and 2023, respectively. The remaining administrative expenses included in the statements of changes in net assets available for benefits related to accounting services provided to the Plan. These transactions qualify as exempt party-in-interest transactions.

**Note 5. Income Tax Status**

The Company has adopted a volume submitter plan sponsored by Alliance Benefit Group of Michigan, Inc. and Affiliates, which received its latest advisory letter dated November 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The volume submitter plan has been amended since receiving the advisory letter. The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification ("ASC") Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability;
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

*Collective investment trusts:* Valued based on NAV of units of the collective investment trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. ASC Topic 820 allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. The Plan administrator has determined the collective investment trusts held by the Plan meet the requirements for the NAV practical expedient.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
