Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of the Polymer Additives, Inc. 401(k) Savings Plan (the Plan), which was created and effective January 1, 2015, is provided for general information purposes only. The Company is the sponsor of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Eligibility: The Plan is a defined contribution plan, covering certain full-time employees of Polymer Additives, Inc. and its U.S. locations (collectively, the Company). Employees are eligible to participate in the Plan on the date of hire.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Contributions: Participants may elect to make voluntary contributions to the Plan through payroll deductions of a percentage of their annual wages, subject to certain limitations. Participants who are age 50 or older by the last day of the plan year are eligible to make additional catch-up contributions. All non-union employees receive a discretionary matching contribution. All Wayside and Walton Hills union employees receive a fixed matching contribution.

Fort Worth participants receive Company contributions of \$1.85 per hour paid, subject to terms in their collective bargaining agreement. Walton Hills participants receive Company contributions based upon hours paid, amount subject to specific terms within their respective union contract. Employer contributions for Fort Worth and Walton Hills participants subject to collective bargaining agreements were \$168,731 in 2024.

Walton Hills union employees and all non-union employees hired on or before April 30, 2020, receive a basic pension contribution based upon participant compensation up to the Social Security wage base, in addition to a contribution rate based upon compensation above the Social Security wage base, subject to limitations. Basic pension contributions, which may be contributed at the option of the Company, were \$199,384 for 2024.

Participants direct the investment of their contributions, as well as the Company's contribution, into the various investment options offered by the Plan. The Plan also allows for transfers or rollovers into the Plan from other qualified plans or retirement accounts.

Payment of Benefits: On termination of service, due to death, disability, retirement or other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Vesting: Participants are immediately vested in their voluntary contributions, plus earnings thereon. Participants become fully vested in employer matching contributions and special non-elective contributions on a five-year graded vesting schedule based on years of continuous service. Fort Worth union employees become fully vested in other employer non-elective contributions after completion of two years of service. To earn a year of service, participants must be credited with at least 1,000 hours of service during a Plan year. The non-vested balance is forfeited upon termination of service.

Forfeitures: Forfeitures of employer matching contributions are used to reduce any nonelective contribution or to reduce any matching contribution. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$107,602 and \$165,365, respectively.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their total vested account balance. Note terms range from one to five years, however, when the note is for the purchase of a primary residence, the note term may extend to 20 years. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan administrator. Participants are limited to two outstanding loans.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the net appreciation in fair value of investments reported by the Plan.

Termination: Although it has not expressed any intent to do so, the Company has the right under the agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 23, 2025, which is the date the financial statements were available to be issued.

As disclosed in Note 6, the Plan's fully benefit-responsive investment contract with Empower Annuity Insurance Company of America was liquidated at contract value on May 9, 2025, following a 12-month put notice submitted in 2024. Participant balances were transferred to the Putnam Stable Value Fund SA, a synthetic guaranteed investment contract held through a collective investment trust.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The financial statements of the Plan are prepared on the accrual basis.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive investment contracts, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts,

because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Accounting Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from those estimates.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Risks and Uncertainties for Investments: The Plan provides for various investment options in mutual funds and other investments. The underlying investment securities are exposed to various risks, such as interest rate, liquidity, market, and credit risks. Market risks include risks associated with ongoing global events. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participants' individual account balances.

Payment of Benefits: Benefits are recorded when paid.

NOTE 3 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. In addition, the Plan's payment of investment management fees qualify as party-in-interest transactions. The Plan holds a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America, which qualifies as a party-in-interest. Empower Annuity Insurance Company of America and Empower Trust Company, LLC hold the Plan investment assets and execute investment transactions and, therefore, these transactions and payments of fees to Empower Annuity Insurance Company of America and Empower Trust Company, LLC qualify as party-in-interest transactions. In addition, notes receivable from participants are considered party-in-interest transactions.

NOTE 4 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (the trustee of the Plan).

NOTE 5 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are based upon the closing net asset value per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Plan holds a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America (Issuer). The contract value of this investment contract was \$1,336,397 and \$1,338,360 as of December 31, 2024 and 2023, respectively. The Issuer maintains the contributions in its general account. The crediting interest rate of the contract is based on an agreed-upon formula with the Issuer, as defined in the contract agreement, but cannot be less than zero. Such interest rates are reviewed on a semi-annual basis for resetting. The Issuer's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact distributions at less than contract value is not probable.

Effective August 1, 2024, the Plan amended its investment contract to replace the Guaranteed Interest Fund with the EI Fixed Account – Series Class VI, both issued by Empower Annuity Insurance Company of America. Participant balances and future contributions were mapped to the new investment option, which is held in the issuer's general account, qualifies as a fully benefit-responsive investment contract, and is recorded at contract value as of December 31, 2024.

On May 9, 2024, the Plan submitted a 12-month notice to terminate the investment contract and receive a book value payout. The contract remains fully benefit-responsive through year-end and continues to accrue interest during the notice period. In May 2025, the contract was liquidated at contract value, and participant balances were transferred to the Putnam Stable Value Fund SA, a synthetic guaranteed investment contract held through a collective investment trust.

NOTE 7 – PLAN TAX STATUS

The Internal Revenue Service issued an opinion letter dated February 1, 2023 indicating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, Plan management believes that the Plan is designed and being operated in compliance with applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
