**December 31, 2024 and 2023**

**NOTE 1 — DESCRIPTION OF THE PLAN**

The following description of Wellabe 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement (Agreement) for a more complete description of the Plan's provisions.

**General**

The Plan is a safe harbor defined contribution plan covering substantially all eligible employees of Wellabe Services Company (the Company and Plan Administrator). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute up to 85% of eligible compensation on a pre- or post-tax basis, subject to the maximum amount allowed by the Internal Revenue Code (IRC) for the Plan year. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation (increasing annually by 1% up to a max of 10%) and their contributions invested in a designated balanced fund until changed by the participant. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company matches 100% of participant deferrals up to 6% of eligible compensation.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contribution, as well as an allocation of Plan earnings and losses. Participant accounts are charged a recordkeeping fee of \$82 per annum, which is billed in equal quarterly installments. Participant accounts may also be charged with an allocation of administrative expenses that are paid by the Plan. Administrative expense allocations are based on account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. Loans must be for a minimum of 1 year but cannot exceed 5 years unless used for the purchase of a primary residence, in which case the term could be up to 15 years. The notes are secured by the balance in the participant's account and bear interest at the 1% over the U.S. Prime Rate at the date of issuance. Principal and interest are paid ratably through payroll deductions. Interest rates range from 4.25% to 9.50% for notes receivable outstanding at December 31, 2024.

**NOTE 1 — DESCRIPTION OF THE PLAN (Continued)**

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. All employer contributions are 100% vested for employees who had at least one hour of service after December 31, 2010.

**Payment of Benefits**

Upon termination of service, participants may elect to receive the vested interest in their account as either a single lump sum, non-recurring partial payments or recurring installment payments. If the total vested amount that a participant is entitled to receive does not exceed \$1,000, a lump sum distribution must be taken by the participant upon termination of service. In addition, in-service distributions are permitted for participants who are at least 59.5 years of age.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts were \$846 and \$62,444, respectively. Forfeitures are used to reduce future Company contributions and to pay Plan administrative expenses. The Plan utilized \$51,715 and \$79,303 of its forfeitures to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively. The Plan also utilized \$11,000 and \$1,800 of its forfeitures to pay Plan administrative expenses during the years ended December 31, 2024 and 2023, respectively.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, the accrued benefits of all participants shall be distributed to participants as provided in the Agreement.

**NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Contributions**

Contributions from participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Risks and Uncertainties**

The Plan utilizes various investment securities, including mutual funds and a common collective trust. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820, in descending order of priority, include: Level 1, defined as observable inputs such as quoted prices in active markets for identical assets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring the Plan to develop its own assumptions. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued based on quoted prices of identical assets in active markets.
- *Common collective trust*: Valued at the net asset value (NAV) of units as determined by VFTC. NAV is a readily determinable fair value and is the basis for current transactions.

**NOTE 5 — INCOME TAX STATUS**

The Plan used a prototype plan document sponsored by The Vanguard Group. The Vanguard Group received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which stated that the prototype document satisfied the applicable provisions of the IRC. The Plan itself did not receive a determination letter from the IRS. However, the Plan's management believes that the Plan is designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax was included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, no such positions exist.

**NOTE 6 — TRANSACTIONS WITH PARTY-IN-INTEREST**

Certain Plan investments are managed by an affiliate of VFTC. VFTC is the trustee and recordkeeper for the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Fees paid to VFTC are based on reasonable rates for such services and are paid by the Company.

**NOTE 7 — SUBSEQUENT EVENTS**

The Plan evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.
