INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Cee Kay Supply, Inc. Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cee Kay Supply, Inc. Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Responsibilities of Management for the Financial Statements

NOTE 1 — DESCRIPTION OF PLAN

The following description of the Cee Kay Supply, Inc. Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Cee Kay Supply, Inc. (the Company and Plan Sponsor) and participating employers. All employees of the Company, excluding nonresident aliens and part-time/temporary/seasonal employees, who have reached the age of 19 and have 60 days of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

T. Rowe Price Retirement Plan Services provides recordkeeping services to the Plan. Reliance Trust Company is the custodian and trustee of the Plan's investments. An officer of Cee Kay Supply is the Plan Administrator and has overall responsibility for the operation and administration of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On September 4, 2024, the Plan was amended to add a waiver for eligibility requirements and entry date for former employees of Welds Supply, as well as include service with Welds Supply for vesting purposes, effective January 1, 2023. In addition, certain provisions provided by the CARES Act and SECURE Act were incorporated into the plan document.

Contributions

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan. The Company automatically enrolls eligible employees with a deferral contribution of 3% unless the employee elects otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also elect to make after-tax contributions to a Roth account.

Employer matching contributions are determined separately by each participating employer and allocated solely to the participants employed by such participating employers. Matching contributions were \$225,700 for the year ended December 31, 2024, and were allocated to participant accounts in 2025.

Profit sharing contributions are calculated using an integrated formula. Profit sharing contributions are determined annually by each employer and are allocated to each participant employed on the last day of the year based upon the profit sharing formula. There were no profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain limitations. Participants may also transfer funds to the Plan from other qualified retirement plans.

NOTE 1 — DESCRIPTION OF PLAN (Continued)

Investment Options

Participants of the Plan elect investment accounts in which their contributions, as well as employer contributions, are invested. The investment account options comprise various degrees of risk and return.

Participant Accounts

Each participant's account is credited with the participant's contribution, employer matching contribution, and profit sharing contributions plus investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions. Vesting in the employer matching contribution and profit sharing contribution portions of their accounts is based on years of service, as follows:

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is 1% above the prime rate. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

Participants may elect to receive an amount equal to the value of the vested interest in their accounts in either lump-sums, substantially equal installments or partial withdrawals, depending on the size of the participant's account balance at the time of distribution. Participants with a vested account balance of less than \$5,000 must take a lump-sum distribution.

NOTE 1 — DESCRIPTION OF PLAN (Continued)

The Plan Sponsor may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from a participant's pre-tax deferral and Roth deferral contribution accounts and are subject to specific statutory and regulatory requirements. Rollover contributions may be withdrawn at any time. In-service distributions from elective deferral contributions are permitted after the participant has attained age 59½ and from all accounts at age 60 (normal retirement age).

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts may be used to reduce employer contributions or to pay administrative expenses. For the year ended December 31, 2024, forfeitures of \$19,654 were used to reduce employer contributions and \$339 to pay expenses. Forfeited nonvested accounts were \$23,469 and \$4,024 at December 31, 2024 and 2023, respectively.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from participants are recorded in the period in which they are withheld from the participant's wages. Contributions from the Company are recorded in the period in which the related participant's wages are paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

Subsequent Events

Subsequent events were evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

NOTE 3 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 3 — FAIR VALUE MEASUREMENTS (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.

Mutual funds: Valued at the daily closing price reported by the fund, which is the quoted NAV of shares.

Common/collective trusts: Valued at the NAV of the fund, which is based on the estimated market value of the underlying investments. The stable value common/collective trust invests in a fund in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value.

NOTE 4 — CERTIFIED INVESTMENTS

Information related to investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, disclosed in the accompanying financial statements and supplemental schedules, was obtained or derived from data provided to the plan administrator and certified to as complete and accurate by Reliance Trust Company, the trustee.

NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are units of pooled separate accounts and an insurance contract managed by T. Rowe Price. T. Rowe Price is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as these are not direct payments by the Plan.

NOTE 6 — PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their company contributions.

NOTE 7 — TAX STATUS

As this Plan is a non-standardized pre-approved profit sharing plan, the Internal Revenue Service issued an advisory letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this Plan will be considered to have a plan qualified under code Section 401(a) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the non-standardized plan agreement.

The Plan is subject to examination by the IRS for the statutory period.

NOTE 8 — DELINQUENT CONTRIBUTIONS

During the year ended December 31, 2024, the Company failed to remit to the Plan's trustee/custodian certain employee contributions totaling \$58,446 within the period prescribed by the Department of Labor's regulations. The delay in remitting contributions to the trustee/custodian was due to administrative error. The Company intends to fully restore affected participants' accounts for potential lost income due to the delays.
