1. Plan Description

The following brief description of the Roloff Construction Employee Stock Ownership Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2024, to enable eligible employees to benefit from common stock ownership interests in L. G. Roloff Const., Co., Inc. d/b/a Roloff Construction (the Company). The Plan is intended to be an employee stock ownership plan (ESOP) within the meaning of Section 4975(e)(7) of the Internal Revenue Code of 1986, as amended, and is intended to invest in "qualifying employer securities," as defined in Code Section 409(1), in accordance with Treasury Regulation Sections 54.4975-11(a)(2) and (11)(b). The Plan was established to provide retirement benefits for the employees of the Company.

Eligibility and Contributions

Employees, excluding leased, union, nonresident aliens, and certain former owners of the Company are eligible to participate in the Plan on the first day coinciding with or the next following date on which the employee has been credited with one hour of service. Participants who are not employed on the last day of the Plan year are not eligible for an allocation of Company contributions for such year. Participants who are not employed on the last day of the Plan year due to retirement, death, or disability are still eligible for an allocation of Company contributions for such year.

Payment of Benefits

Distributions from the Plan will be made when a participant retires, dies, becomes disabled, or otherwise terminates employment with the Company, as defined by the Plan. Distributions are in lump sums or substantially equal annual installments not to exceed five years made in cash. Distributions under \$7,000 will be paid out to the participant in a lump sum payment no later than the 60th day after the close of the Plan year of termination. In the event the participant does not elect a payout option, distribution payments between \$1,000 and \$7,000 will be directly rolled over to an individual retirement account designated by the Plan Administrator. Distributions under \$1,000 will be paid out in cash. Plan provisions include a distribution threshold of \$25,000, which applies to all distribution requests except for death or disability. If a participant elects a lump sum distribution with an account balance exceeding this threshold, plan provisions include steps to convert the request to installments to remain under this threshold annually (as defined by Plan document). This distribution threshold is subject to change by the Company.

Participant Accounts and Forfeitures

Each participant's account is credited with a) an allocation of Company contributions, which includes cash or Company stock, b) forfeiture of terminated participants' non-vested accounts, and c) Plan earnings or losses and expenses. Only those participants who are eligible employees of the Company as of the last day of the Plan year and have at least one hour of service during the Plan year will receive an allocation of Company contributions or forfeited non-vested balances. Allocations of Company contributions and forfeitures are based on a participant's eligible compensation, relative to total eligible compensation. No forfeitures were re-allocated to participants during the year ended December 31, 2024. Plan earnings or losses on investments are allocated on the basis of actual results of the Company stock and other Plan investments. Investments are maintained in individual member accounts managed by Boulay Group (Boulay).

Vesting

A participant's interest in allocated Company contributions is vested based on years of completed service. A participant remains 0% vested until three years of completed service is completed, at which time the participant becomes 100% vested. A year of service is deemed to be completed in a Plan year in which the employee completed at least 1,000 hours of service. Participants are immediately vested in their account balances upon normal retirement, death, or disability.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Other

Investment management expenses, recordkeeping expenses, audit fees and administrative expenses are paid by the Company and are excluded from the Plan's financial statements.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 26, 2025. See Note 7 for a description of subsequent events.

3. Administration of Plan Assets

The Plan's assets are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, who invests cash received, interest and dividend income, and makes distributions to participants. The trustee also administers the payment of interest and principal on loans, which is reimbursed to the trustee through contributions and dividends on common stock as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustees' fees are paid by the Company.

4. Employer Contributions

The Company will make contributions in cash to the Plan as determined by management, subject to limitations within the Plan provisions. The Company made discretionary cash contributions of \$1,500,000 during the year ended December 31, 2024, which is recorded as a receivable to the Plan as of December 31, 2024. The Plan collected this receivable on January 2, 2025.

5. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from Federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. No prior period income tax examinations exist as of the year-end December 31, 2024.

6. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to the Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Committee shall direct the trustee to pay all liabilities and expenses of the trust fund and sell shares of financed stock to the extent it determines such sale to be necessary in order to repay the loans.

7. Subsequent Events

Effective January 2, 2025, the Plan acquired 740,000 shares of the Company's common stock for \$6,500,000. The Plan funded this purchase utilizing \$1,500,000 of cash contributed by the Company to acquire 22,192 shares, which is reflected as employer contribution receivable in the accompany statement of net assets available for benefits. The Plan financed the remaining purchase of 717,808 shares from the Company through a \$5,000,000 installment note payable with the Company. The note payable calls for equal annual installments of \$262,149, including interest at 4.53%, through December 2069. This note is collateralized by the unallocated shares of the Company common stock held by the Plan. Subsequent to this redemption and purchase of stock, the Company is owned 100% by the ESOP.
