Note 1 Plan Description

The following description of Emery & Webb (the “Company”) 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of the Company who are age twenty-one or older with no minimum service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Subject to annual limitations established by the Internal Revenue Code (“IRC”) each year, participants may contribute a minimum of 1% up to 100% of eligible compensation, as defined by the Plan. Participants who have attained age 50 by December 31, are eligible to make catch-up contributions. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and the deferral rate will automatically increase by 1% on February 1st of each year, up to a maximum of 20%, unless the participant affirmatively elects out.

The Company may make a discretionary matching contribution. During the years ended December 31, 2024 and 2023, discretionary matching contributions were made in an amount equal to the percentage declared for the contribution period, \$1 for \$1 up to a maximum of 3% of the participant’s eligible compensation.

The Company may also make an additional discretionary nonelective contribution at its sole discretion, within the limits of the IRC.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, allocations of the Company’s contribution, and Plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The Company’s matching contribution are allocated to participant accounts each pay period. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their account is based on continuous years of service. A participant is 100% vested after six years of service.

Note 1 Plan Description (continued)

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate similar to that charged by commercial banks for similar loans, currently 4.25% – 9.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount equal to the participant's vested interest in their account, or a direct rollover into an individual retirement account. In-service and hardship withdrawals are also permitted by the Plan.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,247 and \$22,666, respectively. Forfeitures of employer contributions shall be used at the discretion of the Company, whether to pay Plan expenses or offset future employer contributions. For the years ended December 31, 2024 and 2023, Plan expenses in the amount of \$7,516 and \$10,400, respectively, were paid from forfeited non-vested accounts. During the year ended December 31, 2024, forfeited balances of \$7,192 were applied toward employer contributions. During the year ended December 31, 2023, there were no forfeited balances applied toward employer contributions.

Note 2 Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 Summary of Significant Accounting (continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value; see Note 5 for discussion of contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the years.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as benefit payments, reducing the participant notes receivable balance, based upon the provisions of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Plan allows certain administrative expenses to be paid from Plan assets, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to administration of participant accounts are charged directly to the respective accounts and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

Note 3 Information Certified by the Plan's Custodian and Trustees

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian, Empower Annuity Insurance Company, and the trustee Empower Trust Company, LLC.

Note 3 Information Certified by the Plan’s Custodian and Trustees (continued)

In addition, certain information related to investments and notes receivable from participants held at December 31, 2023 and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by the custodian, Empower Annuity Insurance Company, and the trustees: Prudential Bank & Trust, F.S.B. for the period from January 1, 2023 through March 31, 2023 and Empower Trust Company, LLC., as of December 31, 2023 and for the period April 1, 2023 through December 31, 2023.

Note 4 Fair Value Measurement

The Financial Accounting Standards Board’s (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 4 Fair Value Measurement (continued)

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued based on the daily NAV of the units held by the Plan at year end, which is used as a practical expedient to approximate fair value. Investments in pooled separate accounts represent a unit of account whose per unit value is the result of the accumulated values of the underlying investments determined at their fair value (NAV).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 Fully Benefit-Responsive Investment Contract

The Plan holds a traditional investment contract that meets the criteria of a fully benefit-responsive investment and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan by Empower Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal, or transfer of all, or a portion of their investment at contract value.

Note 5 Fully Benefit-Responsive Investment Contract (continued)

The issuer declares interest crediting rates semi-annually, effective January 1 and July 1, and that rate will be guaranteed against change during each six-month period. The declared interest rate will always be greater than or equal to 1.5%. Interest crediting rates are determined based on many factors. The key factors that influence future interest crediting rates could include the following: the level of market interest rates, the amount and timing of participant contributions, transfers and withdrawals into/out of the contracts and the duration of the underlying investments backing the contract.

Guarantees are based on the claims-paying ability of the issuer. Generally, there are no events that could limit the ability of the Plan to transact at contract value with the issuer or the participants. There are also no events that allow the issuer to terminate the contract, and which require the plan sponsor to settle at an amount different than contract value.

Note 6 Party-In-Interest Transactions

A party-in-interest is defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As described in Note 1, forfeitures of employer contributions may be used to pay expenses of the Plan. Also, as described in Note 2, fees related to the administration of participant accounts are paid from Plan assets. Therefore, payments to such service providers by the Plan qualify as party-in-interest transactions.

Empower Annuity Insurance Company, serves as recordkeeper and custodian for the Plan and is therefore considered to be a party-in-interest. Empower Trust Company, LLC serves as recordkeeper and trustee for the Plan and is therefore considered to be a party-in-interest.

Under the Company's Administrative Service Agreement with Empower Annuity Insurance Company, the Plan may receive revenue based on a percentage of average eligible Plan assets as defined in the agreement, which can be used to pay Plan administration expenses. During the years ended December 31, 2024 and 2023, \$34,158 and \$30,573, respectively, was received by the Plan which was used to pay Plan administrative expenses. As of December 31, 2024 and 2023, there were no amounts in the account available to pay Plan expenses.

The Plan makes loans to participants and therefore, these transactions qualify as a party-in-interest.

Note 7 Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their account balances and the net assets of the Plan will be allocated as prescribed by ERISA and regulations pursuant thereto.

Note 8 Tax Status

The Plan is an adoption of the Empower Retirement LLC Non-Standardized Pre-Approved Profit Sharing Plan With CODA (Cash or Deferred Arrangement), for which the Internal Revenue Service has determined and informed Empower Retirement LLC by an opinion letter dated September 16, 2022 that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letters, the Plan administrator and Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 10 Subsequent Events

Plan management has evaluated subsequent events through September 25, 2025, the date on which the financial statements were available to be issued.
