### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the financial statements of Knight Construction & Supply, Inc. Group Health Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, the statements of benefit obligations as of December 31, 2024 and 2023, and the related statement of changes in benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (modified cash basis) of Knight Construction & Supply, Inc. Group Health Benefit Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the benefit obligations as of December 31, 2024 and 2023, and the changes in its benefit obligations for the year ended December 31, 2024, in accordance with modified cash basis of accounting as described in Note 2.

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our opinion is not modified with respect to this matter.

#### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 2 and for determining the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Knight Construction & Supply, Inc. Group Health Benefit Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## Notes to Financial Statements

---

### Note 1 – Plan Description

The following description of the Knight Construction & Supply, Inc. Group Health Benefit Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a complete description of the Plan's provisions.

**General** – The Plan was established in January 2018 and provides health and other benefits covering substantially all employees of Knight Const. & Supply, Inc., Knight Boat Docks, Inc., and Knight Wall Systems, Inc., affiliated employers (collectively referred to as the Plan Sponsor or the Company). The Company established a Voluntary Employees' Beneficiary Association (the VEBA or Trust) to fund medical, dental, and vision claims. Certain other health and welfare benefits, including long-term disability and life insurance benefits, are paid by the Plan outside of the trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Eligibility** – Full-time employees of the Company are eligible to participate in the Plan upon completion of one calendar month of regular employment in a covered position. Participant's waiting period end on the first day of the month with their eligibility effective the first day of the month following the waiting period at which time coverage will become effective.

**Benefits** – The Plan provides health benefits including medical, hospital, surgical, major medical, pharmaceutical, dental, vision, life insurance, accidental death and dismemberment, temporary disability, long-term disability, long-term care, and flexible spending benefits to eligible employees who work full-time 30 or more hours per week, their dependents, employees not in a class excluded from coverage, and former employees and/or dependents that have elected to continue their coverage under COBRA (Consolidated Omnibus Budget Reconciliation Act of 1985) and its amendments.

The Plan includes options for eligible employees to contribute to a Flexible Spending Account (FSA). Full time employees and eligible part-time employees may specify dollars to be deducted from their pay on a pre-tax basis to be set aside for unreimbursed medical expenses and/or dependent care expenses. Participants contributed approximately \$56,400 during the year ended December 31, 2024. The Plan does not allow amounts to be carried forward to future years. FSA funds forfeited in 2024 totaled approximately \$3,400.

The Plan offers a Health Savings Account plan (HSA) for the exclusive benefit of and to provide health benefits to its eligible employees, their legal spouses, and eligible dependents. The HSA plan provides hospital, medical, and surgical coverage for eligible participants. The associated activity is excluded from the plan's financial statements as the amounts are contributed to accounts owned and maintained by the participant. Total employee and employer contributions to the HSA were approximately \$50,500 and \$68,100, respectively for the year ended December 31, 2024.

*Self-insured Benefits* – Medical, dental, and vision benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor under an administrative services only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust or the general assets of the Company. The ultimate responsibility for the payments to participants and providers, rests with the Plan Sponsor.

*Insured Benefits* – Life, accidental death and dismemberment, disability, and long-term care are fully insured. Contributions received and premiums paid for these benefits are paid from the general assets of the Plan Sponsor and are reported on the statement of changes in net assets available for benefits (modified cash basis).

The Plan maintained individual insurance policies (stop-loss) on medical benefits for the year ended December 31, 2024. The policy reimburses the Plan Sponsor for individual claims exceeding \$80,000 for the year ended December 31, 2024. Stop loss reimbursements totaling approximately \$315,000 for the year ended December 31, 2024, have been netted with claims paid in the accompanying statement of changes in net assets (modified cash basis).

**Contributions** – Participants contribute to the Plan through payroll deductions based on their elected benefits. Participants who have elected continued coverage under COBRA contribute to the Plan through direct remittances billed monthly based upon their elected benefits. The Company contributes to the Trust the cash necessary to secure the benefits provided.

Participant contributions to the Plan are made on a pre-tax basis pursuant to §125 of the Internal Revenue Code. The Plan Sponsor shares the cost with the participants. A contribution rate schedule is determined annually by the Plan Sponsor.

**Tax status** – The Trust established under the Plan to hold the Plan's assets is a nonexempt VEBA trust that is designed to be tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator is in the process of filing the Trust's tax exemption request with the IRS. The Plan administrator believes the Plan is in compliance with the applicable requirements of the IRC and, therefore, believes the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, Plan management has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Plan termination** – Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

### Note 2 – Summary of Significant Accounting Policies

**Basis of presentation** – The accompanying financial statements are prepared on the modified cash basis of accounting. Under the modified cash basis of accounting, securities transactions are recorded on the trade date at fair value, investment income is recorded when received, contributions are recorded when received, and claims and expenses are recorded when paid.

**Estimates** – The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Changes in these estimates and assumptions are considered reasonably possible and may have a material effect on the financial statements and thus actual results could differ from the amounts reported and disclosed herein.

**Benefit obligations** – Plan obligations at December 31, 2024 and 2023, for claims incurred but not reported, are estimated in accordance with accepted actuarial principles based on the claims data provided by the Plan's third-party claims administrators and an analysis of the Plan's lag time between the date of incurrence and the date the claim is paid. These amounts are paid by the Plan only if claims are submitted and approved for payment. Claims incurred but not reported are not reflected in the accompanying statements of net assets available for benefits (modified cash basis) or the statement of changes in net assets available for benefits (modified cash basis) but are included in the statement of benefit obligations and the statement of changes in benefit obligations.

**Cash** – The Plan Sponsor holds the medical, dental, and vision reserves of the Plan in separate trust accounts. Each month, the Plan Sponsor remits the amounts withheld from participants, as well as a Plan Sponsor contribution, to the trust accounts. Deposits maintained in the trust accounts are restricted for payment of plan expenses, claims, and premiums. From time to time, certain trust accounts that are subject to Federal Deposit Insurance Corporation coverage exceeded their insured limits. The deposits in trust exceeded insured amounts by approximately \$521,000 and \$523,000 as of December 31, 2024 and 2023, respectively.

**Payment of benefits (modified cash basis)** – Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits (modified cash basis).

Claims payments are recorded when reimbursed to the third-party claims processor by the Company. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits (modified cash basis).

**Refunds** – The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. Refunds are recorded when paid. Prescription refunds of approximately \$138,400 for the year ended December 31, 2024, were netted against claims.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

Management has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Benefit Obligations**

Qualified medical costs incurred by participants and their dependents are covered by the Plan. At the end of any Plan year, there may be claims that have been incurred by the participants and their dependents that have not yet been reported to the Plan. These claims are estimated based on claims paid subsequent to the Plan year end. As of December 31, 2024 and 2023, incurred but not reported medical, dental, and vision claims were estimated to be \$144,900 and \$139,500, respectively.

### **Note 4 – Administrative Expenses**

Administrative expenses, as presented in the financial statements, are paid from the net assets of the Plan's trust accounts. The Plan Sponsor pays certain other miscellaneous expenses on behalf of the Plan and is not reimbursed for those expenses.

### **Note 5 – Risks and Uncertainties**

The estimate of claims incurred but not reported is based on certain assumptions pertaining to claims experience and environmental factors, which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumption in the near term would be material to the financial statements.

### **Note 6 – Party-in-Interest Transactions**

The Plan administrator is an employee of the Plan Sponsor. There are no transactions between these parties other than contributions to the Plan and normal benefit payments.

Certain other miscellaneous expenses, such as legal fees, were paid from net assets of the Plan to various parties in interest. These miscellaneous expenses were immaterial during the year ended December 31, 2024.
