## INDEPENDENT AUDITORS' REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements**

We have performed an audit of the accompanying financial statements of Duly Health and Care 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

**1. DESCRIPTION OF THE PLAN:**

The following description of the Duly Health and Care 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions. Effective August 15, 2022, the Plan was amended to change the name of the Plan from DuPage Medical Group, Ltd. Profit Sharing/401(k) Plan to Duly Health and Care 401(k) Plan. Additionally, the plan sponsor was changed from DuPage Medical Group, Ltd. to Midwest Physician Administrative Services, LLC (the “Plan Sponsor”).

The Plan transitioned from Fidelity Management Trust Company and its affiliates (“Fidelity”) to Empower Trust Company, LLC and Empower Annuity Insurance Company of America (collectively “Empower”) as the recordkeeper and trustee/custodian effective May 1, 2023. In addition, the South Bend Clinic Employees’ Profit-Sharing Plan & Trust and the Quincy Medical Group Retirement Trust plan merged with the Plan on May 1, 2023.

General –

The Plan is a defined contribution plan covering all employees of Midwest Physician Administrative Services, LLC and participating related employers (collectively, the “Company”) who are age 21 or older and are not covered by a collective-bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions and Vesting –

Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the plan documents. The Plan also has a Roth feature whereby participants may elect to make after- tax contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. The Plan has an automatic enrollment feature so that any new employee is deemed to have elected to contribute 6% of compensation. This deemed election will remain in effect until such time as the participant elects to change the percentage of compensation deferred to the Plan. If a participant is automatically enrolled or affirmatively elects to defer a portion of eligible earnings less than 15%, the participant’s deferral percentage will automatically be increased by 1% each year, unless the participant opts out of such increases or the participant’s deferral percentage has been increased to 15% of their compensation.

The Company makes matching contributions at its discretion. In 2024 and 2023, the matching contribution was 50% of the first 6% of participant contributions. The Company may also make an additional profit-sharing contribution at its discretion to eligible participants, as defined in the Plan documents. There were no profit-sharing contributions made for the 2024 or 2023 Plan year.

**1. DESCRIPTION OF THE PLAN: (Continued)**

Contributions and Vesting – (Continued)

Participants with one year of service and who are active on the last day of the Plan year are eligible for the Company's matching contributions. In order to receive the Company's profit-sharing contribution, participants must have worked 1,000 hours in the current year, in addition to one year of service and being active on the last day of the Plan year.

Both participant and Company contributions are subject to the limitations of the Internal Revenue Code (the "Code").

Upon enrollment, participants may direct their own contributions and the Company's contributions to any of the Plan's fund options.

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service, with 20% vested each year for the first five years.

Retirement, Death, and Disability –

A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Forfeitures –

Upon termination of employment, participants forfeit their non-vested balances. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions or to pay the Plan's expenses. The unallocated forfeitures balance as of December 31, 2024, and 2023, was approximately \$893,000 and \$998,000, respectively. During 2024, \$1,157,984 was used to reduce employer contributions.

Participant Loans –

The Plan allows certain participants to rollover their existing loan balance from other qualified plans. The pre-existing loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the date of issuance as determined by the Plan administrator. Principal and interest are paid ratably by the participants through electronic payments. If participants terminate employment with the Company, they may continue to make loan payments through a pre authorized check agreement. If the loan is not repaid, it will be treated as a distribution to the participant. Participants are not allowed to borrow from their accounts.

**1. DESCRIPTION OF THE PLAN: (Continued)**

Investment Options –

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and the net appreciation in the fair value of investments, interest and dividends, interest income on notes receivable from participants, and other income for the years then ended, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity and Empower, the trustees of the Plan, and Empower Annuity Insurance Company of America.

Participant Accounts –

Each participant's account is credited with the participant's contributions and the Company's contributions and allocations of the Plan's earnings (losses). Allocations of earnings are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. The Plan has a self-directed brokerage account investment option whereby an individual account can be selected by a participant that allows the participant to choose to invest a portion of their accounts in investments outside the Plan's fund lineup. Participants may still participate in the Plan's core lineup of funds. Hardship withdrawals are only allowed from the employee deferral subaccount.

Distributions –

On termination of service, retirement, or death, participants (or their beneficiaries) may receive a lump-sum amount equal to the vested value of their account or elect to receive annual installments over a fixed, reasonable period of time. Lump-sum payments greater than \$1,000 and less than or equal to \$5,000 are automatically rolled into an individual retirement account if the participant does not make distribution elections. Participant account balances greater than \$7,000 may remain in the Plan. Lump-sum payments less than \$1,000 will be sent by check to the participant.

Administrative Expenses –

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include record-keeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses of the Plan are paid by the Company.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

Basis of Accounting –

The financial statements of the Plan are prepared on the accrual basis of accounting. Accordingly, investment income is recognized when earned and expenses are recognized when incurred.

Investment Valuation and Income Recognition –

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Realized and Unrealized Appreciation in fair Value of Investments –

Net realized gain on the sales of investments is calculated as the difference between the net proceeds and the cost of the investments on a specific identification basis.

Net unrealized gain in the fair value of investments is calculated as the difference between fair value of assets held at the beginning of the year or acquired during the year and the fair value of assets at the end of the year.

Notes Receivable from Participants –

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. No allowance for credit losses has been recorded as of December 31, 2024, or 2023.

Estimates –

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements, accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Credit Losses –

Financial assets measured at amortized cost are presented at the net amount expected to be collected and the measurement of credit losses and any expected increases in expected credit losses are recognized in earnings. The estimate of expected credit losses involves judgement and is based on an assessment over the life of the financial instrument taking into consideration current market conditions and reasonable and supportable forecasts of expected future economic conditions. The Plan determined the allowance for credit losses on financial assets measured at amortized cost was de minimis as of December 31, 2024 and 2023, therefore, no allowance for credit losses has been recorded related to those assets.

Contributions –

Participant contributions are accrued when deducted from employees' pay and are invested after receipt by the Trustee.

Contributions Receivable –

The Plan had contribution receivables from the Companies relating to contributions not yet funded as of December 31, 2024, and 2023. These contributions have subsequently been received by the Plan, no allowance for credit losses has been recorded.

Benefit Payments –

Benefits are recorded when paid.

**3. FINANCIAL DATA CERTIFIED BY THE TRUSTEE:**

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, which was prepared by, or derived from information prepared by Empower, the trustee of the Plan, and furnished to the plan administrator. The plan administrator has obtained a certification from the trustee that such information is complete and accurate.

**4. INVESTMENTS:**

Fair Value Measurements –

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable, either directly or indirectly, for substantially the full term of the asset or liability.

Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan:

*Registered investment companies:* Shares of registered investment companies are valued based on quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

*Self-directed brokerage accounts:* Accounts consist of mutual funds, common stock, exchange traded funds, and U.S. government securities (Level 1 inputs). The accounts also consists of corporate debt instruments (Level 2 inputs). Mutual funds are valued at quoted market prices, which represent the NAV of shares held by the Plan at year-end. Common stock, U.S. government securities and corporate debt instruments and exchange-traded funds are valued at the closing price reported in the active market in which the individual securities are traded.

*Common/collective trust funds:* Valued using the NAV provided by the administrator of the fund.

**5. FORMER PARTICIPANT BALANCES:**

At December 31, 2024 and 2023, net assets available for benefits include \$189,240,659 and \$157,888,891 respectively, of vested balances relating to individuals who are no longer active participants in the Plan.

**6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS:**

The Plan invests in various registered investment companies that are professionally managed by the trustees of the Plan and the holder of the Plan's assets, as defined by the Plan. Therefore, these transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

The Company provides certain other administrative services at no cost to the Plan.

**7. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT:**

The Plan holds a traditional investment contract. The contract, which is a guaranteed investment contract, meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. The fully benefit-responsive investment contract held by the Plan is the Empower Investments Fixed Account – Series Class III fund. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The contract value of the investment contract at December 31, 2024 and 2023 was \$25,094,118 and \$7,420,621, respectively.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a semiannual basis for resetting.

Empower Annuity Insurance Company of America or the Plan Sponsor may terminate the contract with advance written notice to the other party or parties.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet their financial obligations. The issuer's ability to meet their contractual obligations may be affected by future economic and regulatory developments.

**7. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT: (Continued)**

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

- Premature termination of the contract
- Plan termination or merger
- Bankruptcy of the Plan Sponsor or other Plan Sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

**8. PLAN TERMINATION:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

**9. TAX STATUS OF THE PLAN:**

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service ("IRS") dated November 14, 2022, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status.

The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

**9. TAX STATUS OF THE PLAN: (Continued)**

Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**10. RISKS AND UNCERTAINTIES:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**11. SUBSEQUENT EVENTS:**

The Plan evaluated subsequent events for the Plan through September 25, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025 the Plan was amended. The major changes to the Plan as a result of the amendment were:

- Eligibility Conditions – Participants are eligible to participate for purposes of matching contributions on their date of hire. However, they will actually participate in matching contributions once they reach the Entry Date.
- Entry Date – For purposes of matching contributions, Participant's Entry Date will be the first day of the month coinciding with or next following the date on which they satisfy the eligibility requirements..
- Allocation Conditions – Participants will always share in the matching contributions regardless of the amount of service they complete during the Plan Year. In order to share in non-elective contributions Participants must be employed on the last day of the Plan Year and have completed at least 182 consecutive days of employment during the Plan Year.
- Vesting Provisions – Participants of Quincy Physicians & Surgeons Clinic, PLLC and Quincy Physician Administrative Services, Inc. will be 100% vested at all times in all Accounts. Participant's APOM Plan Employer Nonelective Contribution Account, APOM Plan Matching Contribution Account and APOM Plan Prior Money Purchase Plan Account will be 100% vested at all times upon the attainment of age 60. The 3-year graded vesting schedule (1 YOS 33%, 2 YOS 67%, 3 YOS 100%) for matching contributions will apply to all actively employed participants on or after January 1, 2025 and terminated participants with account balance on January 1, 2025.
