## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements**

We have performed audits of the financial statements of Daybreak Game Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **NOTE 1 - PLAN DESCRIPTION**

The following description of the Daybreak Game Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) plan established as of May 1, 2015, to provide retirement benefits for eligible employees of Daybreak Game Company, LLC, Standing Stone Games, LLC and Singularity 6 Corporation (collectively the "Company" or "Employer") as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (the "Code"), as amended, and the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Participant Contributions

Under the terms of the Plan, participants may elect to defer a percentage of their regular earnings from the Company into the Plan. Such salary reduction contributions on a basis shall not exceed the maximum Internal Revenue Service ("IRS") dollar limit of \$23,000 per participant for the year ended December 31, 2024. In addition, participants who reach age 50 or older during the year may be eligible to make an additional "catch up" contribution. Such maximum additional contribution was \$7,500 for 2024. Participants may also contribute rollover distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. An additional 1% will be added annually up to 6% if the employee does not opt out.

Employer Contributions

The Employer has the right to make nonelective contributions to participant accounts which are allocated to each eligible participant in proportion to his or her compensation as a percentage of the compensation of all eligible participants. There were no nonelective contributions for the year ended December 31, 2024. The Employer also has elected to make safe-harbor matching contributions which equal to 100% of the participant's elective deferral not exceeding 1% of the participant's compensation, plus 50% of each participant's elective deferral in excess of 1%, but not in excess of 6% of the participant's compensation. The Employer made safe-harbor matching contributions totaling \$904,514 during the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, Plan earnings or losses, and an allocation of the Employer's contribution. Allocation of the Employer's contribution is based on participant contributions or eligible participant compensation, as defined in the Plan.

**NOTE 1 - PLAN DESCRIPTION (continued)**

Vesting

Participants are immediately vested in their contributions and are fully vested in the Employer's safe-harbor and nonelective contributions.

Hardship Withdrawals

Participants may request a hardship withdrawal as defined by the Plan.

Payment of Benefits

Participants are entitled to a distribution from their accounts upon termination of service due to retirement, death or upon incurring permanent disability. Participants may withdraw all or a percentage of their account balances attributable to their own contributions upon approval of the Plan Administrator. The Plan allows for the automatic distribution of participant vested account balances that do not exceed \$5,000.

Forfeited Accounts

Excess Employer contributions are treated as forfeitures and shall be applied to either reduce future Employer contributions made to the Plan or Plan expenses. There was approximately \$36,000 and \$27,000 of unallocated forfeitures at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, there was no forfeitures utilized to reduce Employer contributions or Plan expenses.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance during the one-year period prior to the date of the loan, or 50% of their vested account balance. Loans must be repaid within 5 years, unless the loan is used to acquire a principal residence. Loans bear interest at rates set forth by the Plan Administrator which approximate the prevailing market rates of interest and ranged from 4.25% to 9.50% as at December 31, 2024 and December 31, 2023. Principal and interest is paid ratably through payroll deductions.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to amend, modify, suspend or terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, all amounts credited to accounts of participants shall be paid to each participant in accordance with the Plan agreement.

SECURE 2.0 Act of 2022

The Plan has implemented certain requirements of the SECURE 2.0 Act of 2022 ("SECURE 2.0"). The provisions implemented in 2024 include, among others, an increase in the required minimum distribution age from 72 to 73, reduced service requirements for long-term, part-time employees to participate in the Plan, and remove the pre-death required minimum distribution requirement for Roth accounts. Future provisions will be adopted at later dates, as necessary, to comply with the requirements of SECURE 2.0.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the fully benefit-responsive investment contract, which is reported at contract value (see Note 6). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Plan Administrator determines the Plan's valuation policies utilizing information provided by its investment advisors and the trustee. See Note 7 for further discussion and disclosures related to the fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains (losses) on investments bought and sold during the year, as well as held year end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

The Employer provides, at no cost to the Plan, certain administrative, accounting, and legal services to the Plan and also pays the cost of certain outside services for the Plan. All transaction costs and certain Plan administrative expenses are paid for by the Plan.

**NOTE 3 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 4 - TAX STATUS**

The Plan has adopted a prototype plan of Empower Retirement, LLC and relies on the prototype plan's opinion letter dated November 14, 2022, from the IRS. The Plan has not applied for a determination letter from the IRS specific to the Plan. The Plan Administrator and the Plan's management believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believe that the Plan was qualified, and the related trust was tax exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 5 - INFORMATION CERTIFIED BY TRUSTEE**

As permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosures under ERISA, certain information prepared and certified by trustees need not be audited or reported on by an independent public accountant. Pursuant to that regulation, the Plan Administrator has instructed the independent public accountants not to perform any auditing procedures with respect to information certified by the Trustees, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, as of December 31, 2024 and 2023 and for the year ended December 31, 2024. This includes the cost and market values of the investments and notes receivable from participants, the activity therein, net appreciation/depreciation in fair value of investments, interest, dividend and other income and all information presented in the supplemental schedule of assets (held at year end). The Trustee has certified that this information is complete and accurate.

**NOTE 6 - GROUP ANNUITY CONTRACT**

The Plan has a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value approximates fair value.

Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

**NOTE 6 - GROUP ANNUITY CONTRACT (continued)**

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (a) Amendments to the Plan document (including complete or partial Plan termination or merger with another plan),
- (b) Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions,
- (c) Bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan or
- (d) The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. (Level 2) inputs include the following:
  - Quoted prices for similar assets and liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in markets that are not active
  - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). (Level 3) inputs include managements own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

**NOTE 7 - FAIR VALUE MEASUREMENTS (Continued)**

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value. There have been no significant changes in methodologies used on December 31, 2024, as compared to December 31, 2023.

- Mutual Funds - The fair values of these securities are based on observable market quotations for identical assets and are priced on a daily basis at the close of business.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

**NOTE 8 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets are invested in a fund managed by the Trustee. These transactions with the Trustee qualify as exempt party-in-interest transactions.

Empower Trust Company, LLC (“Empower”) provides certain administrative services to the Plan pursuant to an Administrative Services Agreement (“ASA”) between the Company and Empower. Empower receives revenue from collective trust service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services provided to the Plan. The Plan or the Company may make a payment to Empower for administrative expenses not covered by sharing of the excess revenue. If the revenue received by Empower from such collective trust service providers exceeds the amount owed under the ASA, Empower remits the excess to the Plan’s trust on an annual basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of participants. During 2024, the amounts remitted to the Plan were approximately \$53,000.

**NOTE 10 - PROHIBITED TRANSACTIONS**

During the year ended December 31, 2024, the Company failed to timely deposit employee deferrals, totaling \$4,159, within the timeframe required by the Department of Labor guidance. Late deposits are considered prohibited transactions and are included in the supplemental schedule, Schedule H, Line 4(a) – Schedule of Delinquent Participant Contributions for the year ended December 31, 2024. In June 2024, \$2,019 delinquent contributions were fully corrected. The 2023 delinquent contributions of \$2,140 were corrected in 2024.

**NOTE 11 - SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events and transaction for potential recognition or disclosures through August 15, 2025, which is the date that the financial statements were available to be issued.
