**Note 1 - Plan Description**

The following description of the Helfman Enterprises, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information only. Participants should refer to the plan document for a complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering eligible employees of Helfman Enterprises, Inc. (the plan administrator), and adopting employers (collectively, the Company or Employer) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was adopted by the Employer on August 1, 1993, and has since been amended and restated. Ascensus Trust Company serves as the Plan's asset custodian. The Plan maintains a recordkeeping agreement with Vanguard Group, Inc. (VGI), whereby VGI has subcontracted with Ascensus, LLC, an agent of Ascensus Trust Company, to provide the recordkeeping for the Plan. Two employees of the Company serve as limited trustees of the Plan.

**Eligibility**

Participation in the Plan is available on the first day of each calendar quarter for all employees who have completed six months of service and who have attained age 21. The Plan includes a savings feature designed to permit employees and the Company to contribute to the Plan, at amounts allowable under Section 401(k) of the Internal Revenue Code (IRC). Employees become eligible for discretionary employer matching contributions from the Employer after attaining the age of 21 and completing one year of service, as defined.

**Contributions**

Employee contributions are made to the Plan by electing to defer any amount of the employee's compensation on a pre-tax basis or as Roth deferrals, subject to the limits of the IRC. Eligible participants who have attained age 50 before the close of the plan year are eligible to make catch-up contributions, subject to limitations of the IRC. Participants may also contribute amounts representing rollover distributions from other qualified plans and certain other qualified sources as defined in the plan document.

Employees that meet eligibility requirements automatically begin deferring at 4% of their compensation, unless an affirmative election not to contribute or to contribute at a different percentage is made by the employee. The contributions are made on a pre-tax basis unless the employee affirmatively designates that any portion or all of the contributions be treated as Roth contributions.

The Company may elect to make discretionary employer matching contributions to participants with at least one year of service and who are employed on the last day of the plan year in an amount determined by the Company's board of directors. The service and employment requirements are waived if the participant is terminated due to retirement, death or disability. For the year ended December 31, 2024, the Company made discretionary employer matching contributions on behalf of each participant equal to 50% of the employee's elective deferral contribution, up to a maximum of 2% of compensation. Additionally, employer profit-sharing contributions may be made by the Company as determined by the Company's board of directors to participants with at least one year of service and who are employed on the last day of the plan year. No employer profit-sharing contributions were made in 2024.

**Participant Accounts**

Participants direct the investment of their accounts into various investment options offered by the Plan. Under the Plan, earnings and losses are allocated to the participants' accounts daily according to an allocation formula provided in the plan document.

**Vesting and Forfeitures**

Participants are immediately vested in their participant contributions plus actual earnings thereon. Vesting in Company contributions is based on years of service. A participant becomes 100% vested in the contributions made by the Company after three years of service. Regardless of the vesting schedule, participants also become fully vested upon attainment of normal retirement age, which is 59 ½, death, disability or termination of the Plan.

Forfeitures attributable to employer contributions are utilized to reduce future Company contributions or to pay plan expenses. Total unallocated forfeitures were \$45,043 and \$4,776 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, forfeitures of \$10,000 were used to pay plan expenses. During 2025, forfeitures of \$36,660 were used to offset the employer contribution for the 2024 plan year.

**Benefit Payments**

Distributions may be made to participants upon termination of employment, death, disability, or retirement. Under certain circumstances, participants may withdraw the value of their account while still employed for reasons of financial hardship, upon the attainment of age 59½ or by anyone requesting a distribution from their participant rollover account. Distributions from the Plan are paid in the form of a lump sum distribution. Upon withdrawal from the Plan or termination of employment, participants with an account balance of \$1,000 or less receive an automatic lump sum distribution from the Plan. For participants with an account balance greater than \$1,000 but less than \$7,000, the plan administrator makes a direct rollover into an individual retirement account. Withdrawals from the Plan may be subject to income tax on contributions and income earned.

**Note 2 - Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Investment Valuation and Income Recognition**

Investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation in the fair value of investments includes realized gains or losses on investments bought and sold during the year, as well as unrealized gains or losses on the investments held at the end of the year.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

**Benefit Payments**

Benefit payments are recorded when paid.

**Administrative Expenses**

Certain transactional charges are paid by the participants. All other administrative costs are paid by the Plan unless paid by the Company, at its discretion. Investment-related expenses are included in the net appreciation or depreciation in fair value of investments.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participants' account balances, and the amounts reported in the financial statements.

**Subsequent Events**

Management of the Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued. See Note 9.

**Note 3 - Information Certified by the Agent of the Plan's Asset Custodian**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Ascensus, LLC on behalf of Ascensus Trust Company as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and accompanying notes to the financial statements as to investments, dividends, investment income (loss), and all of the related information in the supplemental schedule of assets (held at end of year), is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information except for comparing such information to the information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule of assets (held at end of year).

**Note 4 - Fair Value Measurements**

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* These funds are valued daily based on their quoted market prices.

*Common/Collective Trust Fund:* This fund is valued at its net asset value (NAV) as determined by the issuer, based on quoted market prices of the underlying investments, less applicable fees charged by the issuer. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than the reported NAV.

**Note 5 - Federal Income Tax**

The Plan has adopted a pre-approved defined contribution plan offered by Ascensus, LLC. The pre-approved plan received an opinion letter from the IRS dated June 30, 2020, stating that the pre-approved plan was in compliance with the applicable requirements of the IRC. The pre-approved plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan, through its adoption of the pre-approved plan, is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, all participants become 100% vested.

**Note 7 - Party-in-Interest Transactions**

Certain mutual funds offered by the Plan are issued by VGI, a party-in-interest with respect to the Plan. Transactions involving these mutual funds are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.

**Note 8 - Nonexempt Party-in-Interest Transactions**

As disclosed in the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, there were unintentional delays in remitting \$19,734 of participant contributions relating to the 2023 plan year, within the timeframe specified by the DOL's Regulation CFR 2510.3-102. The contributions, including lost earnings, were corrected during 2024. During the 2024 plan year, there were unintentional delays in remitting \$207 of participant contributions. The plan administrator is in the process of correcting these delinquent contributions during 2025.

**Note 9 - Subsequent Events**

Subsequent to year end, the Plan was amended to reflect the following changes: (i) addition of auto-escalation by 1% each year up to a maximum of 10%, (ii) default for auto-enrollment from pre-tax deferrals to Roth deferrals, and (iii) account balances under \$1,000 subject to involuntary cash-out will now be distributed via direct rollover to an IRA, rather than as a lump sum payment.
