1. PLAN DESCRIPTION

The following brief description of the RAM Partners, LLC (the “Company”) Retirement Savings Plan (the “Plan”) is provided for general informational purposes only. Participants should refer to the Plan document, copies of which are available from the Plan Administrator, for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan covering all the employees of the Company who have completed 30 days of service and are 18 years of age or older. An employee may elect to participate in the Plan at the earliest 1st of the month upon meeting eligibility requirements.

The Plan incorporates an auto-enrollment feature for newly eligible employees, automatically enrolling them unless they opt out. For those automatically enrolled, the initial deferral rate is 3% of eligible compensation, with contributions invested in a specified balanced fund until altered by the participant. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan’s management determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

B. Contributions

Eligible employees may make pre-tax and ROTH contributions for a minimum of 1% up to 100% of eligible compensation as defined by the Plan but shall not exceed the maximum allowable deferral under Section 401 of the Internal Revenue Code (the “Code”) for any plan year. Participants who have attained age 50 before the end of a year may elect to defer additional amounts (called “catch-up contributions”) to the Plan up to the maximum allowable amount. Participants may change their deferral election percentage online on any business day and may be discontinued any time. Employees may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”).

The Plan provides for a non-discretionary employer matching contribution of 50% of a participant’s contribution up to 6% of eligible compensation. Employer matching contributions are calculated and remitted with each payroll cycle. For 2024, the Company made \$1,179,617 in non-discretionary matching contributions.

In addition, the Plan provides for a discretionary profit-sharing contribution based on a prescribed methodology. In 2024, the Company made profit-sharing contributions of \$0.

C. Participant Accounts

Each participant's account is credited with the participant's deferral contributions, rollovers, the Company's matching contributions and a proportionate interest in the earnings or losses on investments in their account and is charged with transaction fees related to loans and hardship withdrawals received by that participant and an allocation of administrative expenses either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense itself.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and collective investment trust as investment options for participants. Participants may change their investment options online whenever deemed necessary. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are vested immediately in their contributions (elective deferrals and/or rollovers) plus actual earnings thereon. All Company contributions and earnings thereon become 100% vested upon normal retirement (age 65), early retirement upon meeting certain requirements, permanent disability, or death of a participant. Otherwise, vesting in Company contributions and earnings thereon is based on years of continuous service (including service with certain predecessor employers) and vest as follows:

E. Notes Receivable From Participants

Participants may borrow from their account up to a maximum of the lesser of a) 50% of the participant's vested account, reduced by any outstanding loan balance, or b) \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. Participants may have a maximum of one loan outstanding and may have a maximum of one loan approved in a 12-month period. The maximum term of any loan is five years unless the loan is for the purpose of purchasing a primary residence. The loans are secured by the balance in the participant's account and bear interest rates ranging from 4.25% to 9.50% per annum, which are commensurate with local prevailing rates as determined by the Plan Administrator. The interest rate will be fixed for the duration of the loan. Principal and interest is paid ratably through bi-weekly payroll deductions.

F. Payment of Benefits and Withdrawals

On termination of service due to normal retirement, permanent disability or death, the participant or their designated beneficiary will receive payment of the participant's entire share of accumulated vested benefits of the Plan in a lump-sum distribution subject to the joint and survivor annuity requirements. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as described above or defer payment until retirement age. If the participant's account balance is \$5,000 or less, benefits will be paid out and without the option to defer payment until retirement age. The participant's contributions may also be withdrawn for certain hardship situations.

G. Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$222,617 and \$363,283 respectively. Any forfeitures occurring during a Plan Year may be used to pay administrative expenses under the Plan at any time, if so directed by the Administrator. Any forfeitures not used to pay administrative expenses may be used to reduce Employer matching contributions. In 2024, plan expenses were reduced by \$0 and employer matching contributions were reduced by \$340,250 from forfeited non-vested accounts.

H. Investment Options

Participants direct the investment of their account balances to various separate accounts sponsored by Fidelity Management Trust Company ("Fidelity"). Participants may change their investment options online any business day and change or discontinue their deferral percentages online any business day. Any modification becomes effective as soon as administratively feasible after it is received by the Administrator.

I. Plan Administration

The Company is the administrator for the Plan. Fidelity is the Plan's trustee and Fidelity Workplace Services, LLC ("FWS") provides third party administration and recordkeeping services to the Plan.

J. Plan Adoption and Amendments

The Plan was originally effective on January 1, 2002 and was restated in October 2021 to using Fidelity's Pre-approved Profit Sharing Plan.

J. Plan Adoption and Amendments (continued)

The Plan implemented certain requirements by the Coronavirus Aid, Relief, and Economic Security Act (the CARES Act) and the Setting Every Community Up for Retirement Enhancement Act of 2019 (the SECURE Act), which laws change the Plan to, among others, allow the Plan's participants to take a COVID-19 related distribution up to \$100,000 beginning on or after January 1, 2020 and before December 31, 2020 and certain eligible individuals may receive coronavirus-related relief for loan repayment, suspend required minimum distributions, and delay the commencement date for required minimum distributions. On September 11, 2023, the Plan sponsors approved a Plan amendment to change the eligibility service requirement to 1 month, the entry date to the first day of each month and to include an automatic enrollment feature. Such amendment was effective as of January 1, 2024. On August 13, 2024, the Plan sponsors approved a Plan amendment to change the vesting schedule and the eligibility age to 18. Such amendment was effective as of September 6, 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

B. Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

E. Payment of Benefits

Benefits are recorded when paid.

F. Excess Contributions Payable

Amounts payable to participants totaling \$160,725 and \$73,851 for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions for the years ended December 31, 2024 and 2023 respectively. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

G. Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants or distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

H. Date of Management's Review of Subsequent Events

The Plan has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued and no other events were identified.

3. CERTIFIED INFORMATION AND FAIR VALUE MEASUREMENTS

As explained in Note 1.I., the Plan’s assets are maintained by the trustee, Fidelity. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity. The Plan Administrator has instructed the independent auditors not to audit the information certified as complete and accurate by the trustee.

The framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable input and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trust: Valued at fair value reported by the trust company expressed in units representing the net asset value of each fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity as the trustee and FWS as the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Contract administrator and investment advisor fees paid directly by the Plan for the investment management services totaled \$104,402 for the year ended December 31, 2024. Additional Fees paid to the trustee are netted against investment returns.

As described in note 2.G., the Plan Sponsor pays directly for any fees related directly to the Plan's operations that are not related to the administration of notes receivable from participants or distributions to participants.

The above party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would be fully vested in their employer contributions.

6. TAX STATUS

The Plan participates in a Pre-approved Profit Sharing Plan. The Internal Revenue Service (“IRS”) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed and in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the favorable opinion letter, the Plan Administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan investment in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
