### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of ProHealth Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 - Plan Description

The following description of ProHealth Retirement Savings Plan (the "Plan") provides only general information regarding the Plan. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of ProHealth Care, Inc. (the "Sponsor") and ProHealth Aligned, LLC (ProHealth Aligned). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for pretax and after-tax employee salary contributions up to a maximum of 75 percent of the employee's annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for automatic enrollment for all eligible employees at a deferral rate of 2 percent of their compensation unless the employee enrolls in the Plan at a different rate or affirmatively elects not to participate in the Plan.

Prior to July 1, 2016, the Plan provided for an employer matching contribution, which was calculated using one of two matching formulas. Employees hired before November 1, 2004 who elected to continue their benefit accruals in the ProHealth Care, Inc. Pension Plan (an additional plan offered by the Sponsor) received a matching contribution of up to 50 percent of their contributions, not to exceed 4 percent of compensation.

Employees hired before November 1, 2004 who elected to freeze their benefit accruals in the ProHealth Care, Inc. Pension Plan or who did not participate in the ProHealth Care, Inc. Pension Plan and employees hired on or after November 1, 2004 received a matching contribution of up to 50 percent of their contributions, not to exceed 10 percent of compensation. Participants should refer to the plan document for a more complete description of the Plan's matching provisions.

Effective July 1, 2016, all participants, other than ProHealth Aligned employees, are eligible to receive a matching contribution of up to 50 percent of their contributions, not to exceed 10 percent of compensation.

The Plan also provides for a discretionary employer contribution for ProHealth Aligned employees. These employees can receive an employer contribution of 3 percent of eligible compensation. The Plan made no discretionary employer contributions to the Plan in 2024 and 2023.

Effective April 1, 2021, the Plan added National Regency of New Berlin, Inc., DBA Regency Senior Communities as a participating employer. These employees are not eligible for automatic enrollment. All eligible employees of National Regency of New Berlin, Inc. received a matching contribution of up to 50 percent of their contributions, not to exceed 6 percent of compensation. Effective January 1, 2025, employees of National Regency of New Berlin, Inc. will cease to participate, and any such participants shall be 100 percent vested in such participants' accounts.

#### **Eligibility**

Employees who have attained the age of 18 are eligible to participate in the Plan as of the first pay period coinciding with or immediately following their employment commencement date with the Sponsor. Employees who have elected to make employee deferrals in the Plan are eligible for matching contributions.

### Note 1 - Plan Description (Continued)

Employees are eligible for the ProHealth Aligned employer contribution if classified as a full-time equivalent of 0.5 or higher effective as of the first pay period coinciding with or immediately following their employment commencement date and attainment of age 18.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Sponsor's contributions, and allocations of investment earnings and losses and charged with administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

#### ***Vesting***

Participants are immediately 100 percent vested in their salary and rollover contributions and any income or loss thereon. Vesting in the Sponsor's contribution portion, plus actual earnings thereon, is based on years of service. Participants become fully vested in contributions made by the Sponsor after three years of service. Effective January 1, 2024 via an amendment to the Plan, certain participants became 100 percent vested regardless of years of service.

#### ***Payment of Benefits***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account or installment payments. A participant who has attained age 59½ or is experiencing a financial hardship may request a withdrawal of a portion of his or her vested balance.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to pay administrative expenses of the Plan. Any remaining forfeitures are used to reduce future sponsor contributions. At December 31, 2024 and 2023, forfeited account balances totaled approximately \$262,000 and \$169,000, respectively. The Plan used approximately \$358,000 and \$402,000 to reduce sponsor contributions for the years ended December 31, 2024 and 2023, respectively.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by State Street Bank and Trust Company or its affiliates. State Street Bank and Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value.

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on this investment. The interest-bearing cash is valued at fair value based on its outstanding balance. Additionally, the Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in mutual funds and a money market fund, which are valued at quoted market prices. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Sponsor.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 22, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

State Street Bank and Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
