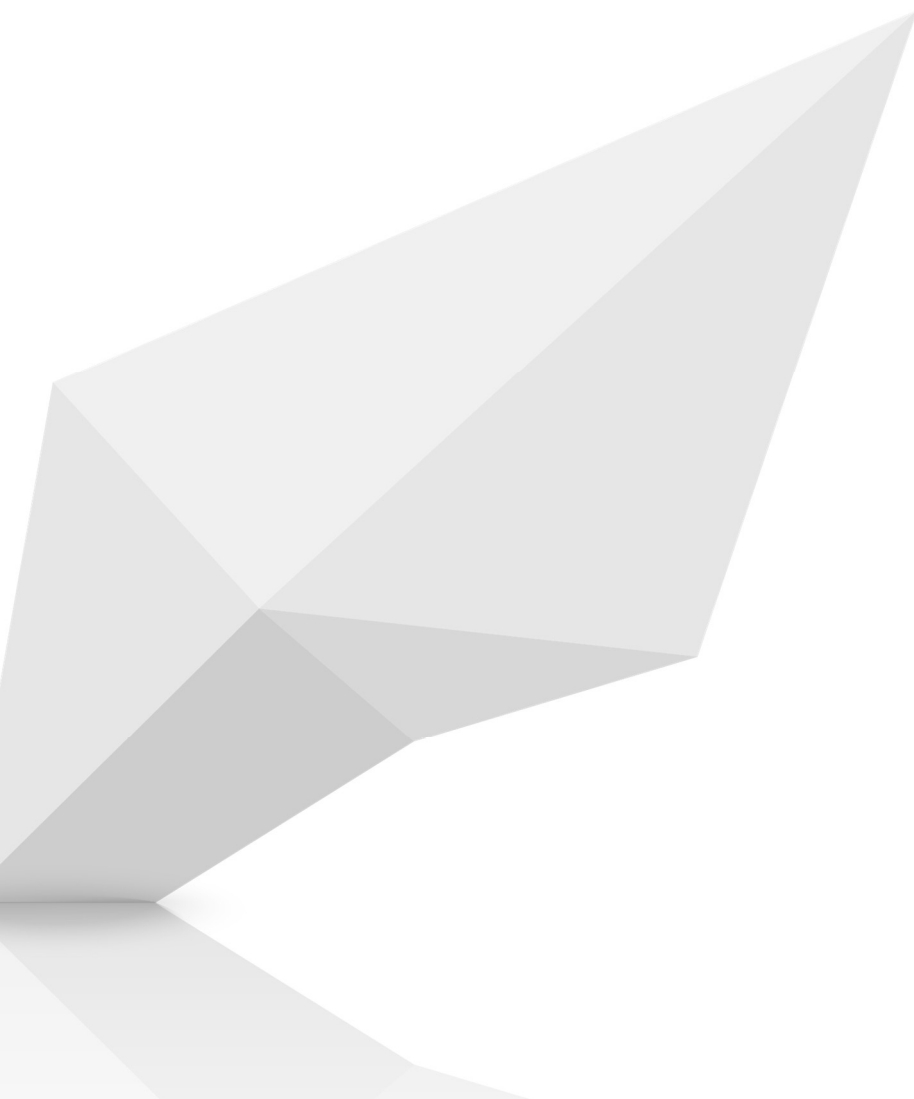

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Almirall LLC 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Almirall LLC 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Note 1: Description of Plan

The following description of the Almirall LLC 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-union employees who are not nonresident aliens of Almirall LLC (the "Company") who have attained 21 years of age and have completed three months of service. Upon satisfying the eligibility requirements, an employee is eligible to participate immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year participants may contribute a minimum of 1% up to 96% of pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also allows for Roth contributions. Catch-up contributions are matched while rollovers are not. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has an automatic enrollment feature. Participants subject to automatic enrollment have 6% of their annual eligible compensation deferred into the Plan on a pre-tax basis upon meeting the eligibility requirements. Such contributions are invested in a designated balance fund until changed by the participant.

The Company makes a matching contribution in the amount equal to 100% of the first 4% of base compensation that a participant contributes to the Plan on a bi-weekly basis. During the year ended December 31, 2024, the Company made matching contributions of \$491,028.

The Company may make a discretionary profit sharing contribution on behalf of eligible participants each plan year, as defined in the plan document. The Company did not declare an additional profit sharing contribution for 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, Company's discretionary profit sharing contribution, and plan earnings (losses) thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully and immediately vested in all contributions, plus actual earnings thereon.

Payment of Benefits

On termination of service due to death, disability, voluntary termination or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum, partial withdrawal, installments, or annuities if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000 but is greater than \$1,000, the plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement plan. Vested balances less than \$1,000 can be distributed only in a single lump-sum payment. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½.

Forfeitures

Forfeitures are used to reduce future Company contributions or pay administrative expenses of the Plan in accordance with the plan document. Forfeited nonvested accounts were \$0 at December 31, 2024 and 2023. During 2024, there were no forfeitures used to reduce Company contributions or to pay administrative expenses of the Plan.

Notes Receivable From Participants

Participants may borrow from their accounts a maximum of one loan with a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 95% of 50% of their account balance. Loan terms shall not exceed 54 months except for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in *The Wall Street Journal*, plus 1%. Interest rates on existing loans range from 5.75% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States. Under this basis, investment income and contributions are recorded when received, and plan expenses are recorded when paid, rather than recording such items on an accrual basis.

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded when cash is disbursed or received. Dividends are recorded when cash is received. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances. Interest income is recognized as remitted to the Plan. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common/collective trust fund - Reliance Trust Company Stable Value Fund: Valued at fair value by determining the Plan's pro rata portion of the market value of the securities in the underlying separate accounts.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company (MATC), the Trustee of the Plan.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Global Retirement Partners provide investment advisory services to the Plan and, therefore these transactions qualify as party-in-interest transactions. Direct fees incurred and paid by the Plan for investment advisory services were \$52,503 for the year ended December 31, 2024, which are included in net investment income.

Paychex, Inc. ("Paychex") is the third-party administrator, as defined by the Plan, and therefore transactions with Paychex also qualify as party-in-interest transactions. Administrative expenses totaling \$1,459 were paid to Paychex for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Tax Status

The Plan adopted a nonstandard prototype document with an IRS notification letter, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8: Risks and Uncertainties and Concentration of Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

Note 1: Description of Plan

The following description of the Almirall LLC 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all non-union employees who are not nonresident aliens of Almirall LLC (the "Company") who have attained 21 years of age and have completed three months of service. Upon satisfying the eligibility requirements, an employee is eligible to participate immediately. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year participants may contribute a minimum of 1% up to 96% of pretax annual compensation, as defined in the Plan, subject to certain Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan also allows for Roth contributions. Catch-up contributions are matched while rollovers are not. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has an automatic enrollment feature. Participants subject to automatic enrollment have 6% of their annual eligible compensation deferred into the Plan on a pre-tax basis upon meeting the eligibility requirements. Such contributions are invested in a designated balance fund until changed by the participant.

The Company makes a matching contribution in the amount equal to 100% of the first 4% of base compensation that a participant contributes to the Plan on a bi-weekly basis. During the year ended December 31, 2024, the Company made matching contributions of \$491,028.

The Company may make a discretionary profit sharing contribution on behalf of eligible participants each plan year, as defined in the plan document. The Company did not declare an additional profit sharing contribution for 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contribution, Company's discretionary profit sharing contribution, and plan earnings (losses) thereon. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are fully and immediately vested in all contributions, plus actual earnings thereon.

Payment of Benefits

On termination of service due to death, disability, voluntary termination or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum, partial withdrawal, installments, or annuities if the account balance is greater than \$5,000. If the participant's vested account balance does not exceed \$5,000 but is greater than \$1,000, the plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement plan. Vested balances less than \$1,000 can be distributed only in a single lump-sum payment. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 ½.

Forfeitures

Forfeitures are used to reduce future Company contributions or pay administrative expenses of the Plan in accordance with the plan document. Forfeited nonvested accounts were \$0 at December 31, 2024 and 2023. During 2024, there were no forfeitures used to reduce Company contributions or to pay administrative expenses of the Plan.

Notes Receivable From Participants

Participants may borrow from their accounts a maximum of one loan with a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 95% of 50% of their account balance. Loan terms shall not exceed 54 months except for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate as published in *The Wall Street Journal*, plus 1%. Interest rates on existing loans range from 5.75% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States. Under this basis, investment income and contributions are recorded when received, and plan expenses are recorded when paid, rather than recording such items on an accrual basis.

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded when cash is disbursed or received. Dividends are recorded when cash is received. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balances. Interest income is recognized as remitted to the Plan. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Common/collective trust fund - Reliance Trust Company Stable Value Fund: Valued at fair value by determining the Plan's pro rata portion of the market value of the securities in the underlying separate accounts.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company (MATC), the Trustee of the Plan.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Global Retirement Partners provide investment advisory services to the Plan and, therefore these transactions qualify as party-in-interest transactions. Direct fees incurred and paid by the Plan for investment advisory services were \$52,503 for the year ended December 31, 2024, which are included in net investment income.

Paychex, Inc. ("Paychex") is the third-party administrator, as defined by the Plan, and therefore transactions with Paychex also qualify as party-in-interest transactions. Administrative expenses totaling \$1,459 were paid to Paychex for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Tax Status

The Plan adopted a nonstandard prototype document with an IRS notification letter, which states the prototype plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8: Risks and Uncertainties and Concentration of Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).
