Note 1 – Description of Plan

The following description of the Brewer Carpet & Design Center 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on September 1, 2002, and restated effective January 1, 2017, covering all employees of Brewer Carpet and Design Center or any affiliate who has adopted the plan (the “Companies”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Employees are eligible to participate in the Plan after completing three months of service and attaining the age of 21.

Participant Contributions

Participants may elect to contribute up to 100% of their compensation to the Plan subject to the annual limitations imposed by the Internal Revenue Service. Plan participants age 50 and older were eligible to make a catch-up contribution of an additional \$7,500 to the Plan during the years ended December 31, 2024 and 2023. The participants eligible to make the catch-up contributions may do so only after making the total elective deferral contributions allowed by the Internal Revenue Service. Rollover contributions are permitted under the Plan agreement.

Employer Contributions

The Company matches contributions on pre-tax elective deferrals equal to 100% of a participant’s salary reduction up to 3% of the participant’s compensation plus 50% of salary deferrals on the next 3%. The maximum matching contribution would be 4.5%. In addition, the Company may make a discretionary profit sharing contribution which is determined annually by management. A participant must complete a year of service and be actively employed at the end of the year to share in the allocation of the profit sharing contribution. Plan sponsor did not make a profit sharing contribution for the years ended December 31, 2024 and 2023.

Participant's Accounts

Each participant's account is credited with the participant's contributions, the Companies' contributions, if any, and the income and appreciation or depreciation of the investments attributable to each type of investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and rollover accounts plus actual earnings and losses thereon.

Participants become 100% vested regardless of years of service upon death, disability, the age of 65, or termination of the Plan.

Payment of Benefits

Upon termination of service, a participant with a vested balance under \$5,000 will receive a mandatory lump-sum distribution. If the vested balance exceeds \$5,000, spousal consent is required to obtain a lump sum payment. Participants are entitled to apply their vested portion toward the purchase of an annuity contract. Upon death, disability or retirement, or other reasons, distributions will be made pursuant to the election of the Participant or the Beneficiary.

Forfeitures

Matching contributions that are forfeited because of termination prior to vesting are used to reduce future employer contributions or pay Plan expenses. Forfeitures utilized to offset contributions or pay Plan expenses were approximately \$14,717 and \$19,861 during 2024 and 2023, respectively. As of December 31, 2024 and 2023, \$19 and \$4,381, respectively, were available to reduce administrative fees or future employer contributions.

### Notes Receivable from Participants

Participants, under certain circumstances, are permitted to borrow a minimum of \$1,000 from their participant accounts. Subject to certain Internal Revenue Code and Plan limits, a participant may not borrow more than the lesser of 50% of his or her vested interest in the Plan, or \$50,000, adjusted for prior loans. The participant may only have one outstanding loan at any one time. The interest rate charged for a loan will be the prime rate as published by the Wall Street Journal on the 14<sup>th</sup> day each month plus 1%.

### Note 2 – Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) included the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable may be reclassified as distributions based upon the terms of the Plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Essentially all of the administrative expenses of the Plan were paid by the Plan participants and forfeiture accounts in 2024 and 2023.

#### Date of Management's Review

Management has evaluated subsequent events through the date of these financial statements.

#### Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair

value of its investments. No Level 2 or 3 inputs were available at year end to the Plan for the year ended December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

- Mutual funds fair values are available based on quoted market prices, when available. The fair values of common stocks, corporate bonds, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are in net appreciation (depreciation) in fair value of investments.

Note 4 – Information Certified by a Qualified Institution

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends income, and interest on income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by the trustee, Charles Schwab Trust Bank.

Note 5 – Transactions with Parties-In-Interest

The Company provides administrative services at no cost to the Plan. Certain Plan investments are shares of pooled separate funds managed by the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Note 6 – Income Tax Status

The Internal Revenue Service has determined and informed the Company in a letter dated March 31, 2014, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe the Plan is currently being operated in compliance with the applicable requirements of the IRC. The Plans' tax returns are generally subject to examination by the Internal Revenue Service for a period of three years from the date they are to be filed.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has taken the position that Plan years ending before December 31, 2013 are not required to have an audit.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8 – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
