Opinion

We have audited the accompanying financial statements of Teck American, Incorporated Health and Welfare Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (cash basis) as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits (cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits (cash basis) of Teck American, Incorporated Health and Welfare Benefit Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits (cash basis) for the years then ended, in accordance with the cash basis of accounting described in Note B.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted (GAAS) in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Teck American, Incorporated Health and Welfare Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule were prepared on the cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. Our opinion is not modified with respect to that matter.

Responsibilities of Management's for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the cash basis of accounting described in Note B. This includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatements, whether due to error or fraud.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Teck American, Incorporated Health and Welfare Benefit Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibility for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS (CASH BASIS)
Years Ended December 31, 2024 and 2023

A. Plan Description:

The following description of the Teck American, Incorporated Health and Welfare Benefit Plan (The Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General:

The Plan provides health, dental & vision benefits to substantially all qualified employees of Teck American, Inc. (the Company/Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits:

The Plan provides health (major and other medical) dental and vision benefits covering, permanent, full-time, employees and qualifying dependents of Teck American, Incorporated, and certain qualifying retirees. Terminated employees and their qualifying dependents may elect to receive health benefits through Consolidated Omnibus Budget Reconciliation Act (COBRA); the cost of those benefits is funded by the allowed premiums charged to those Plan participants making those elections.

Stop Loss Coverage:

The Plan is insured through a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The policy holder of the insurance agreement is Teck American Incorporated, Captive, all related premium payments and stop-loss recoveries are reflected in the Plan's financial statements.

Self-insured Benefits:

All other Plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the general assets of the Plan's Sponsor. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan utilizes a pharmacy benefit manager (PBM) which periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs.

A. Plan Description, continued:

Contributions:

The Plan agreement provides that employees and the Company make monthly contributions to the Plan of a determined amount to provide benefits for employees. The contribution rate is determined by the Plan's Management with recommendations from the Plan consultant. The Company makes contributions to the Plan as needed to fund claims in excess of contributions made by the covered employees. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Termination of the Plan:

Although they have not expressed any intention to do so, the Plan Sponsors have the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Plan Sponsors or be used for purposes other than for the exclusive benefit of the Plan's participants.

B. Summary of Significant Accounting Policies:

Estimates:

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, disclosure of benefit obligations and IBNR. Actual results could differ from those estimates.

Payment of Benefits:

Premiums paid by the Plan are recorded as premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claim's processor.

Basis of Accounting:

The Plan's financial statements have been prepared on the cash basis of accounting; consequently, certain revenues are recognized when received rather than when earned, and certain expenses are recognized when cash is disbursed rather than when the obligation is incurred.

Because the financial statements are prepared on a cash basis, liabilities or plan obligations have not been recognized in the financial statements (See Note F for description of benefit obligations).

B. Summary of Significant Accounting Policies, continued:

Estimated Incurred Claims Not Yet Reported (IBNR)

Plan obligations on December 31 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment.

Assets Valuation, Concentration of Credit Risk and Cash Equivalents

Assets of the Plan are valued at current value as of the date of the financial statements. All cash and cash equivalents are on deposit with Bank of America. Cash equivalents consist of a customary business checking account.

Subsequent Events

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

Stop Loss

Premiums for stop loss insurance are included in premium payments in the accompanying statements of changes in net assets available for benefits. Stop loss refunds totaling \$526,724 and \$141,043 have been recorded as other additions in the accompanying statement of changes in net assets for the years ended December 31, 2024 and 2023, respectively.

Refunds

Refunds due from the Plan's PBM are recorded when paid. Pharmacy rebates totaling \$597,352 and \$496,554 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

C. **Income Tax Status:**

The Plan was established under the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Accordingly, it is the belief of the Plan administrator that the Plan is exempt from state and federal income taxation. The Internal Revenue Service does not provide determination letters for health and welfare plans such as the Teck American, Inc. Health and Welfare Benefit Plan. The plan Sponsor believes that the Plan, as amended, continues to qualify and to operate as designed and as such is not subject state and federal income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

D. **Plan Amendments:**

The Plan was restated and amended effective January 1, 2024, primarily to change some of the Schedule of Benefits and network provider information.

The plan was amended effective March 1, 2024 to add a new dental plan for employees who reside, and access dental services in a foreign country but work in the United States at a Teck American property.

E. **Reconciliation of Financial Statements to Form 5500:**

There were no reconciling items between the financial statements and the amounts reflected in form 5500 as of December 31, 2024 and 2023.

F. **Postretirement and Postemployment Benefit Obligations:**

The postretirement health benefit obligation represents the actuarial present value of those estimated future health benefits that are attributed to employee service rendered to December 31, 2024. Postretirement benefits include future health benefits expected to be paid to or for certain qualified retirees of the plan sponsor and active employees and their beneficiaries and dependents after retirement from service with the plan sponsor. Prior to an active employee's full eligibility date, the postretirement health benefit obligation is the portion of the expected postretirement health benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement health benefit obligation is determined by an independent actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (though discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal and retirement) between the valuation date and the expected date of payment.

F. Postretirement and Postemployment Benefit Obligations, continued:

The trend rate for 2023 and 2024 is 6.25% and 6.50%, respectively. The trend rate will be reduced by .25% each year, reaching 5.0% in 2031 and thereafter.

If the assumed rate of increase costs for the health benefit obligation increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023 by \$3,818,447 and \$4,417,195 respectively. Deficiencies, if any, in net assets over benefit obligations will be funded by the company as the benefits are paid to participants.

Effective in 2014, Teck American went to a fully insured product for post-65 prescription drug coverage. Since the insurer keeps the Medicare subsidy, and adjusts premiums accordingly, a specific assumption set for Medicare Part D benefits is no longer required.

The actuarial present value of the expected postemployment plan benefit obligation is determined by an independent actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (though discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal and retirement) between the valuation date and the expected date of payment.

The actuarially calculated postemployment plan benefit obligation at December 31, 2024 and 2023, is estimated to be \$777,284 and \$624,163.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the disclosed obligations.

G. Administrative expenses:

The plan uses the services of a contract administrator to maintain certain accounting records of the Plan and to administer the processing and payment of claims and other operating expenses. The expense of this service is based on a monthly fee per employee. The monthly contributions to the plan are used to cover the cost of the Plan administration.
