### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of 403(b) Thrift Plan of Marcus Jewish Community Center of Atlanta, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

### ***Basis for Opinion***

### 1. Description of the Plan

The following description of the 403(b) Thrift Plan of Marcus Jewish Community Center of Atlanta, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan under Section 403(b) of the Internal Revenue Code (IRC) and covers substantially all employees of Marcus Jewish Community Center of Atlanta, Inc. (the Organization or Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Eligibility*

Employees of the Organization are considered eligible for participation, except for nonresident aliens with no U.S. source of income. There is no age or service requirement for employee contributions. An eligible participant can enter the Plan immediately upon meeting the eligibility requirements. Participants must be 21 years old and have one year of service to be eligible for Employer matching contributions.

#### *Trustee and Administration of the Plan*

The trustee of the Plan is Teachers Insurance and Annuity Association of America (TIAA) and College Retirement Equities Fund (CREF) (collectively, the Trustee). The administrator of the Plan is the Organization. The Trustee holds the assets of the Plan in accordance with the service provider contract with the Organization. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Contributions*

Each year, participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan. In addition, the Plan provides for Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan document provides for a matching contribution that is equal to 50% of participant contributions up to 5% of eligible compensation. During the 2024 Plan year, Employer matching contributions of \$108,058 were contributed to the Plan. The Plan accepts eligible rollover contributions from qualified plans on behalf of the participant.

Participants may direct the investment of their contributions into various investment options offered by the Plan as provided by TIAA. Certain participants still have balances with Mutual of America, the former recordkeeper of the Plan. Participants may no longer direct contributions into Mutual of America funds.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions; the Organization's contributions, if any; and an allocation of Plan earnings thereon, as well as charges by Mutual of America and TIAA for an allocation of administrative expenses. Allocations are based on participant

earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of participants' accounts is based on years of continuous service. Participants are fully vested after two years of credited service for all Employer contributions as defined in the Plan.

### ***Notes Receivable from Participants***

Participants may borrow from their TIAA fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loans are repaid over a period of five years or less, unless used to purchase a principal residence. The loan interest rate is set at 1% above the prime rate, as defined by the Plan. Principal and interest are paid ratably through payroll deductions.

### ***Payment of Benefits***

On termination of service due to death, disability, retirement, or separation from service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or other specified payment options as provided in the Plan. Withdrawals from the Plan may also be made upon attaining age 59½ and upon circumstances of financial hardship in accordance with provisions specified in the Plan document. All vested balances less than \$1,000 may be automatically distributed after termination of employment. Effective for distributions subsequent to October 1, 2023, vested balances \$5,000 or less will be distributed automatically.

### ***Forfeited Accounts***

Forfeitures by non-vested participants are used to reduce future Employer contributions.

During the 2024 Plan year, forfeitures of \$12,985 were used to reduce Employer contributions to the Plan. Forfeiture balances available to offset Employer contributions were \$60 and \$873 at December 31, 2024 and 2023, respectively.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Administrative expenses include certain annual participant fees and investment consulting fees. Fees related to the administration of notes receivable from participants and for loan withdrawals are directly paid by the participants and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### ***Revenue Credits***

The Plan's trust agreement with TIAA provides for a participant revenue credit arrangement, whereby the Trustee allocates quarterly deposits into the accounts of eligible participants who are

invested in certain funds. There were no unallocated revenue credits at December 31, 2024 and 2023. During 2024, the Plan received no credits. Administrative expenses are presented net of revenue credits in the statement of changes in net assets available for benefits.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual method of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contracts, which are reported at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### *Contributions*

Participant contributions and any related matching contributions are recognized in the period during which the Organization makes the respective payroll deduction from the participant's compensation.

#### *Payment of Benefits*

Benefits are recorded when paid.

### 3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Account* - The pooled separate account is divided into distinct subaccounts that are referred to as separate accounts. The pooled separate account operates similarly to a mutual fund at the investment level and is invested in assets that match the investment objectives of the separate accounts. The Plan's interest in the pooled separate account is evidenced by units of account. The unit value of the pooled separate account is based on the NAVs, which are calculated by using quoted market prices of the underlying investments and adjusted for certain separate account charges. The fair values of the pooled separate account have been calculated using the NAV per share of the underlying investments. The NAV, as provided by Mutual of America, is used as a practical expedient to estimate fair value. The NAV would not be used if it were probable that the investment would not be traded at NAV.

- (a) *Equity Funds* - These funds invest in a diversified portfolio of primarily common stocks with a broad exposure to the market. The portfolios may invest in companies with smaller or larger market capitalizations, investing in domestic and foreign issuers. The investment objective is to provide long-term capital appreciation. The Mid Cap Equity Index Fund and the Equity Index Fund seek investment results that correspond to the investment performance of the S&P Mid Cap 400 Index and the S&P 500 Composite Stock Price Index, respectively.
- (b) *Fixed-Income Funds* - The Money Market Fund seeks current income to the extent consistent with the maintenance of liquidity, investment quality, and stability of capital. The fund invests in U.S. Treasury bills and commercial paper. The Intermediate Bond Fund seeks current income with a secondary objective of preservation of capital. The fund invests primarily in investment-grade, publicly traded debt securities, such as U.S. Treasury bonds and investment-grade corporate bonds.
- (c) *Balanced Funds* - The funds in this category seek to achieve capital appreciation and current income, competitive total return, or high total return with reduced risk over the long-term by investing in a diversified portfolio of common stocks, debt securities, and short-term instruments.
- (d) *Asset Allocation Fund* - The Moderate Allocation Fund seeks capital appreciation and current income. It invests in both fixed-income funds and equity funds of the investment company. The Aggressive Allocation Fund seeks capital appreciation and, to a lesser extent, current income. It invests primarily in equity funds of the investment company and also invests in fixed-income funds of the investment company.
- (e) *Retirement Target Funds* - These funds invest primarily in equity funds and fixed-income funds. Each fund seeks current income and capital appreciation appropriate for asset allocation associated with the fund's approximate year of retirement, which is included in the fund's name. The funds invest in proportions that are balanced to meet the current target of the funds, which will move toward preservation of capital and production of income as the target retirement date approaches. The target of the funds changes over time, so the mix of fixed-income funds and equity funds changes to reflect the periodic modifications in the fund's target.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 4. Investment Contracts

### *TIAA Stable Value Contract*

The TIAA Stable Value Contract is a fixed rate group annuity contract issued by TIAA. Contributions are deposited into a non-unitized separate account of TIAA and buy a contractual or guaranteed amount of future benefits for the participants. Allocations to the TIAA Stable Value annuity are backed by the value of the assets in the separate account and, if insufficient, by TIAA's claims-paying ability. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract provides a guaranteed minimum rate of interest of between 1% and 3%. Although the liability to provide contract guarantees and accumulations is backed by the assets in the separate account, any amount to be credited above the minimum guaranteed rate is determined by TIAA. There are no reserves against the contract value for credit risk of the contract issue as of December 31, 2024 and 2023.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value, as reported to the Plan by TIAA, represents accumulated cash contributions, interest credited, and transfers, if any, less any withdrawals and transfers, if any. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are, however, "equity wash" provisions that prevent the immediate transfer of amounts to any competing funds available in the Plan for a 90-day period. If the Plan sponsor chooses to terminate the Plan's investment in the contract, the Plan will receive contract value in a period not to exceed two years. If the two-year payout applies, a discontinuance fee will be assessed, which has the effect of reducing the interest credited during the two-year period by a maximum of 75 basis points.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### ***Deposit Administration Contract***

The Plan has a fully benefit-responsive guaranteed interest account with Mutual of America. Mutual of America maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investments contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The investment contract is fully benefit-responsive and is reported at contract value in the statements of the net assets available for benefits. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The crediting interest rate is based on a formula agreed upon with the issuer but can never be less than 1%. The crediting rate is reset quarterly.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Organization or other Organization events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

## **5. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income, dividend income, and interest income on notes receivable from participants for the year ended

December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, qualified institutions.

Investments totaling \$145,037 as of December 31, 2024 and related interest income of \$1,580 and net appreciation in fair value of investments of \$9,713 for the year ended December 31, 2024 were held by Mutual of America and are not certified.

### 6. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by Mutual of America and TIAA. Mutual of America and TIAA are the recordkeepers of the Plan and, therefore, these transactions qualify as party-in-interest. Notes receivable from participants also qualify as exempt party-in-interest transactions. As described in Note 1, the Plan paid certain expenses related to Plan operations and investment activity to service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### 8. Tax Status

The Plan uses a 403(b) volume submitter plan document sponsored by TIAA. TIAA received an opinion letter from the Internal Revenue Service (IRS), dated August 7, 2017, stating that the 403(b) volume submitter plan document satisfies the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 10. Subsequent Events

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.
