## Notes to Financial Statements

---

### Note 1: Description of Plan

The following description of the Heartland Produce Co. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan, as most recently amended and restated effective January 1, 2022, is a defined contribution plan covering substantially all employees of Heartland Produce Co. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

Employees of the Company are eligible to participate in the Plan after having attained 21 years of age and completing one year of service, provided the employee is not a union employee or a nonresident alien, as defined by the Plan. Employees may enter the Plan on the next January 1 or July 1 following their fulfillment of the eligibility requirements.

#### Contributions

Each year, participants may contribute a portion of their eligible compensation, as defined by the Plan, as either pre-tax or after-tax Roth deferral contributions not to exceed the maximum allowable by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan provides for the Company to make an annual safe harbor matching contribution equal to 100% of the participant's deferrals up to 3% of eligible compensation, plus 50% of the participant's deferrals from 3% to 5% of eligible compensation. The safe harbor contribution was \$262,508 for the year ended December 31, 2024.

In addition, the Plan provides for the Company to make a discretionary profit-sharing contribution to be allocated to participant accounts based on the ratio of the participant's compensation to total compensation for all eligible participants. For the year ended December 31, 2024, the Company did not make a discretionary profit-sharing contribution.

Participants direct the investment of the contributions to their account into various investment options offered by the Plan, which are held under an investment contract with The Voya Retirement Insurance and Annuity Company (Voya).

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, and allocations of (a) the Company's discretionary profit sharing contributions, if any, and (b) the Plan's earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions and Company safe harbor matching contributions, plus actual earnings (losses) thereon. Vesting in the Company's discretionary profit sharing contributions, if any, plus actual earnings (losses) thereon, is based on years of continuous service, as defined by the Plan. Participants vest at a rate of 20% per year beginning with their second year of service and become fully vested after six years of service. Participants are immediately fully vested upon normal retirement age, death or permanent disability.

#### Forfeitures

Forfeitures are portions of participants' accounts that participants surrender by terminating employment prior to becoming fully vested. Forfeitures may first be used to pay administrative expenses, and any remaining amounts will be used to reduce the Company's contributions. There were forfeited nonvested accounts of \$129 and \$123 at December 31, 2024 and 2023, respectively. During 2024, no forfeitures were used to pay administrative expenses or to reduce the Company's contributions.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the vested interest in their account. In addition, the Plan allows for hardship distributions out of the participant's contributions account, if certain criteria are met. The Plan does not allow for other in-service distributions. At December 31, 2024 and 2023, there were no amounts owed to former participants whose employment had been terminated and who requested payout of their account balances.

#### SECURE 2.0 Act

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management has evaluated those provisions and determined there is no material impact on the Plan for the years ended December 31, 2024 and 2023. Plan management will evaluate and determine which optional provisions, if any, to elect in the future.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of changes in net assets during the reporting period. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan invests in an investment contract with Voya. The investment contract is comprised of several funds within a pooled separate account and a guaranteed interest rate fixed account from which participants of the Plan choose for investment of their account balance. Participants hold units of participation in the individual fund or fixed account in which their account balances are invested.

The Plan's investments in the funds within the pooled separate account under the investment contract with Voya are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in any orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's investment in the fixed account under the investment contract with Voya is stated at contract value. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of units of participation are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefit payments are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are allocated proportionately to participants based on their respective account balances in the related funds and are included as a reduction in net appreciation in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through August 30, 2025, which is the date the financial statements were available to be issued.

### **Note 3: Information Prepared and Certified by the Custodian**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including the pooled separate account, at fair value, and the fixed account, at contract value, held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Voya, the Custodian of the Plan.

### **Note 4: Fair Value Measurements**

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted market prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Pooled separate account under the investment contract with insurance company:* Valued at the net asset value (NAV) per unit, as provided by the Custodian, as a practical expedient to estimate fair value. The NAV per unit is based on the fair value of the underlying investments adjusted by a daily asset charge as determined by the contract issuer.

### **Note 5: Guaranteed Interest Account**

The Plan invests in a guaranteed interest rate fixed account, the Voya Fixed Account (fixed account) under an investment contract with Voya. The fixed account is classified as a fully benefit-responsive investment contract which is carried at contract value. Voya maintains the contributions to the fixed account in a general account. The account is credited with earnings based on the rate of return determined by price breaks as specified in the contract. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The fixed account is included in the accompanying financial statements at contract value (Note 2), which represents contributions made to the fixed account under the contract, plus earnings (losses), less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments in the fixed account at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The value of the fixed account investment at December 31, 2024 and 2023, was \$943,482 and \$1,316,535, respectively. The crediting interest rate is determined at the discretion of the issuer, but may not be less than 1%. The interest rate is reviewed on an annual basis for resetting.

The ability of the Plan or its participants to transact at contract value with the issuer could be limited if the Plan decides to withdraw from the investment contract. The Plan Administrator has indicated there is no intent to withdraw from the contract in the near term. The investment contract permits the issuer to terminate the agreement after five contract years have been completed, from the initial contract effective date of September 30, 2009. No such termination has occurred.

### **Note 6: Tax Status**

The Plan, as adopted by the Company, is a Non-Standardized Pre-Approved Profit Sharing Plan with CODA ("Prototype Plan") sponsored by The Retirement Advantage, Inc. The Prototype Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Related Party and Party-in-Interest Transactions**

Certain Plan investments are managed by the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not considered prohibited transactions under the ERISA regulations. Fees paid by the Plan to the Custodian for administrative expenses aggregated \$6,387 for the year ended December 31, 2024. In addition, certain administrative functions are performed by the trustee of the Plan or employees of the Company, for which no compensation is received from the Plan for their services.

### Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company profit-sharing contributions. Any unallocated Plan assets would be allocated to participant accounts and distributed in such a manner as the Company may determine.

### Note 9: Risks and Uncertainties

The Plan invests in a pooled separate account and a guaranteed interest rate fixed account under an investment contract with an insurance company. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
