INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the financial statements of the Exponent, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

The supplemental schedule included in the accompanying table of contents is presented for purposes of additional analysis and is not a required part of the financial statements, but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

Exponent, Inc. (the Company) established the Exponent, Inc. 401(k) Savings Plan (the Plan), effective March 1, 1988, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by a committee, composed of Company employees, responsible for selecting investment options offered under the Plan and monitoring investment performance. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and record keeper. Fidelity holds, invests and reinvests trust assets in the interest and at the direction of participants and their beneficiaries.

Eligible Participants:

Company employees who have reached age 21 are immediately eligible to participate in and make contributions to the Plan. Participants are eligible to receive Company contributions in any year they work at least 1,000 hours.

Contributions:

Participants are permitted to make voluntary pre-tax, Roth post-tax and after-tax salary deferral contributions of up to 60% of their eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 are eligible to make an additional catch-up contribution under the Code. Participants may also contribute amounts representing distributions from other tax-qualified plans (rollovers), subject to Code regulations.

The Company makes an annual mandatory nonelective contribution to the Plan equal to 7% of each eligible participant's eligible compensation, as defined by the Plan agreement. As of December 31, 2024, the Plan recorded an employer contribution receivable of \$9,979,036 to the Plan (\$10,497,262 as of December 31, 2023). The Company may also make discretionary matching contributions to the Plan, as determined by the Board of Directors.

Contributions are subject to certain limitations under the Code.

1. Description of the Plan (continued)

In-Plan Roth Conversions:

The Plan allows participants who are active employees of the Company to convert their after-tax contributions to Roth contributions. In 2024, \$286,504 of after-tax deferral contributions were converted to Roth accounts.

Participant Accounts:

Participant accounts are credited with participant contributions, Company contributions, rollovers, and an allocation of the Plan's net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting:

Participants are immediately vested in their contributions, plus actual earnings (less any losses) thereon. Company contributions, plus earnings (less any losses) thereon, become 20% vested after each year of service and are fully vested after five years of service, or upon normal retirement, disability, or death.

Forfeitures:

A terminated participant's non-vested account balance is forfeited upon the earlier of the payment of vested benefits or the last day of the Plan year in which the participant incurs five consecutive one-year breaks in service. Forfeitures can first be used to restore previously forfeited accounts, then to reduce Company contributions, then to pay Plan administrative expenses. Forfeitures of \$585,379 were used to reduce the Company's 2023 contribution, which was funded to the Plan in July 2024. Forfeitures of \$3,069 were used to pay Plan expenses in 2024. The Plan had \$1,099,879 of forfeitures available for future use as of December 31, 2024 (\$122,484 as of December 31, 2023).

1. Description of the Plan (continued)

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Participants may borrow up to one-half of their vested account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a term of up to ten years may be granted. Participant notes are evidenced by a written note, secured by the vested balance in the participant's account and bear a reasonable rate of interest, as determined by the Plan administrator. Interest rates on notes outstanding as of December 31, 2024 range from 4.25% to 9.25%. Repayment of principal and interest is generally made through payroll deductions.

Payment of Benefits:

Unless the participant elects otherwise, the payment of benefits under the Plan will begin no later than the 60th day after the close of the Plan year in which one of the following occurs (a) retirement of or after the participant's 60th birthday, (b) death, (c) disability or (d) termination of employment. Benefits may be paid in a lump sum cash payment or in the form of substantially equal installment payments for a period up to or equal to the life expectancy of the participants, the beneficiaries or the combined life expectancy of the participants and beneficiaries. Vested account balances of \$7,000 or less may be distributed in a lump sum cash payment without the consent of the participant. The Plan agreement also allows for certain in-service and hardship withdrawals of benefits to participants who are current employees. Benefits are recorded when paid.

Plan Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Plan expenses include audit and advisory fees as well as certain transaction, account maintenance, and note fees. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments:

Investments consist of mutual funds and a money market fund. These funds are reported at fair value, which is the net asset value of shares held by the Plan at year end, as quoted in active markets.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement: (continued)

The three-level hierarchy for fair value measurement is defined as follows:

- **Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- **Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- **Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's investments are recorded at fair value and are classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Party-In-Interest Transactions

Certain Plan investment options are managed by Fidelity. As Fidelity is the Plan trustee, purchases, and sales of these investments by the Plan qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

5. Income Tax Status

The Plan sponsor received a determination letter from the Internal Revenue Service (IRS) dated July 10, 2017, stating the Plan was in compliance with the applicable provisions of the Code. The Plan has been amended and restated since receipt of the letter. However, the Company believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes, and is, therefore, qualified and the trust that forms a part of the Plan is exempt from federal and state income taxes.

5. Income Tax Status (continued)

GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize an income tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the income tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

6. Subsequent Events

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

Exponent, Inc. (the Company) established the Exponent, Inc. 401(k) Savings Plan (the Plan), effective March 1, 1988, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan, as amended and restated, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by a committee, composed of Company employees, responsible for selecting investment options offered under the Plan and monitoring investment performance. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and record keeper. Fidelity holds, invests and reinvests trust assets in the interest and at the direction of participants and their beneficiaries.

Eligible Participants:

Company employees who have reached age 21 are immediately eligible to participate in and make contributions to the Plan. Participants are eligible to receive Company contributions in any year they work at least 1,000 hours.

Contributions:

Participants are permitted to make voluntary pre-tax, Roth post-tax and after-tax salary deferral contributions of up to 60% of their eligible compensation, as defined by the Plan agreement. Participants who have reached the age of 50 are eligible to make an additional catch-up contribution under the Code. Participants may also contribute amounts representing distributions from other tax-qualified plans (rollovers), subject to Code regulations.

The Company makes an annual mandatory nonelective contribution to the Plan equal to 7% of each eligible participant's eligible compensation, as defined by the Plan agreement. As of December 31, 2024, the Plan recorded an employer contribution receivable of \$9,979,036 to the Plan (\$10,497,262 as of December 31, 2023). The Company may also make discretionary matching contributions to the Plan, as determined by the Board of Directors.

Contributions are subject to certain limitations under the Code.

1. Description of the Plan (continued)

In-Plan Roth Conversions:

The Plan allows participants who are active employees of the Company to convert their after-tax contributions to Roth contributions. In 2024, \$286,504 of after-tax deferral contributions were converted to Roth accounts.

Participant Accounts:

Participant accounts are credited with participant contributions, Company contributions, rollovers, and an allocation of the Plan's net earnings or losses. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

Vesting:

Participants are immediately vested in their contributions, plus actual earnings (less any losses) thereon. Company contributions, plus earnings (less any losses) thereon, become 20% vested after each year of service and are fully vested after five years of service, or upon normal retirement, disability, or death.

Forfeitures:

A terminated participant's non-vested account balance is forfeited upon the earlier of the payment of vested benefits or the last day of the Plan year in which the participant incurs five consecutive one-year breaks in service. Forfeitures can first be used to restore previously forfeited accounts, then to reduce Company contributions, then to pay Plan administrative expenses. Forfeitures of \$585,379 were used to reduce the Company's 2023 contribution, which was funded to the Plan in July 2024. Forfeitures of \$3,069 were used to pay Plan expenses in 2024. The Plan had \$1,099,879 of forfeitures available for future use as of December 31, 2024 (\$122,484 as of December 31, 2023).

1. Description of the Plan (continued)

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Participants may borrow up to one-half of their vested account balance, not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which a term of up to ten years may be granted. Participant notes are evidenced by a written note, secured by the vested balance in the participant's account and bear a reasonable rate of interest, as determined by the Plan administrator. Interest rates on notes outstanding as of December 31, 2024 range from 4.25% to 9.25%. Repayment of principal and interest is generally made through payroll deductions.

Payment of Benefits:

Unless the participant elects otherwise, the payment of benefits under the Plan will begin no later than the 60th day after the close of the Plan year in which one of the following occurs (a) retirement of or after the participant's 60th birthday, (b) death, (c) disability or (d) termination of employment. Benefits may be paid in a lump sum cash payment or in the form of substantially equal installment payments for a period up to or equal to the life expectancy of the participants, the beneficiaries or the combined life expectancy of the participants and beneficiaries. Vested account balances of \$7,000 or less may be distributed in a lump sum cash payment without the consent of the participant. The Plan agreement also allows for certain in-service and hardship withdrawals of benefits to participants who are current employees. Benefits are recorded when paid.

Plan Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Plan expenses include audit and advisory fees as well as certain transaction, account maintenance, and note fees. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of a Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments:

Investments consist of mutual funds and a money market fund. These funds are reported at fair value, which is the net asset value of shares held by the Plan at year end, as quoted in active markets.

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement: (continued)

The three-level hierarchy for fair value measurement is defined as follows:

- **Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.
- **Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- **Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's investments are recorded at fair value and are classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Party-In-Interest Transactions

Certain Plan investment options are managed by Fidelity. As Fidelity is the Plan trustee, purchases, and sales of these investments by the Plan qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

5. Income Tax Status

The Plan sponsor received a determination letter from the Internal Revenue Service (IRS) dated July 10, 2017, stating the Plan was in compliance with the applicable provisions of the Code. The Plan has been amended and restated since receipt of the letter. However, the Company believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes, and is, therefore, qualified and the trust that forms a part of the Plan is exempt from federal and state income taxes.

5. Income Tax Status (continued)

GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize an income tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the income tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

6. Subsequent Events

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were approved by the Plan administrator and available to be issued.
