Opinion

Note 1. Description of Plan

The following description of the ECT Employee Stock Ownership Plan (the “Plan”), which is sponsored by Environmental Consulting & Technology, Inc. and Affiliates (the “Company”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Company established the Plan effective as of January 1, 2000, and amended and restated on January 1, 2020. The Plan operates as a leveraged employee stock ownership plan (“ESOP”) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (the “Code”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan is managed by a Trustee appointed by the Company’s Board of Directors.

The Plan purchased Company common shares using the proceeds of borrowings from the Company and holds the stock in a trust established under the Plan. The borrowing is to be repaid by fully deductible Company contributions to the Trust. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the Code.

The borrowing is collateralized by the unallocated shares of stock. The Company has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

1. The accounts of employees with rights in allocated stock (“Allocated”), and
2. Stock not yet allocated to employees (“Unallocated”).

Eligibility

Employees of the Company are generally eligible to participate in the Plan after one year of service provided, they worked at least 1,000 hours during such Plan year and have attained the age of 18. Participants who do not meet the eligibility requirements or are not employed on the last working day of the year are generally not eligible for an allocation of the Company contributions for such year unless employment is terminated on account of retirement, death, or disability in such year.

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan’s dividends, if any, and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loans. The Company may make contributions of shares to the Plan. Employee contributions are not permitted.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant’s account is credited as of the last day of each plan year with an allocation of shares released by the trustee from the unallocated account and forfeitures of terminated participants’ non-vested account. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive a share allocation. Share allocations are based on the number of units earned by each participant during the year relative to the total units to all participants. All eligible employees receive one unit for every \$1,000 of eligible compensation and one unit for each year of service.

Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. An eligible participant is 20% vested after two years of credited service; vesting increases 20% each year for each of the next four years until 100% vesting is achieved after six years of credited service.

Payment of Benefits

No distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), becomes permanently disabled, or otherwise terminates employment with the Company. Distributions are made in cash or, if a participant elects, in the form of Company common shares plus cash for any fractional share.

Under the provisions of the Plan, the trust is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account under certain specified circumstances and is notified by the trustee prior to the time that such rights are to be exercised. The trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants that is not readily tradable on an established market, or is subject to trading limitations, is required to include a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure the participants have the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Prior to termination, Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth Plan Year, the participant may diversify up to 50%.

Plan Termination

The Company reserves the right to terminate or amend the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the interest of each participant in the Trust will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Plan Administrator shall direct the trustee to pay all liabilities and expenses of the Trust and to sell shares of financed stock held in the loan suspense account, if any, to the extent it determines such sale to be necessary in order to repay the loan. All participants would be fully vested in the event of a plan termination.

Forfeitures

Company contributions and Plan forfeitures are allocated to each participant's account based upon the number of units by each participant during the year relative to the total units to all participants. All eligible employees receive one unit for every \$1,000 of eligible compensation and one unit for each year of service. Non-vested shares are not considered to be forfeited until the last day of the plan year in which the participant incurs a 5-year consecutive break in service. After the break in service requirement is met or a distribution occurs before the 5-year period, the non-vested shares shall be allocated to remaining eligible participants. During the year ended December 31, 2024, the Company allocated 1,832 shares and \$5,089 in cash to the remaining eligible participants.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on the payment date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded upon distribution.

Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.

During the year ended December 31, 2024, the Plan's investment in the Company's common stock appreciated in value by \$1,131,461.

Note 4. Fair Value Measurements

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

Company Common Stock

The fair value of the Company common stock is determined by an annual independent appraisal. This appraisal was based on a combination of the market and income valuation approaches. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts.

Money Market Funds

Money market funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Note 5. Administration of Plan Assets

The Plan's assets are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invest cash received, interest, and dividend income and make distributions to participants. The trustee also administers the payment of interest and principal of the loan, if any, which is reimbursed to the trustee through contribution as determined by the Company.

Note 6. Loans Payable

In 2007, the Plan purchased 108,234 Company common shares for \$2,857,377. The Plan financed this purchase through a note agreement with the Company. The initial loan agreement provides for the loan to be repaid over 20 years. The loan bears interest at the rate of 5%. The loan balance was \$186,400 and \$372,801 at December 31, 2024 and 2023, respectively.

In 2013, the Plan purchased 100,000 Company common shares for \$2,902,880. The Plan financed this purchase through a note agreement with the Company. The initial loan agreement provides for the loan to be repaid over 20 years. The loan bears interest at the rate of 4.5%. The loan was refinanced into the 2019 loan.

In 2019, the Plan purchased 30,000 Company common shares for \$1,033,500. The Plan financed this purchase through a note agreement with the Company and was refinanced with the 2013 loan. The initial loan agreement provides for the loan to be repaid over 20 years. The loan bears interest at the rate of 2.09%. The loan balance was \$2,677,368 and \$2,975,671 at December 31, 2024 and 2023, respectively.

In 2024, the Plan purchased 7,537 Company common shares for \$244,350. The Plan financed this purchase through a note agreement with the Company. The loan agreement provides for the loan to be repaid over 30 years. The loan bears interest at the rate of 2%.

All loans are secured by Company stock.

Note 7. Employer Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loans. The Company contributed \$860,000 to the Plan for 2024, \$313,347 of which relating to loan payments.

Note 8. Tax Status

The Internal Revenue Service ("IRS") has informed the Company by letter dated December 16, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Related Party Transactions

The Plan invests in Company common stock, which is a related party and party-in-interest transaction.

Note 10. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
