The Plan Administrator of UTIMCO 403(b) Tax Sheltered Annuity Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of UTIMCO 403(b) Tax Sheltered Annuity Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1 – Description of the Plan

The following description of the UTIMCO 403(b) Tax Sheltered Annuity Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s information.

General — The Plan is a defined contribution plan covering substantially all employees of The University of Texas/Texas A&M Investment Management Company (the “Company”) who are not covered by another plan. The Board of Directors of the Company has appointed the Plan Administrative Committee to control and manage the operation and administration of the Plan. Effective December 4, 2012, Newport Trust Company, LLC served as the trustee of the Plan through November 13, 2024. The Newport Group, Inc. merged with Ascensus, LLC in April, 2022 and effective November 14, 2024, the Plan’s assets were transferred to Ascensus Trust Company who currently serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions — Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) contributions made by the Company, and (iii) participant rollovers from another qualified plan. Participants have the option to make Roth elective salary reduction contributions to the Plan.

Participants may elect to contribute a percentage or fixed amount of eligible compensation to the Plan each year, subject to limitations, as defined in the plan document. Such contributions are excluded from the participant’s taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan unless the participant has elected to make Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions; these additional contributions are ineligible for a Company matching contribution. Eligible employees whose hire date is on or after May 1, 2020 will be deemed to have automatically elected to defer 6.5% of their eligible compensation unless the participant makes an election to opt out.

The Company makes a matching contribution to each participant’s account equal to 8.5% of the amount of the participant’s eligible compensation for participants who contribute at least 6.5% of eligible compensation as defined by the Plan. Additional employer discretionary nonelective contributions may be made at the discretion of the Company’s Board of Directors. No employer discretionary nonelective contributions were made during the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts — Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution, Company contributions, and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes to Financial Statements

Investments — Investments are entirely participant directed. Participants can direct the investment of their contributions and any Company contributions into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers various mutual and money market funds as investment options to participants as well as the choice to self-direct their investment elections outside the Plan's investment options.

Vesting — Participants are vested immediately in their contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after one year of credited service as defined by the plan document.

Notes Receivable from Participants — Participant loans are not permitted per the plan document. The Plan was amended and restated effective January 1, 2020. There were no loans outstanding as of December 31, 2024, and 2023.

Payment of Benefits — On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive a lump-sum payment equal to the value of the participant's vested interest in the participant's account or installment payments over a period of not more than the participant's assumed life expectancy.

Participants may also be eligible to make financial hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Forfeited Accounts — When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future Company contributions or pay plan administrative expenses for the plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the plan document, the account will be reinstated. As of December 31, 2024, forfeited nonvested accounts totaled \$7 and as of December 31, 2023, there were no forfeited nonvested accounts. During 2024, employer contributions were reduced by \$5,048 from forfeited nonvested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties — The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such a change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Concentration of Investments — Included in investments on December 31, 2024, and 2023, are shares of the Vanguard 500 Index Admiral Fund of \$11,530,742 and \$9,914,319, respectively. These investments represent 23% of total investments at December 31, 2024, and 2023, respectively. A significant decline in the market value of this investment could significantly affect the Plan's net assets available for benefits.

Investment Valuation and Income Recognition — The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expense — Administrative expenses of the Plan are paid by the Plan or the Plan sponsor, as provided in the plan document. Investment management fees for investments are included as a reduction of investment return and are not reflected separately in the statement of changes in net assets available for benefits.

Administrative expenses of \$17.50 per participant are deducted from terminated participant accounts each calendar quarter. Participants also pay administrative costs for distributions, self-directed brokerage accounts and qualified domestic relation orders.

Payment of Benefits — Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan, but had not yet been paid as of December 31, 2024, or 2023.

Excess Contributions Payable — The Plan is required to return contributions received during the Plan year in excess of the IRC limits. There were no excess contributions payable as of December 31, 2024, and 2023.

Note 3 – Certified Investment Information

The following is a summary of the information regarding the Plan as of December 31, 2024, and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule that were prepared by or derived from information prepared by Newport Trust Company, LLC and Ascensus Trust Company, the trustees of the Plan during 2024 and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustees that such information is complete and accurate.

Note 4 – Fair Value Measurements

ASC 820, Fair Value Measurement provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques — Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Cash Equivalents – Money Market Funds — An open-ended mutual fund that is registered with the Securities and Exchange Commission (SEC). The fund is valued at net asset value and the goal is to maintain \$1 value of its shares.

Self-Directed Brokerage Accounts — Includes a variety of common stock and mutual funds. Common stock is valued at the closing price reported on the active market on which the individual securities are traded.

Mutual Funds — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 – Related Party Transactions and Exempt Party-In-Interest Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities for the Plan, including the Company. These transactions qualify as exempt party-in-interest transactions. Employees and/or officers of the Company who may be participants in the Plan perform administrative and other services to the Plan. The Company pays for these and other expenses at no cost to the Plan.

Note 6 – Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. If the Plan is terminated, participants would become 100% vested in their accounts.

Note 7 – Federal Income Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). Plan Management believes the Plan is operating in compliance with the requirements of the IRC.

Note 8 – Subsequent Events

Subsequent events were evaluated through September 25, 2025, the date the financial statements were available to be issued. There were no subsequent events to report.
