A. Funding

Certain assumptions are prescribed as noted below. The other assumptions are estimates derived from historical and recent experience as well as market observations, combined with professional judgment about future expectations.

Interest for IRS funding purposes

The interest rates used for the 2024 plan year are the 24-month average corporate bond segment rates for January 2024 subject to funding stabilization. Under stabilization, the interest rates used for funding purposes are calculated in the usual manner (24-month average corporate bond rates) but are then constrained to be within a corridor around a 25-year average of those same bond rates. Each of the three segments of the yield curve reflecting the 25-year average rates is constrained to be no less than 5%. For 2024, the stabilization corridor is 5%. It will remain at 5% through 2030 and then increase by 5% per year beginning in 2031 until it reaches 30% for 2035. The interest rate description above reflects that the plan sponsor elected to apply the ARPA provisions beginning with the 2022 plan year. The rates are as follows:

Funding Method and Contribution Requirement

Funding method is unit credit actuarial cost method, as prescribed by law. The liability is measured on an accrual-to-date basis using mandated mortality tables and interest rates with no salary projection past the end of the year.

Plan sponsors are required under Internal Revenue Code Section 430 to make a minimum level of contributions to qualified pension plans. Available credit balances can be used to satisfy this required contribution. In general, the minimum required contribution is the sum of the target normal cost and an installment that amortizes the plan's funding shortfall, offset by any plan overfunding, if applicable. If all assumptions are met (including the investment earnings implicitly assumed by the interest rate), funding the plan at the minimum required contribution level is generally designed to achieve a 100% funded status within fifteen years. Once that is achieved, or for overfunded plans, the minimum required contribution will generally equal the target normal cost reduced by any overfunding.

Actuarial Models

Segal valuation results are based on proprietary actuarial modeling software. Plan Status

Ongoing

Normal Retirement

- Age Requirement: 65
- Service Requirement: None
- Amount: 100% of final average salary reduced by 1/10th for each year of service less than 10 years. Final average salary is average salary of the highest 3 consecutive plan years of employment.

Early Retirement

- Age Requirement: 55
- Service Requirement: 10 years of service
- Amount: Regular pension reduced by 1/15th per year for each of the first five years early and 1/30th per year for each of the next five years early.

Disability

- Age Requirement: None
- Service Requirement: None
- Amount: Regular pension accrued, based on credited service and salary through date of disability. The actuarial equivalent of the accrued benefit is payable immediately.

Schedule SB, Part V – Plan Provisions

Vesting

- Age Requirement: None
- Service Requirement: 5 year cliff vesting, except 2-20% Top-Heavy vesting schedule during Top-Heavy years.
- Amount: Regular pension accrued, payable at eligibility for normal retirement. Early Retirement pension accrued, payable at eligibility for early retirement.

Pre-Retirement Death Benefits

- Age Requirement: None
- Service Requirement: None
- Amount: Lump Sum actuarial equivalent of Normal Retirement benefit based on credited service and salary to date of death. The value of the lump sum may not be less than the actuarially equivalent value of the minimum REA spouse death benefit.

Participation

- Age Requirement: 21 years
- Service Requirement: After completion of 1 year of service.
- Entry Dates: January 1 or July 1 after completion of the eligibility requirements above.

Service

- Crediting and Vesting: A plan year during which an Employee completes at least 1,000 Hours of Service.
- Eligibility: The 12-month period commencing on the employee's Employment Commencement Date or any Plan Year if the employee is credited with at least 1,000 Hours of Service during such period or Plan Year.

Schedule SB, Part V – Plan Provisions

Forms of Benefit

- Joint and Survivor Annuity: Monthly payments for the life of the participant and in the event the participant dies after the commencement of benefit payments but before the death of the beneficiary, monthly payments for the life of the beneficiary equal to a percentage (not greater than 100%) of the participant's monthly payment shall continue to the surviving beneficiary for his or her life. The 100% Joint and Survivor Annuity is considered the funded form of the benefit. All options other than lump sum are actuarially equivalent to the 100% Joint and Survivor Annuity.
- Single life option: Monthly payments for the life of the participant which shall continue until and including the first day of the month on which the participant dies.
- Installment payments: Payments over a period certain in monthly, quarterly, semiannual or annual cash installments; provided, however, that the period over which such payment is to be made shall not extend beyond the life expectancy of the participant (or the joint life expectancy of the participant and his or her designated beneficiary).
- Single lump sum: A lump sum payment (in cash, property, or otherwise) equal to the actuarial equivalent present value of the Participant's vested accrued benefit.
- Actuarial equivalence: Based on the 1971 Male Individual Mortality Table and a 5% interest rate for determinations other than those with respect to lump sums.

For lump sums, the 2024 Lump Sum Unisex Mortality Table and applicable interest rates as prescribed by Internal Revenue Code 417(e)(3)(D), limited by IRC Section 415.

Statutory Limits

- Section 415 limit: \$275,000 (previously, \$265,000)
- Section 401(a)(17) limit: \$345,000 (previously, \$330,000)
