**NOTE 1 – DESCRIPTION OF PLAN**

General

The following description of the Uncas International, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a contributory single-employer defined contribution plan covering all employees of Uncas International, LLC as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

Contributions

Participants may elect to contribute to the Plan any percentage of their eligible compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions equal to any whole number percentage of their eligible compensation or whole dollar amount up to the annual limits established by the Internal Revenue Code (IRC). Participants may not contribute more than the maximum allowed by the IRC.

The Plan provides for automatic enrollment for participants meeting eligibility requirements. Deferral is set at 3 percent with an automatic annual escalation provision of 1 percent.

The Plan Sponsor makes safe harbor match contributions to the Plan to those participants that have attained age twenty-one and have completed at least 1,000 hours of service. The safe harbor match contributions are in the amount of 100 percent of participants' contributions that are not in excess of 3 percent of the participants' compensation plus 50 percent of participants' contributions that exceed 3 percent but do not exceed 5 percent of the participants' compensation. For the year ended December 31, 2024, matching contributions were \$188,270.

The Plan Sponsor may also make discretionary profit-sharing contributions to the Plan. Discretionary profit-sharing contributions are determined annually by the Plan Sponsor and are allocated to those participants that have attained age twenty-one, completed at least 1,000 hours of service, and are employed by the Company on the last day of the plan year. Discretionary profit-sharing contributions, if any, are allocated to an eligible participant based on a percentage of their compensation. There was no discretionary profit-sharing contribution for the year ended December 31, 2024.

Participant Accounts

Each participants' account is credited with the participant's contributions, Plan Sponsor contributions, and Plan earnings. Participant accounts are charged with an allocation of investment related expenses that are paid by the Plan and included in net appreciation in fair value of investments. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are vested immediately in their contributions to the Plan plus actual earnings thereon. Rollovers and transfers of funds from other qualified plans in which employees cease to participate are permitted and are fully vested. Participants are fully vested in their safe harbor matching contribution account. Participants are fully vested in discretionary profit-sharing contributions after five years of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Notes receivable are secured by the balance in a participant's account and bear interest at the prevailing commercial rate for loans of similar types. Principal and interest are paid ratably through payroll deductions. Notes receivable balances must be repaid within five years, with the exception of loans whose proceeds are used for the purchase of a participant's residence, which must be repaid within fifteen years.

Payment of benefits

Upon termination of service due to death, disability, or retirement, participants will be entitled to 100 percent of the amounts credited to their accounts. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

The Plan allows in-service withdrawals of vested account balances, subject to ERISA regulations for those participants that have reached age 59 ½ or, if later, normal retirement age. The Plan also allows hardship withdrawals from a participant's vested account balance.

Forfeited Accounts

Forfeitures of nonvested accounts of terminated participants may be used in any permissible method for the plan year in which such forfeitures occur. There were \$53 of forfeitures as of December 31, 2024, all of which were unallocated as of December 31, 2024. There were no forfeitures during the Plan year ended December 31, 2024.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year less investment related expenses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and participant distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Section 820, “Fair Value Measurement and Disclosures” provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Guaranteed interest option:* Carried at contract value which is equal to principal balance plus accrued interest plus deposits less withdrawals and charges less market value adjustments as specified in the contract.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (DOL) Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. For the year ended December 31, 2024, the Plan's transactions with parties-in-interest were as follows:

All plan investments are in the custody of Voya Retirement Insurance and Annuity Company. Any transactions between the Plan and Voya Retirement Insurance and Annuity Company qualify as party-in-interest transactions.

Certain employees and owners of the Company who were participants in the Plan also performed administrative services to the Plan at no cost to the Plan.

Notes receivable from participants qualify as party-in-interest transactions which are exempt from prohibited transaction rules.

Investment related expenses included in net appreciation in fair value of investments are considered party-in-interest transactions.

**NOTE 5 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

**NOTE 6 – TAX STATUS**

The Plan has adopted the Volume Submitter Profit Sharing Plan with CODA (the Volume Submitter Plan). The Volume Submitter Plan has received from the Internal Revenue Service (IRS) a determination letter, dated March 31, 2014, indicating that the Volume Submitter Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Company has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or the DOL. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 8 – PLAN INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Voya Retirement Insurance and Annuity Company has certified to the completeness and accuracy of all Plan assets and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.
