To the Management of the Outdoor Venture 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Outdoor Venture 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. BASIS OF FINANCIAL STATEMENT PRESENTATION

The accompanying financial statements of the Outdoor Venture 401(k) Plan (the "Plan") have been prepared to comply with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The Plan's financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value (see Note 4), except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

2. DESCRIPTION OF PLAN

The Plan's sponsor, Outdoor Venture Corporation (the "Employer"), is primarily a military defense contractor specializing in the manufacture of tentage and accessory products for the United States Government.

The following brief description of the Outdoor Venture 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a standardized 401(k) Profit Sharing Plan established under Section 401(a) of the Internal Revenue Code. The Plan became effective February 1, 1987. During 2015, the plan sponsor approved the adoption of a restated plan sponsored by Tennessee Pension Administrators LLC. The restated plan was effective on June 1, 2015. On November 30, 2017, the Employer approved an amendment to be effective January 1, 2018 to add a safe harbor enhanced match to the Plan and to remove the discretionary match. The Plan is administered by the Plan Sponsor; the trustees of the Plan are officers of the employer adopting the Plan. The Plan covers all employees of the Employer.

Eligibility – To become eligible, employees must be of age eighteen or older and have completed one year of service with the Employer. For this purpose, one thousand hours worked during a plan year equals one year of credited service. An employee who becomes eligible may join the Plan on the first day that they have completed the above eligibility requirements.

Contributions - Participating employees may elect to contribute up to the maximum percentage allowable not to exceed the limits of Internal Revenue Code regulations, including catch-up contributions. Effective January 1, 2014, the Plan was amended to make the matching contributions equal to a discretionary percentage, to be determined by the employer. Effective January 1, 2018, the Plan was amended to add a safe harbor enhanced match for 100% of elective deferrals that do not exceed 4% of compensation for each payroll period. Rollover

contributions are permitted only by employees who have satisfied the conditions for participation. The participant's account will also be increased by earnings on account balances.

Benefits and Vesting - The benefit to which a participant is entitled is the benefit that can be provided from the participant's account that includes employee and employer contributions and related earnings thereon. Participants are immediately 100% vested in their contributions as well as all Employer matching and discretionary contributions and any earnings thereon.

Upon retirement, disability, or death, the participant or designated beneficiary is entitled to receive 100% of the balance of his account. If a participant terminates employment for any reason other than retirement, disability, or death, he shall be entitled to his full account balance.

Loans to Participants – The Plan does not allow for participant loans.

Investments – Participants may, upon enrollment in the Plan, elect to invest their contributions and the Employer contributions in any or all of the various investment options offered by the Plan. Periodic transfers among funds of certain accumulated account balances and directions of future employee deferrals and Employer contributions are permitted.

Risks and Uncertainties – The Plan provides for various participant directed investment options in any combination of mutual funds and an unallocated contract. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value, except for a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's interest in his or her account, or other options as defined in the plan agreement. For termination of service for other reasons, a participant may receive the value of the interest in his or her account as a lump-sum distribution. Participants may also request distributions at the later of the attainment of age 65 or the fifth anniversary of the first day of the Plan year in which participation in the Plan commenced. Benefits are recorded when paid.

Administrative Expenses – Certain administrative expenses related to the Plan are paid by the Employer.

Forfeitures – As participants are immediately 100% vested in their contributions as well as all Employer matching and discretionary contributions, no amounts will be forfeited.

Subsequent Events – Events and transactions that provide additional evidence about conditions that existed as of December 31, 2024, have been evaluated and, if required, adjusted in the financial statements and/or disclosed in the notes to financial statements through the auditor's report date, September 25, 2025, which is the date that the financial statements were available to be issued.

3. ACCOUNTING ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions. These estimates and assumptions affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

4. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") define fair value as the price that would be received for an asset or paid to transfer a liability (an exit price) in the Company's principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. The FASB ASC provides enhanced guidance for using fair value to measure assets and liabilities under current accounting principles generally accepted in the United States of America and expands the disclosure of the methods used and the effects of fair value measurements on earnings.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits, except for the unallocated contract, which is reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

The FASB ASC establishes a fair value hierarchy which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The standard describes three levels within its hierarchy that may be used to measure fair value:

Level 1 Inputs: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 Inputs: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 Inputs: Significant unobservable inputs that reflect a reporting entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In many cases, a valuation technique used to measure fair value includes input from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The fair value of the Plan's financial instruments are based on estimates. These estimates are made at a specific point in time based on relevant market information and information about the financial instrument. These estimates are subjective in nature, involve matters of judgment, and, therefore, cannot be determined with precision. Estimated fair values are significantly affected by the assumptions used.

5. INVESTMENTS

As of December 31, 2024 and 2023, the Plan offered a total of twenty-four investment options, through VOYA Retirement Insurance and Annuity Company ("VOYA") the custodian. The Plan currently offers twenty-three mutual funds and an unallocated contract option in a guaranteed interest account. Each plan participant may select any combination of accounts in which to deposit their contributions. The value of the investments is subject to fluctuations found in financial markets.

The net appreciation in fair value of investments in the amount of \$502,942 for the year ended December 31, 2024 is the result of realized and unrealized gains and losses on the investments in an unallocated contract account and mutual funds. Net appreciation of the fair value of each account is reflected in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

6. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2014, the Plan entered into a fully benefit-responsive guaranteed investment contract with Voya Life Insurance Company which was amended effective August 28, 2017. VOYA maintains the contributions in an allocated account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value.

Contract value, as reported to the Plan by VOYA, represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer for all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rates are based on an agreed-upon formula with the issuer, but it may not be less than 1% (VOYA Guaranteed Interest). The VOYA Guaranteed Interest rate is subject to change at any time subject to contract guarantees. At December 31, 2024, the guaranteed interest account was paying interest at the rate of 1.50%.

Certain events limit the Plan's ability to transact at contract value with VOYA. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a

significant withdrawal from the plan, or (d) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with Plan participants or the issuer, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

According to the FASB ASC, investment contracts held by a defined contribution plan are to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in an investment contract with an insurance company through the VOYA Guaranteed Interest Account. The approximate total contract value at December 31, 2024 and 2023 was \$1,863,857 and \$2,034,095, respectively. Certain events could occur that would allow participants to terminate the contracts or settle at an amount different than the contract value. The unallocated contracts would be subject to a potential surrender charge as well as a possible final fee, depending on timing and contractual requirements. Management does not believe events that would cause the plan to transact at an amount different from the contract value are probable of occurring. As required by the FASB ASC, the statements of net assets available for benefits present the contract value of the Plan's interest in the unallocated contracts.

7. INFORMATION CERTIFIED BY CUSTODIAN

Investments on the statement of net assets available for benefits and the schedule of assets (held at end of year) and investment income and related activity reported on the statement of changes in net assets available for benefits, has been derived from information certified as complete and accurate by the custodian of the Plan, in accordance with Section 2520.103-5 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

8. TAX STATUS

The Plan has adopted a standardized prototype plan sponsored by Tennessee Pension Administrators, LLC. The Plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes

that the Plan was qualified and was tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The FASB ASC prescribes a recognition threshold and measurement attribute for how any benefit plan should recognize, measure, present, and disclose in its financial statements uncertain tax positions that a plan has taken or expects to take on a tax return. The FASB ASC requires that the financial statements reflect expected future tax consequences of such positions presuming the taxing authorities' full knowledge of the position and all relevant facts, but without considering time values. The Plan is subject to routine audits by taxing authorities, however, there are currently no audits for any tax periods in progress. Under federal tax statutes of limitations, the Plan believes it is no longer subject to federal income tax examinations for years prior to 2021.

9. PRIORITIES UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan were to be terminated, participants would be eligible to receive the entire value of their account.
