Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the ***Auditor’s Responsibilities for the Audit of the Financial Statements*** section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements were available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audits of the Financial Statements

Except as described in the ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*** section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control related matters that we identified during the audits.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, line 4i – Schedule of Assets (Held at End of Year) and Schedule H, line 4a – Schedule of Delinquent Participant Contributions are presented for purposes of additional analysis and are not a required part of the financial statements, but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management, and was derived from, and relates directly to, the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

The 2023 financial statements of the Plan were not audited under ERISA Section 103(a)(3)(C). The report dated September 5, 2024, indicated the financial statements presented fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2023 and the changes in net assets available for benefits for the year ended December 31, 2023, in accordance with accounting principles generally accepted in the United States of America. The assets held for investment were not certified complete and accurate.

A. DESCRIPTION OF PLAN

The following description of Brookwood Farms, Inc. (“the Company”) Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. **General.** The Plan was established to provide additional incentive and retirement security for eligible employees of the Company. In 2024, the Plan was amended and restated in its entirety as a 401(k) safe harbor defined contribution Plan. The Plan is funded by employer matching safe harbor contributions, employee salary deferrals through payroll deductions, and employer discretionary contributions that cover all eligible employees. The Plan is an Eligible Automatic Contribution Arrangement (“EACA”) wherein elective deferrals are automatically made to the Plan with an automatic escalation provision. To participate in the Plan and make salary deferrals, the employee must be an employee of the Company, must be the age of twenty-one (21), and must complete two (2) months of service. To participate in the employer matching safe harbor contributions, the employee must be an active eligible participant during the Plan year. The Company may also make discretionary contributions to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Overall responsibility for administering the Plan rests with the Plan Investment Committee, which is appointed by the Board of Directors of the Company.
2. **Contributions.** Participant contributions, representing the deferred portion of compensation, are deposited into a trust account each pay period and are subject to certain limitations under the Internal Revenue Code (“IRC”). Participants who are enrolled in the Plan under the provisions of the EACA have 3% of their salary deferred to the Plan upon eligibility. Employer contributions are made in accordance with the matching percentage for the year as determined by the Board of Directors of the Company. All contributions to the 401(k) component of the Plan are invested at the direction of the participant in one of the investment funds available to the Plan. For the year ended December 31, 2024, the Plan contributed a Safe Harbor match per participant equal to 100% of the amount contributed to the Plan by the participant up to the first 3% of plan compensation plus 50% of the amount the participant contributes between 3% and 5% of Plan compensation. The Company also makes annual discretionary profit-sharing contributions to the Plan, if approved by management of the Company. For the years ended December 31, 2024 and 2023, no discretionary profit sharing was approved. The profit-sharing component of the Plan is funded solely by employer contributions and related account balances are invested at the direction of the participant. Annual employer profit sharing contributions are allocated to each participant’s account based on the participant’s compensation.
3. **Participant Accounts.** The Company’s profit-sharing contributions to the Plan are allocated based upon the percentage of participants’ annual eligible compensation to the total compensation of all participants eligible to share in the contribution. Participants do have access to their accounts to change the investment allocations. Participants are notified annually of their account balance in the Plan.
4. **Vesting.** Participants are always 100% vested in rollover contributions. The participant is vested in the Plan’s profit-sharing contributions and earnings, in accordance with the following schedule:

- 5. Payment of Benefits.** The participant may receive a distribution of the vested portion of some, or all, of the participant's account, for the following: termination of employment, disability, normal retirement, other retirement, or death. The participant's normal retirement age is sixty-two (62). If the participant is under the age of sixty-two (62), then the distribution will be made to the participant after the participant incurs a one-year break in service. If the participant's vested accounts is \$5,000 or less, their vested account will automatically be distributed from the Plan. Participants are also eligible for hardship withdrawal of their vested account balance resulting from elective deferral contributions due to an immediate and heavy financial need.
- 6. Forfeited Accounts.** As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,537 and \$5,774, respectively. The forfeitures were used to offset employer matching contribution obligations to participant accounts.

B. SUMMARY OF ACCOUNTING POLICIES**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for any fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

D. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Codification establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three (3) levels of the fair value hierarchy under FASB Codification are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Government Money Market Fund: Valued at fair value by the Plan at year end.

Cash and Money Market Fund: Valued at cash value by the Plan at year end.

Common stocks: Valued at the fair market value that the stock can be sold on the open market.

Exchange-traded funds: Valued at the daily closing prices as reported by the fund. The exchange-traded funds are published at, or near, its net asset value ("NAV") and transacted at that price. The exchange-traded funds held by the Plan are deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds. These funds are required to be published at their daily NAV and be transacted at that price.

Collective Trusts: Funds primarily consist of common stocks and bonds that are valued on the basis of readily determinable market prices.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value, or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan entered into a traditional fully benefit-responsive group annuity contract with T. Rowe Price Stable Value Common Trust Fund (“the Fund”) totaling \$1,406 and \$0 at December 31, 2024 and 2023, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Fund’s issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the Fund. The crediting rate is reviewed periodically for resetting and was 4.29% at December 31, 2024. The group annuity contract does not permit the Fund to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Fund, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer: Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that causes a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan’s investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

F. TAX STATUS

The Company obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

As of December 31, 2024, management believes there are no uncertain tax positions.

As of December 31, 2024, and including the previous three (3) years considering extensions, the Plan’s Form 5500 is open and subject to examination by tax authorities with relevant jurisdiction. Should such an examination take place, management does not anticipate any significant issues related to the open years.

Although it has not expressed any intent to do so, the Company has the right, under ERISA, at any time, to suspend or discontinue its contributions under the Plan and to terminate the Plan created under the Plan agreement. Upon termination of the Plan, all amounts credited to the affected participants' accounts shall be 100% vested.

H. RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

The Plan's investments are sponsored and managed by the Plan's third-party-administrator, Morgan Stanley, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$5,560 and \$19,833 for the years ended December 31, 2024 and 2023, respectively.

I. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

J. SECURE 2.0

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE 2.0." These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system and finding ways for them to accumulate more assets. These changes have various effective dates starting in 2023 and forward. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

K. PROHIBITED TRANSACTION

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as administratively feasible. The Plan has contributions totaling \$34,475, all of which represented employee salary deferrals, that were not remitted timely. These contributions are considered prohibited transactions.

The Company will calculate lost investment earnings and file form 5330, as applicable, and expects to compensate the Plan for the lost earnings in 2025.
