### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Arvco Container Corp. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### 1. Plan Description

The following description of the Arvco Container Corp. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan originally was adopted effective June 1, 1989, as a defined contribution plan which covers substantially all eligible employees of Arvco Container Corporation and affiliated companies (collectively, the Corporation or Employer) that have completed 90 days of service and are 18 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Contributions*

As a defined contribution plan, all funding for the Plan is made at the discretion of the Corporation or their employees. Under the 401(k) provision, each eligible participant may elect to contribute up to 100% of his or her eligible compensation to the Plan on a tax-deferred basis up to the maximum allowable under the Internal Revenue Code (IRC) each year. The Plan contains an automatic enrollment provision which allows automatic enrollment in the Plan at 8% of eligible compensation after 90 days of service unless the participant opts out or changes the rate. Annually, the contribution percentage will increase 1% per year, up to a maximum of 10%, unless the participant opts out or changes the rate. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may also make a Roth contribution on an after-tax basis.

In addition, the Board may elect to match a portion of the participant contributions on an annual basis. For the years ended December 31, 2024 and 2023, the Corporation matched 20% of the participants' contributions up to 8% of eligible earnings. Additional contributions may be made at the discretion of the Corporation. For the years ended December 31, 2024 and 2023, there were no additional discretionary contributions made by the Corporation.

#### *Participant Accounts*

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions including any rollovers, the participant's share of the employer discretionary and matching contributions, and net earnings or losses thereon. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may elect to invest their contributions in various investment options offered by the Plan. The participants' balances and contributions are allocated based on the participants' elections.

#### *Vesting*

Participants are immediately vested in their elective deferral contributions and actual earnings thereon. The Corporation's contributions begin to vest after one year of service at a rate of 20% per year and are fully vested after five years of service. Participant accounts are distributed without regard to the vesting provisions in the event of death or permanent physical or mental disability.

### *Forfeitures*

Forfeited non-vested accounts may be used to reduce future employer's contributions or to pay administrative expenses. During the years ended December 31, 2024 and 2023, forfeitures totaling approximately \$16,900 and \$14,100, respectively, were used to reduce employer contributions. At December 31, 2024 and 2023, there were approximately \$7 and \$35 of outstanding forfeitures, respectively.

### *Payment of Benefits*

Upon termination of employment (including retirement, disability, or death), a participant or beneficiary has the option of receiving benefits in a lump sum, life annuity contract, or installments. Early withdrawal of participant's contributions, matching contributions, and earnings thereon are permitted in the event of a "heavy and immediate financial hardship" in accordance with Internal Revenue Service (IRS) regulations, or upon attainment of age 59½.

### *Notes Receivable from Participants*

Participants may, under certain circumstances as defined by the Plan Agreement, borrow up to the lesser of \$50,000 or 50% of their vested account balance. The minimum note is \$1,000. Participants may have one note outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at the prevailing rate charged by other lenders for similar notes. Interest rates on notes receivable ranged from 5.25% to 10.50% at December 31, 2024. The notes are repaid ratably through payroll deductions over a period of five years or less, unless for the purchase of a principal residence, in which case the note terms should not exceed ten years.

## **2. Summary of Significant Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments, except for the guaranteed investment contract, are stated at fair value. Fair value is the price that would be received to sell an asset (an exit price) in the principal or most advantageous market for the asset in an orderly transaction between market participants on the measurement date.

Guaranteed investment contracts held by a defined contribution plan that are fully benefit responsive are reported at contract rate. Contract value is the relevant measurement because contract value is the amount participants would receive if they were to initiate permitted

transactions under the terms of the contract. Contract value represents net contributions plus interest at the contract rate. See Note 5 for discussion of the guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in the fair value of investments includes the Plan's gain and losses on investments bought and sold, as well as held during the year. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

### ***Contributions***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Additional discretionary contributions are recorded in the relevant period in accordance with the terms in the Plan Agreement.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Risks and Uncertainties***

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in their values could occur in the near term and such changes could materially affect participant's account balances and the amounts reported in the financial statements.

### ***Subsequent Events***

Subsequent events have been evaluated by management through September 8, 2025, the date these financial statements were available to be issued.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Corporation and are excluded from these financial statements. Fees relating to benefit payments and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Administrative expenses paid by the Plan for the years ended December 31, 2024 and 2023 were approximately \$48,000 and \$7,200, respectively.

### 3. Fair Value Measurements

Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset. The Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, other inputs that are observable, or can be corroborated by observable market data.

*Level 3* - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The following valuation methodologies were used to measure the fair value of the Plan's investments. There were no methodology changes as of December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trusts (CITs)* - CITs are valued at the NAV of the shares held by the Plan at year-end. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. The CITs provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. There is no restriction in place with respect to the daily redemption of the CITs and there are no unfunded commitments.

*Pooled Separate Accounts (PSAs)* - PSA units are valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities). While the majority of the underlying asset values are based on quoted prices, the NAV of the PSAs is not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices and is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The PSAs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date and there are no unfunded commitments.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan's management believes the valuation methods are appropriate and consistent with the market participants, the use of

different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 4. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

## 5. Guaranteed Investment Contract

The Plan invests in the Principal Fixed Income Guaranteed Option (PFIGO), a guaranteed investment contract. The PFIGO is a benefit responsive contract entered into with Principal Life Insurance Company (Principal Life). Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses.

The PFIGO is valued at contract value for presentation in the Plan's net assets available for benefits. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. At December 31, 2024 and 2023, the effective net crediting rate after the deduction for fees was 4.75% and .90%, respectively. Such interest rates are reviewed on a semi-annual basis for resetting.

The guaranteed annuity contract does not permit the insurance company to terminate the agreement prior to the maturity date. The Plan is required to give a 12-month notice before terminating the contract or a 5% penalty will be assessed against the contract value, as defined by the contract. Currently, Plan management believes the occurrence of an event that would cause the Plan to transact at less than contract value is not probable.

### **6. Related Party and Party-in-Interest Transactions**

Investments in CITs, PSAs, and a guaranteed investment contract are managed by Principal Global Investors Trust Company and Principal Life, affiliates of Principal Trust Company, the trustee of the Plan. Therefore, these transactions qualify as a party-in-interest. Fees paid to Principal by the Plan for the years ended December 31, 2024 and 2023 were approximately \$48,000 and \$7,200, respectively. Notes receivable from participants also qualify as party-in-interest transactions.

### **7. Tax Status**

The Plan uses a pre-approved plan document sponsored by Principal. Principal received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits for any tax periods in progress.

### **8. Plan Termination**

Although it has no present intentions to do so, the Corporation reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participant account balances would become fully vested.
