Opinion

We have audited the financial statements of the TMM Team Member Activities Association, Inc. Benevolent Fund (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1—Description of the Plan

The following description of the TMM Team Member Activities Association, Inc. (the "Association") Benevolent Fund (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is an employee association sponsored welfare benefit plan available to all members of the Association. The Plan was established by the Association on August 1, 1995, and a related Trust was established on September 27, 1995. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration – The Association has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Benefits – The purpose of the Plan is to provide financial assistance for emergency relief due to natural disasters and medical emergencies for participants and dependents as determined and approved by the Plan Administrator. Benefits are capped at \$1,000 per incident for each twelve consecutive month period commencing on the date benefits are received.

Contributions – The Association makes discretionary contributions to the Plan.

Eligibility – The Plan provides that any active member of the Association is eligible for benefits.

Plan Administrator – The Benevolent Fund Committee acts as the named fiduciary with authority to control and manage the operation and administration of the Plan.

Trust Agreement – On September 27, 1995, the Association entered into a Trust agreement with PNC Bank (former trustee) for the purpose of establishing a Trust to hold funds which will be used to make disbursements required under the Plan. The Trust funds shall be received, held in trust, and disbursed by the Trustee in accordance with the provisions of the Trust. Effective August 3, 2023, the Plan engaged Kentucky Trust Company as (the "Trustee") of the Plan, replacing PNC Bank. All assets were subsequently transferred.

Note 2—Summary of significant accounting policies

Basis of Presentation – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payments of Benefits – Benefits are recorded when paid. There were no benefit payments requested and not yet disbursed at December 31, 2024 and 2023.

Note 2—Summary of significant accounting policies (continued)

Association Contributions Receivable – Contributions receivable consist of recycling revenues received from various sources and held by the Association. All contribution receivable amounts have been collected as of December 31, 2024 and 2023, therefore no allowance for credit losses has been recorded.

Administrative Expenses – Administrative expenses of the Plan are paid by the Association, as defined in the Plan agreement.

Note 3—Fair value measurements

U.S. GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for investments measured at fair value, including the general classification of such assets pursuant to the valuation hierarchy. There have been no changes in the methodology used at December 31, 2024 and 2023.

Money Market Mutual Fund – Valued at the daily closing price as reported by the fund. The money market mutual fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its net asset value and to transact at that price. The money market mutual fund held by the Plan is deemed to be actively traded and is therefore classified within Level 1 of the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4—Related party and party-in-interest transactions

Certain administrative services are provided by the Association at no cost to the Plan and certain administrative costs incurred by the Plan are paid by the Association. The Plan has entered into various service agreements with parties-in-interest. It invests in a money market mutual fund managed by Kentucky Trust Company, the Trustee of the Plan. These transactions and related activity qualify as party-in-interest.

Note 5—Plan termination

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 6—Income tax status

The Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Subsequent events

The Plan has evaluated all subsequent events through September 26, 2025, which is the date these financial statements were available to be issued and has determined there are no subsequent events that require disclosure.
